Skip Hard, 2560 Hard Lane. Moved here in 1981. Roads were horrible. Mid 1980s we had Hall, Atz, Weber and Corey roads paved. That was a high point of the road project. They have had drainage problems since then but wanted to give credit to CM Dick Korn when he got upset when no progress was being made at project at Hall and Weber. Staff then went out to stand with shovels and take a photo op. That project still isn't done. Mr. Hard said when you leave,

what is your legacy going to be? The major problem in Malabar is drainage. He gave credit to CM Korn.

CM Korn disclosed his sister owns land in the area. CM Krieger, Vail and Ball also had contact with property owners. Mayor made similar disclosure.

Chair opened the PH.

Comments:

1) Phil Crews lived on Johnston Avenue for quite a few years. This connects Blanche and Marshall Dr. He does not favor vacating any ROWs. He said when they gave away ROWs in Malabar Scrub Sanctuary the county wouldn't give an additional 15' along Marie Street.

Additionally he wanted to comment on the drainage mentioned earlier. He now lives off Weber Road and part of the problem was the subdivision outfall that was not functioning properly. The contractor has made the corrections and it flows really well now. He said along the east side of Weber Road it drains very well and thought the town PW Dept did an excellent job.

- 2) Kim Alford owns property adjacent to Clines. He said applicant, Ms. Clines, opinion that we have gun crazy drivers going down the road is wrong. Jennie Street & Alice Street were vacated and he is against Malabar going ahead and vacating this portion of Johnston Avenue. 1164 ft is approved, with the last 306' due a payback. He saw the pin. He is going to commission a survey to prove that. You are giving away my property and you do not have the right to do that.
- 3) Charles (Randy) Carmichael, 609 Aldin Place, Melb Bch. The notice he received that the Reso was listed as 13-2015, the correct one is 15-2015, and Clerk clarified that the number is not what council votes on; it is the subject matter and the numberings is for filing. He sent letters to all of Council and the P&Z member. He said he only got one notice on the 13th. It was dated the 12th.

His bottom line position in this is – if they vacate the ROW then he has the loss of access from the west and that equals loss of value. He does not claim to be a realtor. He did not take time to go thru all the points in his letter. Don't pass this as it means he will lose half of his access. He understands Ms. Cline's desire to join her properties.

In this instance no other property owners are harmed. He doesn't know what the benefit to the town would be. They are charged with doing what is best for the town. By a line of sight from the survey markers, Smith Surveyor – in looking eastward from her home, he does see that the landscaping appears to be in the ROW. If there is any existence of the controversy then he has more concerns.

Pat Reilly, 1985 Howell Lane, Chairman of P&Z. It got tabled because they had some questions about the ROW. He showed how the parcel 264 could be developed. There is no land locked issues if the ROW is vacated. He wanted to bring up some more facts. P&Z Board had no consensus. They voted to table.

Chair closed the PH.

Applicant called to podium.

Discussion: Applicant went over PowerPoint showing the various angles going east and west and how much of the ROW she and her husband cleared the pepper trees. There is now or in the future an accepted road to reach parcel 264. They (she & husband) have cleared the additional ROW in front of their parcel for appearances

Franklin said that this is only to certify the county's final assessment of what the estimated non-ad valorum revenue will be for storm water.

Discussion: Ms. Alvarez, Dept of Natural Resources, SW Division. She explained in 1990 the county hired a consultant to come up with the method to use for assessment SW fees. Each property is assessed a basis of one "equivalent residential unit" (ERU) at \$36. This was based on a 2500sf single family home. For commercial properties it is a more complicated formula that takes into account the amount of pervious, impervious, parking, and a percentage of percolation, retention and runoff. Malabar has not increased that rate although the county has to accommodate larger homes and commercial uses that have more impervious surfaces. Overall residential uses have more pervious surfaces than commercial uses. CM Krieger said not necessarily. Alvarez said a typical five acre lot with a 3,000sf home would still produce less. CM Krieger what about a 50,000sf house; they would still only pay \$36.

CM Krieger said a corporation that has built to proper specifications is not putting any more runoff into the IRL than a 5 acre parcel with horses running around on it and draining into swales that go straight to the IRL. Ms. Alvarez said Malabar can hire a consultant and come up with their own assessment and fee process. Atty said this would be an inordinate burden on Town.

CM Korn said he has three acres and he doesn't have any impervious ground other than his house and sheds. He said Council is joisting at windmills. CM Korn thought it would be a good to have a Regional project; it could be a benefit to Malabar. Ms. Alverez said you are free to use the consultants that they have negotiated with. She did say that you would want to use the TRIM notice to do this, and then the property can be liened if they don't pay.

Acquaviva: Really?

Krieger: Really; I see Kruger and Wilkinson as #1s; most have ranked Jeff as number 1; I didn't turn in my paper at the workshop but my vote is for Jeff as well. I'm just pointing out the obvious. I think we are wasting a lot of time.
