BCSO - Agent Holiday: he is the agent assigned to Malabar and G-V area. Agent Bermuda is also. Good news and bad news. Bad news is that we have had some crime lately. Has worked here for 22 years. Good news is they have been successful in catching some bad guys. He still has some stolen items. By word of mouth most of the calls from Malabar residents have resulted in returned material. Also, have had a kayak recovered from a pawn shop and made arrest. It was a total stranger. On Rocky Point we have had several boat burglaries. There were four actual break ins from docked boats. Successful in identified the suspect and was picked up down in Marten County and returned all the material. Sometimes he calls staff and asks them to put stuff on website. There is still a day time burglary. They will knock on door and if no one answers the kick in the door. They are following leads. Very similar across the river. Eric Weaver and Anthony Brown on the boat and kayak burglaries. Mayor asked if they are in jail. These two are. Eric Weaver is still in Martin County answering charges down there. He did not know about Anthony Brown. As of yesterday, he was still in jail. Mayor asked about the other crimes: when did they take place? A particular day or time? Nothing they can track. Whoever it is, the best thing that catches them is nosy neighbors. As a rural community, it makes it a little harder to watch these neighbors. You must talk to your neighbors. If you think you know something, call. Marisa asked about how many door kick ins? It is not a home invasions unless there are people home. Day time burglaries, breaking and entering. He thinks there may be three or four in the past 6-7 weeks. In Palm Bay that is not a big deal, but here it is. Wilbanks asked if he has something we could put on the website. Holiday said they have made Malabar one of the safest places. Put that there have been some day time burglaries, and to be watchful. Vail said word of mouth is the best method. That solved the vehicle burglaries. That was over 30 of them. When the Deputy responds, they are supposed to canvass but if it is late, or they have calls waiting. He is big on serving the public. Rivet asked about the effectiveness of burglar alarms. Holiday said he likes the loud ones. Some are the silent ones and the burglar doesn't know it has been tripped. They rarely work. The loud ones can be heard across the acre and the neighbor comes out. There is a place in G-V that also uses game cameras. It showed the guy pulling up and it showed his license plate. A lot of video is as cheap as alarms.

Borton asked Chief about the ladder truck repair. The ball valve pin sheared off and needed to be repaired. Have we used it? Twice we have used it: once to Palm Bay and once for a response, but not the ladder part.

At December SCLC meeting, the Malabar Wish was to have more water front access. A question was raised at the Dec SCLC meeting regarding a charge on FPL bill. It is labeled storm charge and has gone up considerably in December, mostly on the street light bills. Council Member Borton asked me to review our bills and contact FPL for an explanation and report to Council. Our FPL contact is on vacation. I have placed a call to the billing department and will report back. We have paid \$174.32 to date, mostly on our street light bills.

3. Award of Stimulus Projects

Chair asked Wilbanks to present. Wilbanks said the memo given to each Council Person before the meeting explained the requirement to award the bids to the lowest bidder for each project. Mr. Stephenson's memo is incorrect. McKnight stated that if we must award to the lowest bidder for each project then Council's job is done. Wilbanks explained that some cities bids came in under the budgeted amount and those extra dollars would go back into the pot. We have asked for some of those monies to fund the difference in our bids and budgeted amount. Mayor asked if there would be competition for this money. Yes, but the County at first was going to automatically get all the extra money, but they are already getting 10% from each city for doing the LAP certification. The money should be used to help small towns that are doing the LAP certification themselves. That is what we are pursuing. We wouldn't have to cut a project. If they had no intention to help us, they wouldn't have said they don't want us to cut any projects.

McKnight said if we can pay for the projects with the stimulus money or if we can pay for any difference with Stormwater funds, he has no problem with approving the bids.

BW said that this was to be done by Carl Beatty. He met with Engineer Bill Stephenson and Carl had a different opinion on how to do repair. Nothing was done. We have taken emergency short term work. Chief said what about the weight? At the time of inspection, the FDOT did not state there was a weight concern but now there may be.

MOTION: Borton / Acquaviva to authorize expense from reserved funds on deposit.

Acquaviva asked if there will be an engineering inspection. Yes. Once the repairs are made there will be pictures sent for our file with the bridge repairs.

Borton asked about how she didn't know about this? The report was addressed to Carl Beatty. Borton asked how that happened. BW did not know.

6. Added item – request for grievance hearing. Mayor will let Attorney brief Council. Erin Harrigan stated she had just read the memo just before the meeting and then reviewed the Employee Manual, and it is better to allow it. Once Council approves the grievance hearing a three person committee is formed. The grievant picks one committee member, department head picks one member and those two pick the third. If they can't make a selection, the Town Administrator selects. There are some time restrictions in the handbook.

His request for administrative leave also is a separate issue. She will talk to Bohne.

Mayor asked who will facilitate the organization of this committee. Would the meeting be in the sunshine? Is it a closed meeting? Erin said looking at the employee manual, you would typically have the issue causing the grievance on a Thursday and then the grievant would take grievance to his department head. Once committee is approved, you would have 5 days to present. Acquaviva asked if the grievant would have to present evidence.

BW said we should use the labor attorney. She has been in contact with him about the FMLA requirements; that is why we gave the last two time outs. If he had another sickness we could track using the FMLA. Rivet said he doesn't want to have the grievance committee until after the holidays.

Rivet said is the administrative leave with or without pay? McKnight thought that should be handled internally by Administrator.

BW asked about the personal effects. Are we allowed to send him a letter to remove the stuff? Erin said we can still continue to work as we. Rivet asked if this is the proper way to address a grievance. No says Erin. But she has no problem telling council they have time to set up a grievance. If he doesn't have anything, then the council will form the committee. Mayor said think up the questions, and council will make a decision at the first meeting in January if he is entitled to a grievance committee. Acquaviva asked if Erin will contact the labor attorney.
