3. Amending Article XV Providing for a Tree Buffer (Ord. No. 2008-08)

Discussion: Mayor at 3<sup>rd</sup> line, Para D: at the top of said tree should be stricken. The other thing at end, where it says greater than 30 feet – strike the 30 feet and insert – "the distance from the canopy to the roofs edge". Attorney will change the "Whereas" to deal with hurricane as well as fires. McKnight asked about permitting. Permits are still required.

Council says this gives the mechanism to take them down. This will go to P&Z for public hearing on July 23 and then first reading on August 4, 2008.
