- Update on Citation Revenue did research and BCSO have not been putting in the city code. That has been corrected. Try to do retro for last two months.
- Update on Playground Tarp tarp is still off because there are serious holes and deterioration to cable and they took pictures and they are attempting a warranty repair.
- Update on Country Cove Bridges started with ants and escalated with heavy rain. Professionally rid ants and then stabilize and plan a long term project to wrap culvert and compact and reinstallation of sidewalks. These are two main access points. Do quick fix and then plan for repair. Staff did nice job on original repair. Bill S. talked to previous TA about this she can find no memo. She will correct problem. Mayor asked Mr. Merrick if he wanted to speak. His concern is that it is the only entrance to the community. He has seen this problem going steadily going downhill. He is not a bridge expert and there are 43 homes in there. It is doe
- Update on Road Closure Investigated this and there has been a criminal aspect that
 have used this. This culvert at Melb Tillman has to be replaced and the town can apply
 and the homeowners can contribute for the culvert. Residents are very appreciative.
 We will have to buy the pipe. Barricades are bright orange and FDOT approved. West
 end of Atz there was an occupied burglary. These are moveable and we can move

- them. East end of Atz has cut the post and opened the gate the town closed ten years ago.
- Update on Interlocal for Radio Network We have only 22 radios. And bill will be revised.
- BCSO Stats included reports for Oct and Nov.
- Malabar Fire Dept Report Chief Joe Gianantonio went over monthly report for November. (Attached to minutes) Fires have been kept to a minimum. Goes over equipment and reported Brush 99 has gone down. Vail is working it as a warranty to replace engine. Practicing with turbo-draft to pull from ponds. Brevard Cty has shown interest in training on same. They will start the connection of the antennas. Once the antenna is online, the PW radios will go online. Fire Chief then showed the training clip. Practiced extraction and real life triage situations. This is done with the Explorers in a limited way. They are the next generation of fire fighters. No guestions for Chief.

CLERK:

- We purchased the day timers to give out to all the Board members, Council and Eagle Corp as a small thank you. Meeting dates are highlighted on inside.
- 2nd conflict Resolution Mtg set for 1/20/2008 at Malabar Baptist Church,1665 Malabar Rd
- Karl and I will review records on Thursday of this week. Estimate from Palm Bay is 5000 documents already and at 15 cents each comes to 750.00 for copies alone.
- Another utility issue is the fact that since we have been paying base rate for the 10 inch meter on Malabar Road, appx May/June 2007, we have been paying Palm Bay a considerable amount more than we bring in from the three customers, four customers with MIMA coming on in Feb 08. Example is paying 2791 and receiving 635. Of that, 76 is over charge for Dr Leedy and Eye Institute who have been charged sewer. We are doing research to see how far back it goes.
- Our insurance is with the Florida Municipal Insurance Trust (FMIT) and is sponsored by FLC Inc. The FMIT Board of Trustees oversees the FMIT operations. They solicit member municipalities annually for nominations for election to the Board. The nominee must be an elected official and must be endorsed by the governing body. Openings on the FMIT Board throughout the year are then filled by vote of the Board on those nominees. Is anyone interested? BWF stated Borton has said she wants to get more involved with FLC. Put on next agenda.

10. Purchasing Policy

Mayor said the agenda report said it may be codified and asked why. BWF explained other cities codes very explicitly spell out the purchasing regulations. It details for the vendors and the administrative said is very clear. This would make it more transparent to the residents. You are going to see a more attentive body and it will show that there is no more good old boys. McKnight said it prevents the appearance of impropriety. Mayor said the PO is required for over \$100. He has no problem with this in the policy but not in codified. The next administrator may want to do it at 250 or 500. The other thing is the 5000 requirement to bring it to Council. There again, doesn't want to see it in the code. The administrator needing to come to council for over 5000.00 was enacted with a resolution. BWF said she would get with the Attorney and remove the dollar amount and bring back as an ordinance. McKnight said he agrees. It is easier to change a resolution or policy for dollar amounts.
