#### **REPORTS:**

## ROSS WHITLEY, BERMAN, HOPKINS, WRIGHT & LAHAM, ANNUAL AUDIT REPORT FOR FISCAL YEAR 02/03

Whitely – the audit is unqualified. The general fund equity shows a nice upward trend, the fund is in good shape. Whitely reviewed the revenues and their trends. He then reviewed the water and sewer fund, this picture is not so rosy, there is a net loss for the 2003 year.

The opinion of the auditor is that there were no inconsistencies, the opinion is unqualified. The only comment is more of a finding, not a comment, and it is regarding GASB34.

#### **ATTORNEY**

Bohne – prepared the ordinance for the annexation, the Clerk has a copy. Rivet – where is the nuisance ordinance? Bohne – Booth is working on it.

#### **ADMINISTRATOR**

#### - MPO UPDATE

Booth – notes that the State is funding less and less for local projects and funding more and more State projects so there is absolutely no worry in widening this end of Malabar Road.

#### - EELS: INTENT ON PURCHASING LAND

Booth – the article in today's local paper stated that the EELs own 300 acres of land in

Malabar, that is way under the correct amount. Hunter – there are over 300 acres in the Jordan scrub alone. Crews – but when the EELs turn the land over to the State it may not be counted as theirs any longer. Booth – the point is that there is more land listed as preserve than stated in the article and that land is not being properly taken cared for. Booth states that the EELs are trying to obtain one more piece of land.

- Booth there is a \$150,000 grant to beautify US1 but he feels that the new view along the river is beautiful already, it looks like Florida. He does not recommend the grant, Council agrees. Booth shows slides of the beautification.
- Booth we will purchase four domes to be used as storage.
- Booth Palm Bay annexed additional land along Babcock.

## **CLERK**

- asks Council for bios for website.
- Kabana will be out of office for six days.
- does Council want food for box at Space Coast Stadium? Council no.

#### PARK AND RECREATION BOARD CHAIR

Hans Kemmler – mower was discussed by the Park Board, Council will address this tonight. Is working on Malabar Day, needs volunteers to make calls and work on the event. Discussion. Havet – is working with the Park Board to extend Malabar Day into the nighttime hours, would be using her discretionary money to pay for evening entertainment. Kemmler – continues discussing plans for Malabar Day. Park Board will make a recommendation for play ground equipment.

#### **PUBLIC COMMENTS: GENERAL ITEMS**

- Jim Newell last week he presented to P&Z regarding their proposed facility and P&Z was not in favor of the project. Newell asks if there is a window of opportunity from Council regarding this. Hunter what were P&Z's objections? Newell they may have a problem with the pet care facility. Havet P&Z is a recommending board, can he come before Council? Bohne yes. Moccia Council needs to review P&Z's recommendation, this item will be on the next agenda.
- Mike Linell has a problem with the mining on Railroad Avenue, there is unfinished work. He cannot open the doors to his shop because sand flies into it. He feels the project is being mismanaged, he would like to see it complete. Booth the trash is to be removed tomorrow and the sand around the edge of the property is being moved. Rossman would like to see the sand wetted so it does not fly. Booth we have requested a silt barrier, once the piles are down the issue will improve. Rossman would like a report next Council meeting. Havet gives Booth permission to go on her property.
- Steve Chalmers expresses his appreciation of Malabar Community Park, he has watched it grow.
- Harlod Wynot regarding the mining on Railroad Avenue. He owns Hidekruger Wells and has a lot of equipment. Asks if there is a setback because the pond is against the fence. Has no problem with the pond, just feels the operation should have been better organized.
- Bill Withers:
- -- on August 7, 2003 the road was renamed going into the Fire Station, where are the street signs?

- -- the red maples at the park have buds and are growing.
- -- Port Orange is having 2<sup>nd</sup> reading on an ordinance that will prohibit smoking in public parks. He notes that one of the larger Counties in central Florida has done the same thing for all County parks.
- -- the new parking lot and access road at Malabar Park have been laid out and are ready for construction.
- -- a fire was started in the EELs property today, it was quickly contained.
- -- the bleachers and the benches for the ball field at the park are installed. Withers asks Council to budget for bleachers for the soccer moms.
- -- we will be putting up additional trash cans in the park tomorrow.
- -- shows Council a picture of a dog in the park, it comes from Country Cove and runs in the park, he is concerned about the sandhill crane eggs.
- Moccia there are two stray dogs that attacked a horse and its rider this weekend on Benjamin Road, animal control is setting traps.

#### **DISCUSSION ITEM:**

# 1. DAVID KIPPER FROM PRINCETON PARK APARTMENTS, DISCUSSION OF SENATOR NELSON'S PROPERTY IN ROCKY POINT

Allicia Spina – is here to ask about the feasibility of development for the Nelson property. Gives overview of their company. Asks Council if they are open to the idea of development. Hunter – is opposed. Rossman – is not entirely opposed as long as it is not rental property. Kipper – they have no expectation of the type of density they have proposed here tonight. Discussion. Bohne – Kippers group has complied with all requirements in Indian Harbor Beach in a very professional manner. They have been good to work with. Kipper – they want to do the right thing, they are well regarded in Melbourne. Hunter – would like the developers to meet with Rocky Point homeowners associations. The developers agree. Discussion. Rivet – if the residents of Rocky Point approve then he would agree.

# 2. TRAFFIC LIGHTS ON MALABAR ROAD AT COREY ROAD OR WEBER ROAD – BRIAN HUNTER

Hunter – he was called regarding an accident at Corey and Malabar Roads. Hunter would like Council to back him in regard to putting up a stop light. The Clerk is to draft a resolution to take to DOT. Would like Booth to come up with the costs involved. Crews – their argument is that there are limited funds and they will not put our project in front of another project.

Booth – this is the \$150,000, this is a 50% match. Council may want something more distinguishable at the Town entrance. Asks Council for ideas. Discussion.

#### REPORTS: MAYOR, COUNCIL

- Havet – Malabar Day is moving along, is working on the night time entertainment. Moccia – who is going to police the people. Rossman – what is the liability? Feels that Havet is changing the flavor of the event.

## MOTION: Crews/Havet to table. VOTE: all aye.

- Crews threw out the first pitch for the Brevard Stars, they are using Malabar Park as their home field, the game was entertaining. There is a need for a closer restroom.
- Hunter there were a few fires in the scrub, they are being investigated.
- Hunter can the fire department use the van to move people out to a fire? Booth sees no problem with that.
- Hunter spoke to Charlie Hart from the Hotel California to ask his patrons to leave a section of fence belonging to the neighbor of the north alone, there has been some vandalism.
- Hunter will support no smoking at the park.
- Hunter the brush pile at Jordan scrub is getting larger, would like to see it removed.
- Rossman nothing at this time.
- Rivet the brush pile on Hall Road, it seems to simultaneously grow and shrink which is a problem. Booth they are to remove it all. Discussion.
- Rivet postmaster problem has had very little luck in getting people to sign his petition. Has heard nothing back from Dave Weldon, would like Kabana to write another letter to Weldon. Havet would like to do a questionnaire at Malabar Day. Discussion.
- Moccia her short-term contract is over, plans to devote more time to Town issues.
