3. SUSNHINE LAW REVIEW: Atty Bohne gave a brief overview of Florida State Sunshine Laws governing Municipal Bodies. He encouraged any CMs with questions about the Sunshine Law to contact him. Essentially the Sunshine Law prevents two members from the same board from discussing Town Business in private. There are a few exemptions such as executive session for pending litigation, or in union contract negotiations. He then gave a brief overview of Florida's Public Record's Law. He also emphasized the danger of social media in public records laws.

December 6th is the next RTCM. Would a 6 PM tree lighting that night be okay? Consensus is yes. The Tree is already up at Malabar Community Park. ITM Morrell also requested to be a Toys for Tots collection site, with a box at Town Hall and a box at the FD. IAFF has approved the inclusion of D/E. Costs are up at the mine for

Stabilizer. EDC has completed a survey for Rivet Ln and should have a cost per liner foot by the end of December. Code Enforcement cases have been opened on the Lett Lane issue. There will probable be two cases heard in December. Still working on the road paving assessment. Road stripping project has been completed. There is a request to vacate Walker Lane, which access 4 houses and is not an accepted road. There are many issues to solve on this case, and it will be brought before you soon. Her idea is to not accept the road but begin maintaining it. CM Rivet requests this be an agenda item at the next meeting.

ITM Morrell introduced this item by reviewing the Agenda Report. A transition plan has been enacted. Start date is January 1st, 2022. Automatic renewal after 6 years. This is not the final contract; however, this is a close copy. There was an option to reduce the franchise fee the Town collects and decrease the monthly amount for the residents. Option 1 is 10% Franchise Fee and option 1a is 5% Franchise Fee.

Mayor Reilly: At the last Council Meeting we passed a resolution opposing HB... and local cities supported it, but the SCLC did not. He suggested it wait until it gets past the committee phase.
