2. Conditional Use Permit Request for an Extensive Care Facility on five (5) acres at 2605 Malabar Road, Ol Zoning; Applicant Vision Quest National

Chair asked Clerk to call property owner who in turn got Vision Quest Rep Steve Reilly on the phone as well.

Chair asked Mr. Wolfington to speak. Mr. Wolfington said he would like to state that it is a "for profit" business and then turned it over to Vision Quest Rep Mr. Steve Reilly.

Mr. Steve Reilly, Vision Quest, they care for kids that have been referred because they have been abused or neglected and are coming through the Dept of Children and Families to these type of places before being placed in foster care. Vision Quest has the option/ability to refuse any child and refer them to some other place.

Mr. Wolfington said he thought the Town's concern was that these kids were delinquents; they are not. It is a like use that is in the area.

Chair asked if Council had any questions for applicant. No questions.

Chair asked if staff had any comments. TA said she would defer to Attorney. She disclosed she has had email communication with Mr. Wolfington prior to P&Z Board meeting.

Atty Bohne said the TA is making a disclosure and perhaps Council should also. CM Jim Milucky made disclosure that Mr. Wolfington had called him. Milucky told him to come to a Council meeting and fill out a speaker card. CM Marisa Acquaviva also disclosed that Mr. Wolfington had called and asked her to sponsor him on the agenda. CM Steve Rivet also talked to Mr. Wolfington on three occasions and to lobby for the project. CM Jeff McKnight also disclosed he had a conversation with Mr. Wolfington.

Attorney stated that the P&Z Board considered this request on April 16, 2013. The Board had tabled the Public Hearing on the project to allow the applicant additional time to provide a complete site plan with all the required information. The applicant did not submit a site plan for the May 6, 2013 meeting. The P&Z Board made a motion to approve and it failed. The reasons stated were the failure to submit the required information on the site plan.

Chair declared Public Hearing open:

Mr. Pat Reilly, Chairman of P&Z Board. It was denied 5 to 0. It was due to failure to comply with Sec 1-6. 1.a. "the applicant shall demonstrate that the intense scale. Reilly talked to 17 people that live around this site and all opposed it. There are three letters in packet against it and one resident spoke against it at P&Z Board meeting. Reilly stated that at the P&Z meeting on 4/16/13 PZ Member Bud Ryan asked what local services the facility would use. Applicant said they would use the park, police and fire, like other facilities. Reilly then read from the minutes where the applicant stated that the court is the custodian.

CM Milucky asked PZ Chair if Malabar Code for group home limits it to six (6). Yes. CM Milucky also said the facility would use public transportation and we don't have any.

Mr. Pat Reilly, Malabar resident, 1895 Howell Lane, made a public records request to BCSO on the Devereux Home in Viera and he received it. The BCSO had 235 reports done in 16 months; that is 1 every other day. They had 67 Case reports that included Baker Act, Abuse of a child, Assault & Battery, Criminal Mischief, Sexual Battery, Suicide threats, and felony arrests. There were 82 Verbal Disturbance reports; 25 investigations; 8 missing persons; 9 911 hang-ups; 11 injured persons; 1 drunk driving and 31 AOA reports. He did not know what AOA stands for.

Mr. Reilly said that this proposed project has the potential for the same types of responses from the BCSO. The people who he talked to said they didn't care what it was called, they didn't want it.

Chair declared Public Hearing closed and brought it back to Council for discussion.

Council discussion. Mr. Wolfington asked to speak. Chair explained it is back to Council for discussion and if Council permits they can ask him questions later. CM Marisa Acquaviva said the lack of the site plan, after being given additional time to produce one went a long way with her. The cost of a site plan is part of the cost of doing business. Also the fact that he didn't appear in person to present the project.

Mr. Jay Wolfington asked if the facility was only for girls. Would that make it more acceptable? Chair said applicant should have introduced it at beginning of meeting. CM Marisa Acquaviva said she had three (3) girls and they can also be wayward. She felt they could still have the same type of issues.

CM Milucky Council Chair Rivet asked P&Z Board Chair if it would have made any difference if it was for only girls. Mr. Reilly said he did not believe so.

MOTION: Milucky / Acquaviva to deny the CUP for Extensive Care Facility on 5 acres at 2605 Malabar Road, OI Zoning, as presented.
