Discussion:

Franklin said the discussion at P&Z indicated there would not be support unless the question had a specific property and amount included. She printed out the Capital Improvement Plan approved by Council and suggested that they may want to reference the three land purchases listed in that document in the question.

Franklin also spoke to Cape Canaveral regarding the voted debt. It does not have to be for a period of two years; it can be for longer period. Also he suggested a better method is to use FLC staff and use the bond issue.

Mayor said 1 mill of the final certification of property value in 2011 would bring about \$166,000.00 or \$332,000,00 for two years. They could add the projects such as the top three in the Cap Imp Plan. Once it is approved, then Council can decide on how it will be spent.

McKnight heard three reasons for referendum: purchase riverfront, for town hall or buy land because it is cheap now.

Rivet said if we don't have specific property in mind, one mill is a reasonable percent for voter consideration and enough to reasonably acquire land for a needed town purpose on the Capital Improvement Plan.

Acquaviva, if this is just to buy land, to have it in our coffers to buy land but not do a project or build something. Yes. Rivet said we could have another ballot initiative to raise money to do the development.

Chair said to revise the ordinance to reference the Capital Improvement Plan and specifically list first three things. Rivet said it should also add "or other park and recreational purposes as listed in the Capital Improvement Plan.

Mayor asked Attorney it they need to have another first reading since they added this. Bohne said no. ROLLCALL VOTE: Beatty, Aye; White, excused; Rivet, Aye; McKnight, Aye; 1)Acquaviva, Aye. Motion carried 4 to 0.

Franklin explained McKnight asked for this to be on for Discussion. TA thought we would have information from Engineer in time to put in agenda packet so we made it an Action item. Did not get information until today. Since the expense is over 10K, it must go before Council. McKnight said he just did not want it to fall off table. No action at this time. TA working on and will bring back. No further action at this time.

#### 11. **Golf Carts**

McKnight asked if it is a liability issue about the horse signage and also with removing the stop signs, is it also an issue regarding allowing golf carts. Bohne said you have to post signs. Acquaviva asked if there is a groundswell of people that wanted golf carts. Mayor said one Malabar resident ask about this. Acquaviva said if there is a ground swell she would consider. We have a lot of horse people that asked for signage and we didn't buy the signs. He sees what looks like golf carts. Bohne said they are clearly defined. Bohne said there are prohibitions on other types of 4-wheel vehicles. Rivet said if we can ride horses then we should be able to ride golf carts. Bohne said you have to make a determination, not necessarily an engineering study, to determine if roads are able to accommodate them safely. McKnight said sign needed on every street? No, but Council decides where to put signs. Rivet said the obvious ones to exclude are Weber, Corey and Malabar. They would also have to follow the rules of the road. Bohne said Grant Valkaria did allow them on Weber and Corey.

Beatty said one level of threshold if at night, they have to have lights, age issue, can drive at age 14. Other vehicles can be used on roads but because of speed, not allowed on road over 35 mph.

Beatty would like to see us engage the FIT graduate students to look at the impact of allowing this, any changes we would need to make. FIT engineering students. Acquaviva says how many persons are we doing this for and buying signs. Beatty said people in subdivisions like Brook Hollow would like this. Same with Stillwater Preserve. Beatty is proposing FIT, virtually free, they can do traffic studies. Next

year they are doing an evaluation of Corey and Weber. Rivet asked if he had a contact there. The graduate students work for virtually nothing. There is a think tank

McKnight said Town bought signs for entrances. If people want them they can buy them, pay for signage. Golf cart crossing signs would be bought by Town. Bohne said they also have signs around the neighborhood, "Golf carts sharing roadway" and reference the Ord # at their entrances. Bohne said if you can get word out otherwise it is ok, but you make the decision on where to place them and what the wording says. The county in Suntree, "golf carts share roadway". Several areas would take advantage of this.

Acquaviva said we can have Beatty contact F.I.T. and bring back information. Trailer Parks have private roads. People that can't walk that would use them. Acquaviva said she has not heard of people wanting this. Mayor says the people that have them do what they want and don't come in and ask for an ordinance change. Beatty said he will be back with info at next meeting.

## 12. Traffic Control Devices on Malabar Roadways (Beatty)

Recommendation: Request Action

Brian Vail, 2700 Smith Lane, read through the portions of the MUTCD handout and his take is that this is a local decision. He referenced Home Rule and said we should be able to put traffic control signs in as the Council sees fit. He read part of Section 1A.07 that stated the placement of traffic control devices shall rest with the agency having jurisdiction, the town. He referenced 1A.08 which gives the authority to place traffic control devices solely to the public authority having jurisdiction. The requirement is for all traffic control devices to meet the guidelines. The reference to the engineering judgment is within the authority of the Town.

Vail said he read the Mayor's memo; but as he read these same guidelines his understanding is if it is local roads, it is local decisions. We should have the say in these. The signs should meet the standards stated in the MUTCD.

Mayor pointed out error in his memo; it was 103K not 300K for the comp plan review.

Acquaviva wanted to speak about the Mayor's memo sent out after the meeting. She thought he was chastising the two who did not vote in support of removing the signs as if they were not thoughtful in their votes. She is appalled that he would write such a memo. Mayor said he was puzzled and that is the word he used. Acquaviva said that pulling stop signs at a very busy intersection that has been up for many years, she would have liked to research that indicated it was necessary.

Beatty said several factors relate to the MUTCD. One area says shall, if you put a sign up it shall comply with guidelines so it is like any other sign in Florida.

Book has one section on culverts relative for DOT standards, so if Town chooses to uses those, we can piggy back.

The segment in-between says you "should", like a recommendation. What the Town decides is at a local decision. If it says you should do a study, that's fine but it is not required. The Town did direct and put the signs up and they were put up 8 years ago. Pulling them now will cause other issues. Concern at Weber and Corey had nothing to do with speed control. The controlling was to make it safer without getting t-boned. He was there.

MOTION: Beatty / Acquaviva to rescind the action the Town took at last meeting related to having stops signs on Corey Road at Atz removed.

Chair said point of order. He said Beatty can't call for that. Attorney Bohne stated that Beatty called for a motion to rescind in contrast to a motion to reconsider. Motion to reconsider can only be brought by member of the prevailing side. A motion to Rescind can be brought by any one.

Discussion. McKnight said there is no rush. He doesn't have problem with doing further study. He voted to support the removal at last meeting because if the Town is liable he was going for cheaper route. He still thinks they should either both have 4-way stop signs or not. They need to be equal one way or the other. Acquaviva said they shouldn't rush to judgment. Need to reconsider this.

TA said she has asked Palm Bay if their Engineering Dept could do the studies and they can. If we use Palm Bay to do this, then look at both intersections for study. Mayor said we need to make sure we do further study.

VOTE: All Ayes.

McKnight was under impression, if there was not a traffic study then sign is illegal. Beatty said the language said we *should* do a study, not shall and Council discussed the matter and voted to put the signs up.

Mayor said if you don't do it by the manual there could be liability. Dick Korn disagreed with him.

Bohne said he did not say if it was legal or not legal. Bohne said at what point was the decision made. McKnight asked how do we determine if it is legal or not?

TA said we have 138 stop signs.

Beatty says the Section that says do a study says should.

TA said she went to Palm Bay and they could use their in-house Engineering staff to do study at Corey and Atz and they offered to do it.

TA said she was asked why she didn't have the sign up announcing the stop sign was coming out. Mayor asked why signs weren't up. She had two Council persons who had requested this be brought back. The estimate for the portable electronic sign is \$1350.00 plus \$75.00 delivery. She did not want to commit that amount of money knowing it was coming back before Council.

Mayor said it would be good to get a professional opinion instead of emotional one that existed when stop sing was put in. Bohne said if the signs were put up illegally, there could liability. Acquaviva said Florida Statute 316, 006, states cities shall have jurisdiction and may place and install traffic control devices.

Beatty said they should use the students at Florida Institute of Technology (FIT). TA said no they must be certified. .

Mayor read 316.045. All official traffic control devices shall conform.

Discussion: Acquaviva was not sure they decided to have no fees. She supported repealing the fees in place. Rivet said the fees were to cover the cost of the Fire Marshal. Since there is no incremental cost, then there is no need for a fire inspection fees. Acquaviva said what about if they want to charge a nominal fee in the future.

Rivet said if they hire a fire marshal in future, they can reconsider. Beatty said the fee schedule was copied from the county. A business was charged \$100.00 and another business was charged \$120.00. Acquaviva said she was aware of those and that is why she wanted those fees repealed but to not have any charge? She said we are discussing not having any charge. It can be looked at in the future if council wants to impose a nominal fee at some point.

Mayor read 50<sup>th</sup> anniversary proclamation. It will be read again at SpringFest. Also will have copies available at event for residents. Mayor thanked Franklin for research. Franklin said she will have another done for meeting in December.

Mayor also Proclaimed a Certificate of Appreciation to Brain Vail. McKnight said he can help with top and brass if needed.

Mayor also Proclaimed a Certificate of Appreciation to Rick and Chris Rakauskas for writing the Malabar Song adopted by Council in 2011. It will be read and presented to them during SpringFest.

#### N. STAFF REPORTS:

ADMINISTRATOR:

- Gave info on Palm Bay traffic engineering earlier.
- She will be contacting each Council Member separately to discuss something personal
- Fire Chief nothing.
- TA showed the pix from the recent PW project. Beatty said he did a similar job to the south of there and PW did it with plastic pipe and had clean connection. One issue is there is a primary power going across there. Shut power off for two hours. They are close to that last culvert. Beatty said they didn't have engineering we just did it.

#### CLERK:

- We are in high gear for preparations for SpringFest. Still need volunteers; looking for qualified persons to take shifts in driving a tractor pulling a trailer to haul people around park. Would also like qualified volunteers to work the beverage booths.
- The Park Bd will hold a public hearing on the grant ap for FDEP funding for a restroom at the Sand Hill Trailhead. Their recommendation will be at Council on April 2, 2012 for Council adoption of resolution to commit to the Town's portion in in-kind services.

- We will have t-shirts with the cow bell logo for each participant in the 5K. They will also get a free pancake breakfast so the SpringFest Committee will be paying \$5 for each registration for the race to compensate the Fire Dept.
- We will also have 50<sup>th</sup> anniversary t-shirts for sale at SpringFest, a lapel pin, ball caps and tote bags. The quantities were chosen to get the best affordable price. We have also purchased prizes to award to the "winners" in the Kids Zone. We will be offering wrist bands for the Kids Zone to play all day.
- Re: Item 9, she explained the applicant realized after the rain two weeks ago that he needed a venue indoors for musical instruments. He would like to thank council for their consideration and may come before them in the future to offer free concerts in the park at Malabar Community Park on a monthly business and may ask for their consideration to waive use fees. The parks are first come, first served and there is only a fee if someone wants to reserve and have exclusive rights to an area. The Blue Grass Bunch uses Sand Hill Trailhead on first come first served basis.

Remember from last mtg. Recommendation from atty. Situation with Mr. Morris. Town has requirement in code but doesn't say how. Make that more specific. He thought our town eng could make some recommendations on what could be added to code. Develop any kind of property be kind of specific on how to retain the water. TA said Eng Smith would have many suggestions. OK with Council. McKnight said Eng called him, it performed in the rain. He was out there in the rain. He wanted him to convey to the Council.

Beatty said we talked about this at 7PM and don't want to do things so based on that he will pass on that.

### 15. Stormwater Utility (Beatty)

Stormwater utility, previous statement on graduate students if we can use them in any of this. TA said stormwater would have to comply with NPDES. TA said if he could get a list a resources and contact numbers that would be helpful

## P. REPORTS - MAYOR AND COUNCIL MEMBERS:

- 1) Beatty: Public Safety employees can get free training at Barry University and he will give to Clerk and she can mail it out to everyone. Re: procedures, he will be out of town on May 7. Will be part of SCLC fly-in to Washington DC. It appears SCLC is funding it in full for 4.5 people. Georgia Phillips of Rockledge is 50% funded by her city as she goes up every year. They made vote at last meeting. Referencing the Boards, he said they each go to the Chair to ask for an excused absence. For Council, our rules say it is up to Council to determine if he is excused. Acquaviva said she was sure they would mark him excused for his trip to Washington DC. Beatty said he went to the Revenue Workshop in Feb at Altamonte and he learned a lot that will help him at budget time. Acquaviva said she appreciates his work at the SCLC. Beatty said SCLC asked for six volunteers and only got five.

Mayor says how far into discussion. Procedures say that the card must be in before council take item up for discussion. At Council request that is how he will change it. Make that an action item. Review Council procedures for cards. Make it action and get procedures to Council.
- 4) McKnight: Resident asked about Coquina Drive and Rocky Point Drive. As long as it remains open, they will be looking at a patch. They claim it is also a safety issue between the two back yards. There is a fence. The one that is caved in the back yard. Caved in on north side of house. There is one at curb and one. They have to remove a lot of stuff. There have been

- some concerns. TA said if it is on the inside of their fence. Tom will look at it tomorrow. If they could mark it with flags.
