MOTION: White / McKnight to approve the consent agenda.

ROLL CALL VOTE: 1)Beatty, Aye; White, Aye; Rivet, Excused; McKnight, Aye; Acquaviva, Aye. Motion carried 4 to 0.

PUBLIC COMMENTS: General Items not related to agenda items; Speaker Card Required Bromley Ball, regarding MSTU we pay 1.6mil in county taxes to fund the sheriff services and then they are asking us to give an additional 1.3 mil with the MSTU. Does anyone get this? TA said the MSTU pays for patrols. We pay 1.6mil for general county tax. Then the MSTU asks us to give an additional 1.3mil. What do we get for that? TA said we would get an additional four deputies for south area. Malabar is 1/10 of the south precinct.

McKnight agreed with that whole heartedly. The year the MSTU went into affect we got 4 new deputies. Then in the following year we heard that they were lost to normal attrition of 4 officers. That is a lot of money going for a little service. Do we continue this or not. He addressed the audience. Does everyone pay the MSTU?

TA said we were the only town that was not paying. The other cities that don't pay have their own police depts.

Chair said when he was Mayor, this was an issue. The State statute requires the sheriff. Cape Canaveral was paying the MSTU and stopped when they got their own police dept. Then they got rid of their police dept and now they have to do the contract with BCSO for services.

TA said the general fund taxes pay for jail services and those types of expenses. TA did verify that they still have four bodies in the south precinct area.

McKnight said the website showed that the south precinct was identical to what they are providing Malabar. There is no control over the millage rate. It has gone up.

TA said she could ask Cmdr Ambrose to come to next meeting and speak to this issue.

Bud Ryan, MSTU, since this referendum came up and he has talked to trash men, anybody, post office, telephone guy, Eagle Patrol lady. They have all said they rarely see BCSO in Town. He questions what we are getting for the money we are paying. The Eagle Patrol is down to one day a week, on Tuesday.

Mayor said if you reject the MSTU then you have to provide your own policing.

Bohne said the constitution requires the sheriff to provide law enforcement. You will eventually get a law enforcement response to incidents and criminal law. They will not enforce local law and they won't be here to run radar.

TA said they are out at Corey, is due to the new 4-way stop. McKnight said that was on Weber.

McKnight said the Statement of Work listed that they provide the citizen patrol. TA said they did offer and former Mayor Tom wanted our own patrol.

Bud Ryan asked when they are going to resume the taping of council meetings. Council replied that this was discussed at a recent council meeting. The taping creates public records issues when they have to be duplicated. The recent lawsuit tapes had to be copied in real time. A better method has to be found. TA will be bringing proposal from vendor that does our website.

Ryan asked - bottom line, what would happen if they don't approve MSTU. Bohne said they will still enforce criminal law.

Beatty said look at an MSBU, "benefit area", we control the millage rate and then structure what kind of coverage we want. He suggested having a meeting with sheriff.

Brain Vail, if you don't have the MSTU deputies he said you will get general fund officers. They would not be easily available. If you want quick response you need to pay the MSTU. That is the difference. The actual guys on the roads are paid by the MSTU dollars.

Acquaviva said we have a sub-station, do we get any for that. TA said using this substation allows the deputy to get back on the road quicker. McKnight said he brought that up before. They are taking our space for free and we are in need of more space. McKnight said another thing that bothered him was the parking spaces. There are a lot of cars here tonight and many of the spaces are taken by patrol cars. TA said there are three cars that park here at end of lot. Tonight was an unusual situation with a call finishing up from this afternoon.

# Ordinance Setting Budget FY 2012/2013 (Ord 2012-59)

AN ORDINANCE OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA ADOPTING THE BUDGET FOR THE TOWN OF MALABAR FOR THE PERIOD FROM OCTOBER 1, 2012 THROUGH AND INCLUDING SEPTEMBER 30, 2013; PROVIDING FOR ADJUSTMENTS, AMENDMENTS AND REPEAL; AND PROVIDING FOR AN EFFECTIVE DATE.

Section 1. The Town Council of Malabar in regular session duly assembled adopt the final budget of 1,861,349.00 for the proposed expenditures from October 1, 2012 through Sept 30, 2013, reflecting the general operating millage of 1.6630. This total budget is comprised of \$1,564,126.00 in the General Fund which includes \$250,000.00 in one-time revenue from the sale of the utility and \$297,223.00 in the Stormwater Fund.

Chair directed Clerk to read by title only.

Chair declared Public Hearing open - Question from audience on purpose of this ordinance. She asked if this is to keep it the same. Mayor explained that on certain streets some speed limits may be reduced. It was first requested by residents in Brook Hollow for Briar Creek blvd. Atty Bohne added that it authorizes Council to order the reduction of speed in all residential areas. This gives town authority to do so.

## Chair declared Public Hearing closed

MOTION: Acquaviva / Beatty to approve Ord 2012-57.

Discussion: McKnight said we are reacting to a group of people and we need to be careful. Evidently this is not a complete community consensus. We have complaints coming in about the speed humps. Acquaviva said you will never get 100% support and they had brought in lots of people to support their request. Mayor said this is a closed community. He said if you go to any military base it is 15mph in the residential areas.

ROLL CALL VOTE: Beatty, Aye; White, Aye; Rivet, Excused; McKnight, Aye; 1)Acquaviva, Aye. Motion carried 4 to 0.

Recommendation: Request Action

Bromley Ball, US 1, you are proposing reducing land use in areas on property he owns. Initially looked at it and if he wants to sell it to someone to put on townhomes on the buyer couldn't put six per acre; only four. He said he had been paying taxes on this land based on the land use permitting developing at six per acre. Will his taxes go down? Is there any provision in there - any grandfather clause. Seems to be taking away some right we have already have. Mayor said zoning changes always do that. Acquaviva said we brought this up at other discussions.

McKnight said could we add in a clause to allow the current property owners. Bohne said the question becomes what are you grandfathering. You have to figure out who owns what and specify it in the ordinance. It could be done. He did something like this in W Melb years ago and it is conceivable. Create a grandfathering clause to do so. McKnight asked Reilly to come up.

McKnight asked P&Z Vice Chair Reilly about grandfathering; could Board consider that? Reilly said the rest of the ordinance needs to be done, the changes to the definitions and wording in the code. Council could approve the recommendation and strike the one issue of reducing density from six to four. The Engineer or Franklin did a map and there was no way they could do six per acre with the other requirements anyhow. That is the way more than half the Board felt. Don't send it back to P&Z; they have been on it for a year. The drawing they had reviewed showed how much building area you could have with the other requirement and you can't do six per acre.

Juliana Hirsch, 1035 Malabar Road, said she did not support the reduction in density. The dimension requirements will take care of the development allowed. She said the idea of reducing the density to four was an off the cuff remark by one of the P&Z Members and it went from there. It has been six for all of this time and we have had no problem. She would like to request it to remain at six. If they can't do it then do a smaller development. All agree.

Brain Vail, relayed a situation in Palm Bay, was multi family, assessed for water, per unit of what the zoning was in area. The building department would not give permit to build 10 per acre. That is a potential problem and gave them food for thought.

McKnight explained to Ms. Hirsch about the change in policy to allow comments from the audience once recognized by a Council Member.

Consensus of Council to approve the P&Z recommendation on R/LC but striking the change to the reduction in density from six to four.

Chair asked if Park Board representative would like to address Council. Dick Korn addressed the batting cage. He challenged where it would be placed. They said that was not a problem. Recommendation was unanimously made by Park Board, Scott will install and it will be used by existing league and future leagues. It is a generous donation. Accept his generous donation. Council approves.

Huggins Park - move gazebo from here where it is not being used much and Park Board is working on changing it into senior citizen attractions. To that end we will apply for grants and may get a new one or pavilion as part of the retro. The gazebo is not being used. Hans Kemmler is very involved with Disc Golf Park and the gazebo would be used by members and players. Hans has done research and cost is \$350.00 to have it professionally moved. Thinks this is a worthwhile expense.

White commented that just like McKnight's previous comments, once Council agrees to move it we may still get complaints from others that want it to remain. Mayor said he could speak to this item as Huggins Park is next to his home. It had been a children's park but before that it was used for prostitution. The gazebo gets almost no use. Korn said Dep Hammer is grandson of Huggins and he has no problem. Disc Gold is so popular. Hans explained that it would be near the front of park on the back side of the fence. Council approves.

Original FRDAP grant included a sandy beach and it has not been maintained. But it could be used for swimming.

Board felt they did not want to include a lot of do not and no not. They would like the information posted.

Mayor said the cases of amoeba are much less than the number of deaths by drowning.

Bohne said the issue is the liability if they don't put the no swimming signs up and you have the signs warning of the dangers.

Korn said Park Board's two concerns - health is addressed with the sign 2<sup>nd</sup> is swimming at your own risk – per Bohne

McKnight said less risk by doing nothing. Bohne agreed. Nothing is better than something in this case.

Ben DuBose, 950 Falls Trail, this is the sign at Veterans Park. He was at Park Board meeting. Franklin explained they do also have other signage at Veterans Park that says no swimming. We did not show that at Park Board meeting.

## Consensus to table this part until Council meeting on November 1, 2012.

TA said she will have information on this for this meeting.

McKnight met him at TBRB and is all for it. To work on this at any level possible.

Dick Korn thanked Franklin for doing research on the reactivation of the committee. They reactivated it as a committee not a board. We never had a meeting. The committee exists and is dormant. He pushed it at the time. Appoint someone to be Chair of this committee.

As long as it is not a fact finding. Franklin then explained the need for two groups. Marisa asked about difference on the SpringFest Committee, sometimes it is sunshine and sometimes not. It depends on what they are doing.

Drew Thompson, basically his perception, there was a budget allocation. Town's needs a great trail plan. Sense of desire to get involved. Bring together aspects the committee could also be on the work party. They want to be presenting to council when decisions are warranted and then volunteers, could be both. Further in the woods those decisions, are not sunshine, minimize the recommendation and get more. Mr. Thompson. Separately we had right to pull the right people together. Committee would be a recognized. Those same 2 or 3 or 1 persons could be working a tree. Don't mean to beleaguer it. Change language in body, to match title, subject to council approval. Acquaviva applauds him for being willing to do this.

McKnight is on the fence. He doesn't think it will be unbiased.
