MALABAR TOWN COUNCIL REGULAR MEETING May 16, 2011 7:30 PM

This meeting of the Malabar Town Council was held at Town Hall at 2725 Malabar Road. Mayor announced there was no quorum at 7:45PM. McKnight is out of town on business; White is helping his mother with medical related issues. Beatty is not present and has not answered the calls to him. Chair asked CM Rivet and Acquaviva if they wanted to have a general public meeting to discuss some of the items. If is proper, he asked attorney. They can take no action and have no votes. Chair said if Beatty arrived they could commence with regular meeting. Acquaviva agreed to the discussion and did propose adding an action item. Mayor said he also was going to mention that. Acquaviva stated it was unfair to those who were here on time to have to be delayed by late start. Mayor stated in reference to 1.d. Public Records policy, he had question about 4.a. and thought there should be a definition for extensive request. Franklin suggested a \$20.00 limit could be inserted there. If a request came in and was estimated to exceed \$20.00 then a deposit shall be required; that would be a lot of copies at .10 a copy. We collect that now using the F.S. Having this policy will provide the staff, at Town Hall and Fire Dept., the process for handling public records. It would also allow for collecting for media such as CDs and cassette tapes. We don't collect now because of lack of policy. We do not charge for scanned documents or faxed documents.

Chair then asked if BCSO Lt. Scott M had anything to report. (Franklin ask him on Tues about alleged pot bust at Lundy's old house for grow house on Sat – (pot 6' high according to Wilbur); nothing in paper or on TV.

Acquaviva asked about accident at Corey and Malabar Roads and Palm Bay police being first on scene; she understands that is procedure, correct. Yes. Then same day she saw a Palm Bay police west bound stop a car in front of Malabar Community Park. Could they issue a ticket? Lt said they could pursue into adjacent municipality. If she has question in such a case, she should call Palm Bay police. As he stated at last meeting, Council can call Palm Bay police and ask about such stops. Acquaviva stated Franklin has done that in past for Council.

Chair said regarding K.3., Fire Inspection Ordinance on agenda, there has been much discussion on this at the last meeting. The revised ordinance on this agenda does not provide for authorization of apartments private living quarters. This ordinance does not authorize fire inspections in rental apartments or multifamily units, except for common areas. Mayor pointed out there is a proposed project for assisted living facility that will not have any fire inspection because they would not be authorized in the apartments. Franklin stated to Chair for clarification, those would not be apartments; they are units of a facility. Chief Covey stated we should inspect all units of rental apartments and quoted from a recent news article where people died in an apartment fire in IL due to one apartment not having a smoke alarm.

At this time, 8:00PM, CM Carl Beatty arrived. Stated he had fallen asleep and the multiple calls woke him and he rushed here. Acquaviva asked if he was ok to go on with meeting. Yes. Mayor stated they could proceed with regular meeting.

A. CALL TO ORDER:

The meeting was called to order at 8:03 pm by Mayor. The prayer and pledge were led by Council Member District 3 Steve Rivet.

CM Rivet called a Point of Order to Chair. The Malabar requirement for a quorum is three Council Members. He asked Chair if it was for three sober members; Beatty appears to inebriated. Chair asked Beatty to respond. Beatty said he had no response.

CM McKnight had said it was an important and controversial item. Acquaviva said the ordinance proposed on the agenda is from P&Z; drafted by attorney and reviewed by P&Z twice and included their recommendations. We are correcting something that needed correcting. She wants to leave it on the agenda. Rivet said it is important enough to have all five council members. Pulling it or move to discussion. Pull it.

Beatty wanted to ask some questions. Specs call for pulling out material at potholes and redoing. Are you aware of what is there? Town Engineer Morris Smith said yes and the bidders are; 4" of cold patch, 4" of base. Beatty said there is appx 3" or more of actual bed rock. Engineer is aware of that, he did profiles for specs. That was put in over and above. Then there are the two turnaround areas; the approaches on each end; he means aprons. There is no marl under those. They were paved over dirt. Beatty wants those portions to be brought up to the other part of the road. Town Engineer stated we could write that up as an addendum to the contract if necessary. TA said now you are changing the scope of work on something that has already been bid. Engineer Smith stated Town could do a change order to the contract to be awarded but it would increase everyone's bid proportionately. TA asked Attorney if we can approve the bid and then do a change order. Town Engineer Morris Smith stated after conferring with PW Mgr Tom Miliore that the recent pipe replacements at each end of LaCourt did upgrade the base under that area and finished with the cold patch and the asphalt. What was done previously is what we did on those projects. Mayor asked Beatty if he was satisfied. Beatty didn't want us to have to pay for 8" on a pot whole repair. TA said the scope of work was prepared by the Town Engineer. Beatty had personal information because he did the work. Acquaviva asked when he did it. Beatty couldn't remember.

Doesn't need clarification; if it pertains to town business not charge will be required. If it a separate public records request not related to town business, then fee will apply. TA said Franklin has gone out of her way to provide records requests at limited costs. If scanned or faxed not charge.

Bought property sight unseen and fell in love with it after two days. She has encountered such gracious people; from Clerk's office to Building Department to neighbors and fellow residents. It is dream come true. She has also sat on Board for Melb Beach and said Malabar meetings are more sophisticated meetings. She looks forward to coming to more. She is happy to be here. Mayor asked if she knew Mayor Stacy; yes. He will tell him about his former resident liking Malabar. She has cleaned up her new property and people are stopping to comment. CM Acquaviva thanked her and said it is nice to hear thanks. Ms. Kinzer is a nurse/paramedic and knows and understands what a good word does.

H. STAFF REPORTS:

ATTORNEY: hearing scheduled for having surcharges deposited. Hearing is set for August.

ADMINISTRATOR:

- She wanted to recognize Chief and FD for recent event at Malabar Community Park.
 Scouts were set to stay there for a crossover ceremony and got rained out. She thanked FD for helping them finish by opening up their bays for the cross over for scouts. FD helped them out.
- BCSO Lt Scott Molyneaux no crime to report for April.
- TA showed pictures from the PW cleaning of the Town's drainage pipe from the FEMA project and stated the pipe is flowing and overgrowth is cleaned out at pipe. Carl Beatty said we can't reach far enough in to clear the blockage. There is a built in weir from the material thrown in at earlier times. TA thought that is what they dug out. In the past they hired a "menzie muck" machine and they could not even reach this blockage. TA will find out with estimate from local contractor provided by Bob Wilbur and bring that back to Council. TA asked how long this has been. Beatty said it was a long time. TA will bring back to Council what she finds out. The TS Fay didn't flood anyone. We can't break the bank if we can't afford to clear the area CM Beatty is referring to. That is the blockage. They will meet tomorrow. PW Mgr Tom Miliore asked where the blockage is. Beatty said 50-60 feet back. It is road material thrown off; can't do it with a shovel. He referred to a lawsuit and a court agreement between FEC and Mr. Glatter and they did pay Mr. Glatter for crop loss. TA said we may not be talking about the same area. Mayor said could Beatty could get with Tom Miliore and show him. Yes.

Following that Acquaviva said thanks to PW for their good work on the Golf Disc Park also. The good work will be a benefit to all for a small inconvenience to some. The overall project looks good when she drives by and she knows they will appreciate it.

Franklin explained that we have been making electronic payments to the state for over ten years. We are also paying some of our recurring expenses via electronic checks. As we evolve our accounting policies we will pay more expenses via EFTs or P-cards. Our Charter needs to be updated to provide for this.

Mayor said we should just delete it.

The Charter used to require all candidates to provide a petition. During an amendment in the 1990s it was amended and Council and Mayor were separated and the petition requirement was left out for the Mayor.

The other request is to add a sentence to the Charter to clarify when elected officials take their seat. The Charter deals with election and terms and should state when they take office.

Also want to mention redistricting. Council consensus for Clerk to draft the ordinance.
