

**MALABAR TOWN COUNCIL SPECIAL MEETING  
NOVEMBER 6, 2008                      7:30 PM**

This meeting of the Malabar Town Council was held at Town Hall at 2725 Malabar Road.

**A.     CALL TO ORDER:**

The meeting was called to order at 7:30 pm by Mayor Eschenberg. The prayer and pledge were led by the Mayor.

**C.     ACTION ITEMS: Certification of Election Results:**

Franklin explained that there was no election for District 1 and 2 as they were unopposed and the respective Council Members, Nancy Borton and Brian Vail would be sworn in to serve another two-year term.

There was an election for District 3, and the unofficial report lists Steve Rivet with 598 votes as the winner.

There was an election for Mayor, and the unofficial report lists Thomas M. Eschenberg with 1081 votes as the winner.

There was a referendum question on the ballot asking voters if they wanted to continue with the law enforcement MSTU and the unofficial report list the response as YES with 1299 votes or 84.29% of the voters.

Franklin then asked Steve Rivet to stand at the podium and raise his right hand and read the Oath of Office.

Franklin then asked Nancy Borton, Brian Vail and Tom Eschenberg to raise their right hands and read the Oath of Office and insert their names.

Out going Council Member Chuck McClelland read a statement. He has enjoyed serving on Council and working with staff. He stated much had been accomplished. He agreed with a statement Dezman had made at the last meeting, that this Council might not have always agree on everything, but it was a good Council and had accomplished a lot of good for the community and he did not want to see that slip away. He hopes that it is not undone. This Council was not corrupt as stated in a letter that had been mailed out during the election campaign by Rivet. He said the letter contained lies. He said he would be attending the Council meetings and continuing to participate in the system.
