**C. ACTIONS ITEM:** Vice-Chair stated the special meeting is required after the election and asked Franklin to explain.

Mayor welcomes Acquaviva and recognizes that she has been in attendance at previous meetings. He stated that none of meetings as far back as he can remember have been contentious. There have been disagreements; it does happen from time to time. He stated Council Members can disagree up here on the dais and debate and then be friendly when off the dais. That was also true back in the 1990's when he was a Council Member. He disagreed with two other Council Members constantly, but the three of us were best of friends when we left the dais. He welcomed Acquaviva again and asked if she would like to make motion to adjourn this special meeting.
