Discussion: CM Mahoney said this is a public document. It is not always representative of the public. Would not like to approve until they can be more precise minutes. Chair asked if there were any other specific corrections – hearing none -

E. ATTORNEY: Re: Marijuana Treatment Centers - State Legislature still hasn't made final rules and regulations – Malabar may have to relook later, as most other municipalities have done.

PUBLIC: Dave Kello, 1041 Hall Road, had pleasure of meeting a lot of the council members at the past Saturday Fire Academy at Malabar Fire Department. He has lived here for years and watched how Malabar has grown to accommodate the new residents. Some changes are good and some were out right dangerous. Their family identified some very serious electrical modifications that was done without a permit and it endangered their family. This past Saturday of last weekend spending three hours with the Malabar Fire Department volunteers, showed him both the physical and the psychological stress they deal with. They will blindly walk into our homes to protect lives and properties. He thought he was ready and he realized that he is in no way prepared to do that. He would like in the future to talk to the Malabar Fire Chief about volunteering. He stated his brother is also a fire personnel in another jurisdiction and he asked who do they find. The tough one is the kids. Fire Dept personnel find kids in ovens, dryers, and under their beds; the adults are usually within ten feet of the exits. The fact that the question of getting rid of the Malabar Fire Dept even came up is unbelievable; to add to the response time is one of the most terrifying thoughts he deals with; he wants his family to stay here the rest of their lives. He is very supportive of the small changes that council is making for the FLUM on the arterial corridors; allowing commercial development along those corridors will provide additional needed tax revenues to assist in funding the fire department. If it (getting rid of fire department) is talked about again or eliminating the FD, that would make him leave the Town. Again thanks Council and the Malabar Fire Department.

PRESENTATION: Trails and Greenways Committee: Drew Thompson and Murray Hann, Chair and Vice-Chair of the Malabar Trails and Greenways Committee
Went through PP presentation with updates after award from County TPO for trail development.

CM Rivet asked what they want – how do you want them to present. Mur – TOM support the twin lakes option. Like the options to the south - empower Doug to work with them. CM Mahoney wanted to thank them. Recognized recently by the County for the award. The thought being if they can make the best – involve the public more. People are still contacting her on how to involve the public. Drew trying to promote Malabartrails.org will advertise future walks. Not trying to offend anyone. Mur said the TPO lays out a place and then the want to get local input. EELs are not regulatory. It is their duty to get local input.

ADA Restrooms – Sandhill Trailhead – supposedly passed health department testing but nothing in hand yet.

DD ranch – it is entirely possible that someone is stirring the pot over there. The surveyor was sent over there to do s generic description of the easement and he was not received. Later meeting with TA was also not positive. Property owner representative said they are now not interested in giving us anything. Should have gotten the easement years ago. Franklin explained that there were "hold harmless agreements" in the past for town drainage going through their property. TA will contact the principal property owner.

Otherwise they must pay the Town back for the training.
