#### MALABAR TOWN COUNCIL REGULAR MEETING MINUTES MAY 07, 2018 7:30 PM

This meeting of the Malabar Town Council was held at Town Hall at 2725 Malabar Road.

MOTION: CM Rivet / CM Ball to approve the 4/16/18 minutes as presented. Discussion: CM Mahoney questioned the two Votes for the minutes. Franklin directed to delete the "vote" immediately after the motion as the vote is called for after the discussion. CM Mahoney stated on page 3, Item I. 2. Resolution, she had read a list of questions but only Franklins comments are included and she said they should be deleted. No further comments. Vote: Ayes, 3; Nay, 1 (Mahoney).

ATTORNEY REPORT: spoke with John Connor on Painted Acre litigation. Trial date is on Feb 4, 2019 docket. Deadline is August of 2018 for exhibits and experts. Who is going to be the designated town expert to sit at trial is under consideration. Case is going to proceed under Bert Harris – no other claims. Estimating a three-day trial.

#### F. STAFF REPORTS:

Tom Miliore, PW Director made report. He will be working on scheduling but said it is subject to change. He reported the recent breakdown of the excavator; had it repaired and did not have it operating out of the yard and another breakdown occurred. It has been inoperable for five weeks out of eight weeks. This has impacted the drainage Project on Hall Road. Can't just put someone in ditch with shovel.

ADMINISTRATOR: Continuing efforts to clean up Marie Street property. A metal scrapper has proposed it will take 3 or 4 roll off containers to take the metal culvert debris and get it out of here and will pay town a small amount of money. Consensus of Council for TA to proceed.

Chair asked if Council had questions for TA. CM Mahoney read from a list of culvert problems and asked TA to focus on those repairs. CM Mahoney spoke about her conversation with the Florida Dept. of Economic Opportunity regarding zoning changes and possibility of millions of dollars to buy properties in flood plains but we are not applying for it.

Chair and Council called point of order. Chair recognized Franklin - FDEO is agency that has found Malabar not in compliance and that is the project staff has been working with the mayor to produce map of "land use map designation changes" no zoning changes. Also, as previously reported to Council part of the FDEO requirement is to include in the compliance update all legislative updates made since last update. Franklin had previously reported on the Peril of Flood statute that required additional information to update that Comp Plan Element.

TA said he has looked at some possibilities for outside funding and met with a person – we are not equipped to hire outside vendors. Determine the best use of town's dollars. Working with Town's Florida Registered Civil Engineer and are in accord and will be starting again. Are also shooting all the elevations so PW will have these resources. He asked CM Mahoney to send her nearly two pages of questions in advance of meeting. CM Mahoney said we can use shovels to clean culverts.

CM White asked about slope mower attachment demo that five persons had witnessed. He is ready to move to approve purchase. TA said he has heard from vendor to arrange for that. CM White said he would like to place on next agenda for purchase. TA will try and arrange demo before then to encourage public to witness as well. Put on next agenda.

**CLERK:** SpringFest on 4/21/18 was a great success. Beautiful day and good turnout. Lots of great cars to look at and bar-b-q to eat. Since we had done the FallFest we did not spend money on pony ride vendors or live band and kept total expenditures very low. Had positive input for two events a year but more support for one big one with live music and pony rides.

Clerk prepared two handouts for Council and placed in their mail slots. One handout addresses the homestead exemption information currently in place and the possibility of the additional exemption proposed as Amendment 1. The other handout includes the Budget to Actual for Oct – Mar, marked as "draft and for budget purposes" only and a working creation of a Citizen's Guide to the Budget that is a document we are building to assist citizens in understanding the budget process. The 5-year capital improvement plan is listed but is not included at this time. We are updating the projects that have been accomplished or initiated. These handouts will both provided again in the June 11 budget workshop package. Mayor asked about one big event vs. two smaller events. CM White asked about having the car show in the Fall and having one large event at that time. CM Ball said the Fall has less competition. More sense to put efforts into one event – Put on next agenda.

Franklin also reported the TPO will meet in Viera on May 10 and award Brian Vail and the T&G group for their contributions on the trail enhancements in Malabar (Correction: Award was for Brian Vail only). Malabar T&G member Murray Hann will also be recognized with a resolution for his attendance as Malabar citizen rep from 2014-2017 with a greater than 85% attendance (Correction: Lifetime Achievement Award).

## G. BOARD Reports:

Drew Thompson, T&G Committee Chair, gave overview of Trail Town application and would like to get signed and submitted ASAP. Eco tourism. He is looking at late June. Get the application in the que early. Accept and submit – unless there is a problem. Encourage citizen support. Put on next agenda if necessary. Requires no commitment by Council.

Liz Ritter, PZ Board Chair, stated they hope to have recommendation on medical marijuana ready for Council after this Weds meeting and thanked CM White for his input. The Board is also reviewing the 5-year plan. The sign ordinance is under review but she questioned staff for not enforcing the code on non-compliant business as was reported by a P&Z member. She asked if we are not going to enforce. TA said using the pending ordinance doctrine. Attorney said better to wait. Ritter said staff should go by what is on the books and take action on violation brought forward by Board member. TA said if Council directs action on a code under amendment, he will have to go after all code violations to avoid liability to the Town. CM Mahoney said old signs are grandfathered in. Point we are focusing on one instance. If they are illegal now they will probably still be illegal after code is amended. Some of the ones that are not going to have a problem enforcing an illegal sign. Putting up a sign without a permit. Attorney said Council has no problem with going forward with pending ordinance doctrine.

H. PUBLIC COMMENTS: Comments at this point may address items NOT on the Agenda. Comments related to subsequent Agenda Items may be made as those items come up. Public comments do not require a Council response. (Speaker Card is Required) Three (3) Minute Limit per Speaker.

Speaker Card: Tom Saleeba – at 450 Hall Road and had concerns with the ditch project. Has no criticism to PW or staff but questions the benefit of the ditch in front of his property that looks like a moat.

Before Attorney dismissed: CM White asked about letter to owners that put brought fill on to property without a permit and site plan. We only caught it afterwards when same occurred and now it has been repeated. CM White made the distinction between a complaint about a possible sign code violation which is aesthetic vs a violation of Malabar Code that adversely affects the community:

CM Ball: Fired up about getting us designated as a trail town. Be front and center and bring something to the town. This is a great opportunity. Mayor asked about potential for signage. CM Mahoney: Appreciates public opinion and neighborly community on next door and 3<sup>rd</sup> sat of month Malabar community event.

CM Rivet: Eva Lane has improved that was long overdue and is a connector. Residents certainly appreciate it.

CM Korn: Excused

CM White: Speeding on Atz – catch one or two cars. Supported buying a digital sign showing speed of vehicles. They do help. Cost about 3K. TA said the responsible people slow down and the others don't.

Put on next agenda.

TA stated that they just completed putting road material from Eva onto Quarterman and rolled and compacted it and someone has dug a hole in the road deliberately dug big tracks into the road.

Mayor: Mayor is impressed with drainage on Eva Lane and can tell by slopes. Would like to get a final cost on road and drainage portions. Mayor's breakfast this Thursday and it is more of a roast. Today went to the first TAC meeting. Need to be aggressive.
