5. ATTORNEY REPORT: Attorney spoke about mediation with Painted Acres. No agreement was reached. The FLC legal rep Atty Doug Noah is back in discussion with the other party and has asked for a closed door mtg to discuss settlement options and costs. Case is now focusing on money. Have a closed door mtg to discuss those settlement possibilities. Council, Atty, ITM and Mr. Noah and a court reporter are the only ones allowed to attend. He estimates a about one hour. He proposed Monday, 10/25/2021 at 7pm. Council consensus to set this date. We will confirm with Mr. Noah's office and order a court reporter. He then reminded Council of the process - convene as an open mtg, recess to closed mtg and then reconvene public meeting and adjourn. Mayor will not be here - The FLC is still on board here.

Mayor/Chair called on Gary Sampson: to speak on the rate increase on the trash. Even with lower rate offered by the other vendor it is a big increase. Asked why some cities add it to the tax bill and Malabar doesn't. What if we just say no to the increase. Mayor asked ITM Lisa to respond. She referenced the information that is posted on both the Town's website (depts/solid waste) and the Town's Facebook page. She showed on the overhead the page and went thru the timeline and attempt to piggyback and the subsequent formal bid and the results. She negotiated the original bridge contract cost down from WM by reducing the franchise percentage. It is still a huge increase considering up until June, WM continued to say to Malabar Council that they enjoyed the relationship with Malabar.

CM White and Scardino also explained the Town's action related to this situation. Town staff and Town Council did their due diligence.

Reso read by title only, Franklin explained the revised resolution at their seats includes the fee when a private provider is used on a Building project in Malabar. It was originally approved in 2020 by Council with Reso 06-2020 but was not included in the subsequent updates. It came to staff attention when the Twin Lakes SD submitted for construction permits using a private provider for plan review and inspections. As ITM Lisa has previously stated this Fee Reso will continue to be updated until it contains all the fees and charges the Town requires for all administrative procedures. Then there is only one document to keep current. It should be looked at annually.

ITM explained that in June Council approved the contract with EDC for provide the engineering estimate for the total cost to pave Rivet Lane. That estimate is the first step. Council approved \$12,500.00 for Rivet Lane. Bundling may save some on these preliminary engineering costs. This is the first step after contact by residents about the interest in paving. This will provide a realistic estimate to put in the next communication with residents. ITM said we can amend the existing task order with EDC to add these roadways. This is the request to Council to add these to the task order for your consideration.

10.d. Malabar Market Discussion

Agenda Report No. 10.d Exhibit:

Mayor said this was a continuation of discussion at last meeting. Council needs to provide direction to Staff to either take on the event or not. CM Acquaviva totally supports the Malabar Community Market, but she has thought of it as being in its infancy stage at this time. It is about how the Town deals with the collection of money as well as payment of related expenses. It must be kept separate.

Mayor said they have received donated money for this event and expenses. Let the money go to the committee as a donation to them. CM Acquaviva said with limited staff, it would be a lot on the Town. What do other CM think? CM Rivet doesn't like more work for staff or create more work. Council agrees to donating the use of the park at no fee. Atty Bohne said it doesn't seem appropriate for staff to collect the money and then expend the money if it is not for a public purpose. All other non-profits that want support from Council would have a claim for similar support. CM Acquaviva said the bigger it gets the more work it will take. Keep it simple like it is. We can help advertising for volunteers. Annalie said maybe the Town could help with the cost of insurance. ITM Lisa explained that the Council must either take on the event and put it in budget and add fees to Fee Reso and provide for accounting of the event but they would also have to either provide same support to all other requests or not. It is not serving a municipal public purpose.

Mayor asked if there was Council consensus that the donations, and expenses be handled by the private, not for profit volunteers. Council will still support the event and waive fees for use of park on 4th Sat of each month. But can't waive the insurance and other requirements.

ORDINANCE 2021-22

AN ORDINANCE OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA; AMENDING ARTICLE V IN THE LAND DEVELOPMENT CODE TO ADD A NEW SUBSECTION "D" PROVIDING REGULATIONS FOR TEMPORARY STORAGE UNITS IN THE TOWN OF MALABAR; PROVIDING FOR SEVERABILITY, CONFLICTS, CODIFICATION AND AN EFFECTIVE DATE.

WHEREAS, the Town Council desires to update the Code of Ordinances providing regulations for allowing temporary storage units in the Town of Malabar.

NOW THEREFORE BE IT ORDAINED by the Town Council for the Town of Malabar, Brevard County, Florida:

SECTION 1. Article V, General Provisions, in the Land Development Code Section 1-5.6. Accessory Buildings is amended to add subsection "D" to read as follows:

"Sec. 1-5.6.D. Standards for Temporary Storage Units.

- 1. Temporary Storage Unit is defined and typically utilized for the temporary storage of personal belongings only, as part of the process of household moving and/or part of a household intent to store items offsite at a commercial storage location. This definition does not include storage units authorized by the Florida Building Code pursuant to Fla. Stat. § 553.73.
- 2. Temporary storage units are permitted as follows:
- (a) Permitted in Residential Areas: Any land zones RR-65, RS-10, RS-15, RS-21, RM-4, RM6, R-MH, R/LC, and PUD designated for single family and multiple family uses
- (b) Size: Temporary storage units, shall not exceed nine (9) feet in height, ten (10) feet in width, and 24 feet in length.
- (c) Location: temporary storage units are allowed in any required setback and shall not be placed in any public or private right-of-way or easement and shall not be in such a manner to create any visual obstruction for any motor vehicle operator's view of other motor vehicles, bicycles, or pedestrians upon entering or exiting rights-of-way.
- (d) Time frame: Temporary storage units are allowed in residential districts for a period not exceeding 14 days in a calendar year and no more than two times a calendar year.
 - (e) The temporary storage unit shall not be utilized for the following:
 - Storage of live animals.
 - ii. Utilized for human habitation.
 - iii. Storage of hazardous or flammable materials.

iv. Advertising is prohibited on the temporary storage unit except for the name and phone number of the vendor of the unit.

- v. Storage of trash, junk ,debris, garbage, construction debris or material or refuse.
- 3. The Town Manager, or designee, may grant one (1) extension to the time limit established in subsection (1) above with written request by the property owner demonstrating good cause. For purposes herein, "good cause" shall mean an act of God, or some unforeseen circumstance or event which has caused a need to extend the use of the temporary storage container at the present location. No extension shall be longer than the time period which was previously approved by the Town.
- 4. Exemptions. The above regulations shall not apply to temporary storage units that are placed for construction purposes in connection with a valid building permit or during any period of declared weather emergency by federal, state, or local official action.

The provisions of this Ordinance shall not apply to any container which is placed on real property within the Town that is otherwise authorized by the Town's garbage and trash franchise agreement.

- 5. Violations and provisions for schedule of fines will follow the Town of Malabar Code of Ordinances, Land Development Code, Article XII entitled Administrative Procedures for land development and code enforcement.
- <u>SECTION 2.</u> Severability. If any provisions of this ordinance or the application thereof to any person or circumstances is held invalid or unconstitutional, such invalid or unconstitutional portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the other portions of this ordinance, provided the remaining portions effectuate the purpose and intent of this ordinance.
- <u>SECTION 4.</u> Conflicting Provisions. In the case of a direct conflict between any provisions of this ordinance and a portion or provision of any other appropriate federal, state, or town law, rule, code, or regulations, the more restrictive shall apply.
- **SECTION 5. Inclusion in Code.** It is intention of the Town Council that the provisions of this ordinance shall become and be made a part of the Code of Ordinances of the Town of Malabar.
- <u>SECTION 6.</u> Effective Date. This Ordinance shall take effect immediately upon passage and adoption.

SUBJECT: 1st Reading Ord 2021-23 to Amend Chapter 6 of Code to Provide for Private

Provider is Hired by Permitee

BACKGROUND/HISTORY:

Section 553.791 of the Florida Statutes requires local jurisdictions to authorize building permit applicants to utilize private providers for plan review and inspection services in lieu of Town staff professionals. Private providers must be fully licensed to perform the required reviews and inspections and are paid directly by the permittee. They must also provide evidence of professional liability coverage with a minimum policy limit of \$1 million per occurrence.

The private provider must provide the Building Department Manager documents and reports stating plans as reviewed and work as performed complies with the Florida Building Code. The Building Official would then review and authorize the use of private providers.

The statute also states that such permittees pay a reduced fee related to plan review and inspections based on the cost savings to the Building Department:

Subsection (2)(b) It is the intent of the Legislature that owners and contractors pay reduced fees related to building permitting requirements when hiring a private provider for plans review and building inspections. A local jurisdiction must calculate the cost savings to the local enforcement agency, based on a fee owner or contractor hiring a private provider to perform plans reviews and building inspections in lieu of the local building official, and reduce the permit fees accordingly. The local jurisdiction may not charge fees for building inspections if the fee owner or contractor hires a private provider; however, the local jurisdiction may charge a reasonable administrative fee.

We have done that review and believe Malabar savings would be like the City of Melbourne, the Town of Grant-Valkaria and the Brevard County Building Departments. They all offer a fee reduction of 25% on the Plan review cost and Inspection fees done by private providers. The City of Palm Bay reduces the plan review and inspection fees by 15%.

AN ORDINANCE OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, RELATING TO BUILDING CODES; AMENDING CHAPTER 6, CREATING A NEW SECTION 6-10 OF THE CODE OF ORDINANCES OF THE TOWN; PROVIDING FOR PRIVATE PLAN AND BUILDING CODE INSPECTIONS; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Florida Statute Section 553.791 provides, in part that: Notwithstanding any other law or local government ordinance or local policy, the fee owner of a building or structure, or the fee owner's contractor upon written authorization from the fee owner, may choose to use a private provider to provide building code inspection services with regard to such building or structure and may make payment directly to the private provider for the provision of such services... The fee owner may elect to use a private provider to provide plans review or required building inspections, or both; and,

WHEREAS, Florida Statute Section 553.791 provides, in part, that: If an owner or contractor retains a private provider for purposes of plans review or building inspection services, the local jurisdiction must reduce the permit fee by the amount of cost savings realized by the local enforcement agency for not having to perform such services; and,

WHEREAS, The Town staff has reviewed the total cost savings to the Town for not having to do such inspections and has compared the and reviewed similar cost savings to other local jurisdictions, including the city of Melbourne, Town of Grant-Valkaria, City of Palm Bay and Brevard County and has recommended a reduction of 25% on plan review costs and Inspection fees done by private providers; and,

WHEREAS, The Town Council adopts the findings of Town staff.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, THAT:

SECTION 1. Chapter 6 of the Malabar Code of Ordinances is hereby amended to add a new section 6-10 to read as follows:

"Section 6-10. Private plan and building code inspections

A property owner or the owner's contractor may elect to use a private provider to provide plans review or required building inspections, or both. However, if the owner or the owner's contractor uses a private provider to provide plans review, the Town's building official, in his or her discretion, may require the owner or the owner's contractor to use a private provider to also provide required building inspections.

If the owner or contractor retains a private provider for purposes of plans review or building inspection services, the Town must reduce the permit fee by 25%. The Town may not charge fees for plan or building inspections if the owner or contractor hires a private provider to perform such services; however, the Town may charge a reasonable administrative fee to be provided by resolution of the Town Council from time to time.

The provisions of Florida Statute section 553.791 are hereby adopted herein by reference and it shall be the responsibility of the property owner or property owner's contactor to comply with the provisions of Florida Statute section 553.791as amended from time to time."

SECTION 2. Codification.

It is the intention of the Town Council of the Town of Malabar, Brevard County, that the provisions of Section 1 of this Ordinance become part of the Code of Ordinances of the Town of Malabar. The Town Clerk is hereby authorized and directed to cause the provisions of Section 1 of this ordinance to be incorporated into the Code of Ordinances.

SECTION 3. Severability.

In the event a court of competent jurisdiction shall hold or determine that any part of this ordinance is invalid or unconstitutional, the remainder of this ordinance shall not be affected and it shall be presumed that the Town Council of the Town of Malabar did not intend to enact such invalid or unconstitutional provision. It shall further be assumed that the Town Council would have enacted the remainder of this ordinance without said invalid or unconstitutional provision, thereby causing said remainder to remain in full force and effect.

SECTION 4. Conflicts.

All ordinances or parts thereof in conflict herewith are hereby repealed to the extent of such conflict with this Ordinance.

SECTION 5. Effective Date.

This Ordinance shall become effective immediately upon its adoption.

RESOLUTION 22-2021

A RESOLUTION OF THE TOWN OF MALABAR, BREVARD COUNTY. FLORIDA OPPOSING SENATE BILL 280 WHICH WOULD EVISERATE LOCAL CONTROL FOR FLORIDA CITIES WITH RESPECT TO ADOPTING AND ENFORCING ORDINANCES: CREATE A SUBSTANTIAL UNFUNDED MANDATE; AND REQUIRE COURTS TO CONSIDER SPECIFIC FACTORS DETERMINING IF AN ORDINANCE IS ARBITRARY UNREASONABLE: **PROVIDING** FOR DISTRIBUTION OF RESOLUTION TO THE BREVARD LEGISLATIVE DELEGATION, THE FLORIDA LEAGUE OF CITIES, THE PRESIDENT OF THE SENATE. SPEAKER OF THE HOUSE AND THE GOVERNOR; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Malabar, like 411 other municipalities, enjoy Home Rule authority under the 1968 Constitutional revision adopted by the voters of Florida: and

WHEREAS, this Home Rule authority was formally adopted by the Florida Legislature in 1973 as the Home Rule Powers Act of 1973; and

WHEREAS, the Florida Constitution states in Article VIII, Section 2(b) for municipalities:

"Municipalities shall have governmental, corporate and proprietary powers to enable them to conduct municipal government, perform municipal functions and render municipal services, and may exercise power for municipal purposes except as otherwise provided by law."

WHEREAS, the proposed Senate Bill (SB) 280 would prohibit local governments from adopting local ordinances without first conducting unfunded equity studies to determine the economic impact to local businesses as well as businesses in the surrounding areas, determine the number of businesses likely to be affected by the ordinance, and determine the extent the ordinance would impede local businesses from competition; and

WHEREAS, SB 280 will also require a business impact statement that must include the following:

- The public purpose served by the ordinance;
- A statement of reasonable connection between the public purpose and the expected effects of the ordinance;
- Estimated direct and indirect effects of the ordinance on businesses inside and outside the municipality;
- An estimate of the number of businesses likely to be affected by the ordinance;

These powers do not extend to fiscal Home Rule: the state reserves all taxing authority unto itself

Town of Malabar Board Member Code of Conduct

(Malabar Code Chap 2. – Code of Conduct) In addition to adhering to the requirements of State Law, any person appointed to serve as a Member of a Town Board or Committee shall commit to the following Code of Conduct by written affirmation, which shall remain on file with the Town Clerk, as follows:

I affirm that the proper Statutory and Town Charter role of Members of appointed Town Boards and Committees, as with any Member of an appointed government body, is to act collectively, not individually, to apply the Town's governing policies, and that the Town Administrator and Staff administer such policies.

I understand that an appointed Board or Committee Member does not manage the affairs of the Town. I will not intrude into daily operations or spheres of responsibility designated by Florida Statutes, Town Code, and Town Charter to the Town Administrator as the Chief Executive Officer; or undermine the Town Administrator's lawful authority. Further, I understand that the Town Administrator is responsible for administering the policy direction established by a majority vote of the Town Council and not the individual wishes of Board or Committee Members.

I will represent the interests of the entire Town when making decisions and will rely upon available facts and my independent judgment. In my capacity as an appointed Board or Committee Member, I will avoid conflicts of interest and avoid using my official position for personal, professional, or partisan gain.

I will demonstrate dignity, respect, and courtesy toward those whom I am in contact with in my capacity as an appointed Board or Committee Member. I will refrain from intimidation and ridicule of fellow Board or Committee Members, Town Council Members, Town Administrator, Town Attorney, Staff, citizens of the Town, and those conducting business with the Town.

In my capacity as an appointed Board or Committee Member, I will refrain from inappropriate language including statements that are malicious, threatening, slanderous, disparaging, mean-spirited, vulgar or abusive. All disagreements, concerns or criticisms shall be framed in language that is in keeping with the dignity and professionalism of an appointed official and the honor of my respective Town Board or Committee.

I will focus on solving problems. I will maintain appropriate decorum and professional demeanor in the conduct of Town business and work cooperatively and conscientiously with others as I request or receive information, examine data or weigh alternatives in the decision-making process.

I will demonstrate patience and refrain from demanding, interruptive access to Staff or immediate responses or services when requesting information that requires significant Staff time in research, preparation or analysis or that will result in Staff neglect of urgent duties. Such requests will be made through the Town Administrator for scheduling and prioritizing through consensus of my respective Town Board or Committee.

I will devote adequate time for preparation prior to my respective Town Board or Committee meetings and as much as possible, I will be in attendance at such meetings and all other scheduled events where my participation is required.

I will respect diversity and encourage the open expression of divergent ideas and opinions from fellow Board or Committee Members, Town Council Members, Town Administrator, Town Attorney, Staff, citizens of Malabar. I will listen actively and objectively to others' concerns or constructive criticisms.

I will refrain from any individual action that could compromise lawfully authorized decisions of the Town or the integrity of the Town and my fellow Board or Committee Members. I will delineate clearly for any audience whether I am acting or speaking as an individual citizen or in my capacity as a Town Board or Committee Member.

I will maintain the confidentiality of privileged information and will abide by all laws of the State applicable to my conduct as a Board or Committee Member, including but not limited to the Government in the Sunshine Law, the Florida Code of Ethics for Public Officers, and Town Rules of Procedure and Codes of Conduct.

SUBJECT: Amendment 1 to State Revolving Fund Loan Agreement SW051400

BACKGROUND/HISTORY:

This amendment provides for the repayment process and period for the \$190,000.00 the Town used for Master Stormwater Planning. The need for a Stormwater Master Plan is a preliminary requirement before any further grant can be applied for.

Singhofen and Associates requested an extension so they can finalize and submit their last items on the Contract. We subsequently requested an extension to begin the reimbursement. This request was approved and is entered into with the Amendment.

It provides for the first semiannual loan payment in the amount of \$5,170.00 shall be due on August 2022 instead of the previous December 2021. From then forward the payments will be in February and August of each year to complete the repayment of the 20-year loan.

STATE REVOLVING FUND AMENDMENT 1 TO LOAN AGREEMENT SW051400 TOWN OF MALABAR

This amendment is executed by the STATE OF FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (Department) and the TOWN OF MALABAR, FLORIDA, (Local Government) existing as a local governmental entity under the laws of the State of Florida. Collectively, the Department and the Local Government shall be referred to as "Parties" or individually as "Party".

The Department and the Local Government entered into a State Revolving Fund Loan Agreement, Number SW051400; and

Loan repayment activities need rescheduling to give the Local Government additional time to complete planning activities; and

Certain provisions of the Agreement need revision.

The Parties hereto agree as follows:

- 1. Unless repayment is further deferred by amendment of the Agreement, Semiannual Loan Payments as set forth in Section 10.05 shall be received by the Department beginning on August 15, 2022, and semiannually thereafter on February 15 and August 15 of each year until all amounts due under the Agreement have been fully paid.
- 2. The items scheduled under Section 10.07 of the Agreement are rescheduled as follows:
- (2) Completion of all Planning Activities for all Project facilities proposed for Ioan funding no later than February 15, 2022.
- (3) Establish the Loan Debt Service Account and begin Monthly Loan Deposits no later than February 15, 2022.
- (4) The first Semiannual Loan Payment in the amount of \$5,170 shall be due August 15, 2022.
 - 3. All other terms and provisions of the Loan Agreement shall remain in effect.
