SUBJECT: Approve Recommendation from Selection / Negotiation Committee (SNC) regarding Stormwater Asset Management Master Planning

BACKGROUND/HISTORY:

As a part of the process required to select an engineering firm to conduct a stormwater asset inventory and master plan, a request for qualifications (RFQ) was announced and seven firms responded.

The selection and negotiation committee (SNC) conducted two meetings. The first meeting short listed five firms for additional presentation and follow up interview questions at the second meeting.

The shortlisted firms were then scored and ranked:

Firm Name	Total Points
Singhofen & Associates Inc. (SAI)	450
Engineering, Design & Construction Inc. (EDC)	432
Kimley-Horn	431.5
Inwood Consulting Engineers, Inc.	421.5
B.S.E. Consultants	415.5

The SNC has made the recommendation to select Singhofen & Associates (SAI) to conduct the Stormwater Asset Inventory and Master Plan. Additionally, the SNC recommends continuing service contracts with SAI, EDC and Kimley-Horn to provide project design and construction consulting services for the capital improvement projects produced by the master plan.

Section 2. Table 1-3.2 Land Use by Districts in Article III of the Land Development Code is hereby amended to provide for addition to footnote " * " That provides for the following language:

"* = These uses are permitted only on sites abutting Babcock Street, US 1, West Railroad Avenue, <u>Garden Street and Pine Street</u>.

Section 3. Codification.

It is the intention of the Town Council of the Town of Malabar, Brevard County, Florida, that Article III, District Provisions, Table 1-3.2 be codified into the next supplement update of the Land Development Code of the Town of Malabar. Florida.

Section 4. Severability.

SUBJECT: Action on Road Improvement Waiver Request - Rivet Lane

BACKGROUND/HISTORY:

Ord 2020-01 was adopted to provide a waiver process for applicants to follow when dealing with the requirements for road improvements. It gives Council authority to grant "waivers" to the strict requirements.

In this case, only the property owners on the east side of Rivet Lane ever dedicated right-of-way for road purposes. There are currently three homes, all on the east side of the lane. The applicant proposes to improve the road in a similar fashion to what is in existence far enough north to gain access to their lot and develop their home.

The travelway currently is 11 feet. The Code requires 18 feet. They are requesting a waiver of 3 feet so they can build a 15-foot wide roadway.

They will improve approximately 425 feet of the road from its current terminus north far enough in front of their lot 4 (parcel 268) to construct their driveway. The road right-of-way ceases at the north end of their parcel. It would serve no public purpose to require the applicant to develop a road that dead ends at the end of their parcel.

They are requesting a waiver to the requirement of 'developing the road to the furthest point of the parcel to be developed' - a waiver to the improvement requirement for approximately 175 feet in front of lot 4.

The applicant will use the guidelines developed by the Town Engineer to improve the roadway within the existing right-of-way.



The 2020 Census is closer than you think! Here's a quick refresher of what it is and why it's essential that everyone is counted.

Everyone counts.

The census counts every person living in the United States once, only once, and in the right place.




It's in the Constitution.

The U.S. Constitution mandates that everyone in the country be counted every 10 years. The first census was in 1790.


lt's about fair representation.

Every 10 years, the results of the census are used to reapportion the House of Representatives, determining how many seats each state gets.



It's about \$675 billion.

Article 1



The distribution of more than \$675 billion in federal funds, grants, and support to states, counties, and communities are based on census data.

That money is spent on schools, hospitals, roads, public works, and other vital programs.



It's about redistricting.


After each decade's census, state officials redraw the boundaries of the congressional and state legislative districts in their states to account for population shifts.




Completing the census is mandatory: it's a way to participate in our democracy and say "I COUNT!"

Residents use the census to support community initiatives involving legislation, quality-of-life, and consumer advocacy.




Local governments use the census for public safety and emergency preparedness.

By law, your responses cannot be used against you and can only be used to produce statistics.





SUBJECT: Adopt Resolution 04-2020 Authorizing Loan Application

BACKGROUND/HISTORY:

Council is asked to authorize the application for funding by the Florida Department of Environmental Protection Agency Revolving Loan Program in order get State funding in the next cycle to pay for the Master Plan. Council had approved going forward for these funds in the current budget for the estimated cost of \$190,000.00.

The Notice to Affected Parties document I sent out separately identifies Malabar as an applicant. We intend to pledge the revenues from the Storm Water Utility to repay this loan if and when required. As explained in the original presentation, many times these revolving loans by DEP are "forgiven" before repayment is due.

In order to meet the deadline requirements, we must submit this resolution and a legal statement from the Town Attorney that we have the authority to increase the non-ad valorem rates per Florida Statute 197 as we did in 2017.

RESOLUTION 04-2020

A RESOLUTION OF TOWN OF MALABAR, FLORIDA, RELATING TO THE STATE REVOLVING FUND LOAN PROGRAM; MAKING FINDINGS; AUTHORIZING THE LOAN APPLICATION; AUTHORIZING THE LOAN AGREEMENT; ESTABLISHING PLEDGED REVENUES; DESIGNATING AUTHORIZED REPRESENTATIVES; PROVIDING ASSURANCES; PROVIDING FOR CONFLICTS, SEVERABILITY, AND EFFECTIVE DATE."

WHEREAS, Florida Statutes provide for loans to local government agencies to finance the construction of wastewater treatment facilities; and

WHEREAS, Florida Administrative Code rules require authorization to apply for loans, to establish pledged revenues, to designate an authorized representative; to provide assurances of compliance with loan program requirements; and to enter into a loan agreement; and

WHEREAS, the State Revolving Fund loan priority list designates Project No. CWSRF 05140 as eligible for available funding; and

WHEREAS; the Town of Malabar, Florida, intends to enter into a loan agreement with the Department of Environmental Protection under the State Revolving Fund for project financing.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MALAAR, FLORIDA, AS FOLLOWS:

SECTION I. The foregoing findings are incorporated herein by reference and made a part hereof.

SECTION II. The Town of Malabar, Florida, is authorized to apply for a loan to finance the Project.

SECTION III. The revenues pledged for the repayment of the loan are the Malabar Stormwater Utility revenues. There are no senior liens.

SECTION IV. The Town Manager is hereby designated as the authorized representative to provide the assurances and commitments required by the loan application.

SECTION V. The *Mayor* is hereby designated as the authorized representative to execute the loan agreement which will become a binding obligation in accordance with its terms when signed by both parties. The *Mayor* is authorized to represent the Town in carrying out the Town's responsibilities under the loan agreement. The *Mayor* is authorized to delegate responsibility to appropriate Town staff to carry out technical, financial, and administrative activities associated with the loan agreement.

SECTION VI. The legal authority for borrowing monies to construct this Project is 166.111, Florida Statutes.

SECTION VII. All resolutions or part of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

SECTION VIII. If any section or portion of a section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other section or part of this Resolution.

SECTION IX. This Resolution shall become effective immediately upon its passage and adoption.
