SUBJECT: 2<sup>nd</sup> Reading Public Hearing on Ord 2019-13 - Rezoning Huggins, Park 2540

Johnston Avenue, Prior to Sale

#### **BACKGROUND/HISTORY:**

Council held a Public Hearing on this request per the requirements in Article XII of the Malabar Land Development Code on November 4, 2019. That section requires a Public Hearing to be held also at the Planning and Zoning Board meeting. That was done at their meeting of 10/23/19.

Florida Statutes separately requires a legal advertisement and public hearing on the second reading of all ordinances. That is what is before Council on December 2, 2019.

The Town owns and maintains 150 acres of park and conservation land for its citizens. In addition to this there is over 1,100 acres of preserved lands maintained by the Brevard County Environmentally Endangered Lands Program for passive public enjoyment within Malabar.

Throughout public meetings in 2017 and 2018 Council discussed closing Huggins Park due to the dilapidated, unsafe play equipment and lack of use. The TA at the time spent almost a full year working with Brevard County legal department to get a clear title to the land.

The direction of Council was to get a clear title to the land, get it rezoned to match the surrounding property and get it back on the tax roll. Once the ordinance is adopted, staff will pursue information on the best method to offer for sale: either by sealed bids with a minimum or listing it with an agent. That information will be brought back before Council for final direction.

#### FINANCIAL IMPACT:

Revenue from sale, annual ad valorem and reduced expenditures for maintenance.

AN ORDINANCE OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA; ADMINISTRATIVELY AMENDING THE ZONING MAP FOR THE 3.4 ACRE SITE IN SECTION 31, TOWNSHIP 28 AND RANGE 38 LOCATED IN THE JOHN J POLLAKS SUBDIVISION, MALABAR FLORIDA FROM INSTITUTIONAL (INS) TO RESIDENTIAL (RS-10); PROVIDING FOR PROPER CLASSIFICATION IN ORDER TO SELL; PROVIDING FOR AMENDMENT TO THE OFFICIAL TOWN ZONING MAP; PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, as follows:

<u>Section 1.</u> The Town Council has determined that the 3.4 acre parcel located at 2540 Johnston Avenue is no longer used as a recreational park and should have the designation changed to residential to be compatible with surrounding areas in order to market it as surplus land. The parcels together are identified as 2540 Johnston Avenue, Parcel ID 28-38-31-26-5-1.

<u>Section 2.</u> The Town Clerk is hereby authorized and directed to cause the revisions to the Official Town Zoning Map as referenced in Article II of the Land Development Code to show the zoning change set forth above.

<u>Section 3.</u> The effective date of this ordinance shall be six (6) days following adoption by Council.

- request by the town council, I will return to the town any privileged or confidential documents or materials or town property provided to me by the town while serving on the town council.
- I will abide by all laws of the state applicable to my conduct as a member of the town council, including, but not limited to, the government in the Sunshine Law, the Florida Public Records Law, the Florida Code of Ethics for Public Officers, and town rules of procedure and codes of conduct.
- m. I will promote constructive relations in a positive climate with all town employees, town attorney, and town contractors and consultants consistent with my role as a member of the town council, as a means to enhance the productivity and morale of the town. I will support the town administrator's decision to employ the most qualified persons for staff positions. I will recognize the bona fide achievements of the other members of the town council, town administrator, town attorney, staff, citizens of the town, members of the public, vendors of the town and those who do business with the town and other sharing in, and striving to achieve, the town's mission.
- n. I will enhance my knowledge and ability to contribute value to the town as a councilmember by keeping abreast of issues and trends that could affect the town through reading, continuing education and training. I will study policies and issues affecting the town, and will attend training programs if required by the town. My continuing goal will be to improve my performance as a councilmember.
- o. I will value and assist my fellow councilmembers by exchanging ideas, concerns, and knowledge through lawful means of communication. I will help build positive community support for the town's mission and the policies established by the town council.
- p. I will support and advocate for my beliefs, but will remain open to understanding the views of others. I recognize that I share in the responsibility for all town decisions and will accept the will of duly authorized decisions of the town council and town electorate.
- q. I understand that my first priority as a councilmember will always be to look out for the best interests of the citizens of the town and the public health, safety and welfare. I will seek to provide appropriate leadership that nurtures and motivates town citizens to be stakeholders in the affairs and achievements of the town.
- r. I will be accountable to the town council for violations of this code of conduct.
- (3) Penalties for violation of code of conduct.
  - a. Before any councilmember shall be found to be in violation of this code of conduct the councilmember shall be given a public hearing concerning any charge of a violation of this code of conduct. The date and time of a public

hearing concerning a member charged with a violation of this code of conduct shall be published in a newspaper of general circulation in the town at least one week in advance of the hearing, or as otherwise provided by state or local law.

b. All such charges shall be in writing and filed with the office of the town clerk. The written complaint must be based substantially upon the personal knowledge of the complainant and signed under oath or affirmation by the person filing the complaint. The town clerk shall cause the notice in subparagraph (a) to be drafted and published. To the extent possible such hearing shall occur at the next regularly scheduled meeting of the town council. In the event that there is insufficient time to cause the publication in subsection (a) above to occur or if the next available meeting of the town council has been previously cancelled then the hearing shall be scheduled for the next available regular meeting of the town council.

In the event that any councilmember shall be found in violation of this code of conduct the following penalties shall be imposed:

- For a first violation: a notation in the councilmembers file that a first violation of the code of conduct has been found to have been committed by a majority vote of the town council entitled to vote on such matter;
- For a second violation: Censure;
- For a third violation: At the discretion of the town council, sanctions may
  include additional censure, or removal or exclusion from leadership
  positions, other official positions or duties.
- For any subsequent violations: If there is a determination of such a subsequent violation and upon the vote by a majority vote of the town council entitled to vote on such matter the institution of subsequent forfeiture of office proceedings pursuant to F.S. § 112.501(2).
