MALABAR TRAILS AND GREENWAYS COMMITTEE REGULAR MEETING MINUTES February 13th, 2023, 6:00 PM

This meeting of the Malabar Trails and Greenways Committee was held at Town Hall at 2725 Malabar Road.

1. CALL TO ORDER, PRAYER AND PLEDGE:

Meeting called to order at 6:02 P.M. Prayer and Pledge led by Chair Thompson.

- 8. DISCUSSION

a. Trail, Kiosk and Firebreak Conditions

VC Hann states the trails are open and running well. He did a small trail trimming in the Cameron Preserve and replaced a missing sign. He also marked the Yellow Trail signs as East or West. He also removed some of the ribbons down that were used to mark the Impala Trail. He also checked the Cameron Trail Shelter for any debris and found it clean.

b. Cameron Preserve Update

Chair states we still have signs to be installed. VC Hann suggests it can be done in one full workday by accessing the area from the Boundary Canal Trail. He is also looking into getting reflectors for the back of the signs. He is also considering getting some sign edging to protect the signs close to the trail.

c. Eagles Nest Trailhead Update

Secretary Kohler informs the Committee that several loads have been brought into the ENT. Over this past weekend, CM Vail spread them, and placed stakes where more dirt is needed. CM Wilbur states the area looks great and is ready for the fence line. CM Wilbur also suggested plugging the broach in the Southern wall.

d. SCTPO South Brevard Master Trail Plan Meeting

Chair Thompson began by reviewing a power point showing the 7 proposed projects for the South Brevard Master Plan. The SCTPO has informed us that the project

area encompasses Brevard County south of Palm Bay Road. We have collaboration from Palm Bay and Grant/Valkaria. We are hosting the meeting here at Town Hall on March 2nd. Liaison Smith informed the Committee that the Grant/Valkaria T&GC has proposed a trail as well. VC Hann suggests getting high resolution maps of the area. Chair Thompson shared a spreadsheet with suggestions to be filled by the Committee on topics like resources, coordinators, trail types etc. VC Hann suggests working towards finalizing the path of the Al Tuttle Trail. Liaison Smith agrees, citing that the Grant/Valkaria residents are opposed to paving Leghorn Rd. VC Hann suggests we focus on the top projects, and request the County to assist us. Chair states eventually we should be trying to connect to Indian River County. We should focus on our main visions of connectivity. VC Hann suggests selecting our priority project. He is concerned the scope is now too wide. He suggests the top priority be connecting Malabar to Grant/Valkaria, with the Master Plan being a secondary goal. If we can connect south with a paved trail, it is possible for federal funding. We should have a PDE for a paved connection to Grant/Valkaria. Our target for an exit should be the park property on the northern curve of Valkaria Road. Liaison Smith asks if the Al Tuttle Trail must be ADA accessible and paved? CM Wilbur states it should be but may not be required. VC Hann states his goal would be to show the SCTPO the options south from the JSS and try to get a final outcome. VC Hann states he will research his past TIGER Grant submission on trails on canals in Palm Bay. Chair states with these goals, the three south Brevard communities will be well represented and connected. VC Hann suggests hosting a secondary meeting with Palm Bay staff. CM Wilbur states with the southern expansion of Palm Bay this should be a major priority for them. VC Hann reiterates that Malabar's priority is connecting to GV, and secondly creating a combined vision with all three towns, and third is to get Palm Bay's ideas for the future.

e. Next Field Event - TBD

Secretary Kohler informs the committee that TM Stinnett has given the Committee permission to cut a small entry into Eschenberg Park and to do an exploratory survey of the area. Chair Thompson suggests finishing the posts in Cameron Preserve. He suggests March 10th at 9 AM.

- **a. Board Member Comments:** VC Hann states he would like to see an informed member attend the Court Case on Wednesday February 15th, 2023.
- b. <u>Staff Reports:</u> Secretary Kohler informs the Committee that their next scheduled meeting of March 13th conflicts with the Space Coast League of Cities dinner being hosted by Malabar. He suggests having the meeting on March 27th instead.
