MALABAR TRAILS AND GREENWAYS COMMITTEE REGULAR MEETING MINUTES July 10th, 2023, 6:00 PM

This meeting of the Malabar Trails and Greenways Committee was held at Town Hall at 2725 Malabar Road.

1. CALL TO ORDER, PRAYER AND PLEDGE:

Meeting called to order at 6:02 P.M. Prayer and Pledge led by Chair Thompson.

4.a. Regular Trails and Greenways Committee Mtg Minutes of 6/12/2023. Motion to approve the consent agenda as amended by Cameron/Hann. Chair noted a minor correction in Section 7.B. <u>All Ayes: Carried 5-0.</u>

- 7. DISCUSSION

a. Trail, Kiosk and Firebreak Conditions

VC Hann states the trails are open and running well. Chair states at the BPTAC there was a survey of what the Committee should be. The conclusion was that the BPTAC members were unhappy, and to combine the board with another subcommittee. VC Hann states he shared his frustration that the committee was no longer working towards trail development. Chair states there will be another meeting to discuss it before it finalizes, but he believes it is a deletion of the BPTAC. He wanted to make the Town and Committee aware of this.

b. MSS Restoration Plan Observations and Concerns

Chair states he added this item because there is no record of what the EELs program is doing outside of these agendas and minutes. He asks if there are any notation of the work? VC Hann states they are working in the south east corner of the property, and he has respected their trail closed signs. He did note that there appear to be far fewer trees marked for preservation than he felt were agreed to. He notates the area right near the entrance to the Sanctuary appears to be losing many trees. Chair thanks him for the observation.

c. Eagles Nest Trailhead

Chair states the Committee has been discussing installing a fire well at the ENT. The goal would be to have a filling station for FD tankers. He believes it will likely be a

wide bore well. Chief states there are well grants available through forestry. These wells are excellent for fire prevention. The FD would have to check in once or twice a vear, but any wells in South Malabar would be useful. Chair asks is an on-site storage tank would be required, and what this group can do to assist in the grant process. Ideally, fire trucks could use the circular nature of the trailhead to refill their tanks. VC Hann suggests using a spring-loaded feed to produce the water. He anecdotally notes that during the Mother's Day fires, there were over 100 fire trucks seeking to fill along the concrete road. Chief states that the FD has a portable drop tank, and a good water control officer can maintain a steady flow of water. Chair states the placement of the well will depend on the applicability of the design. CM Wilbur states a 6-inch artesian well will flow over 500 gallons per minute. Chief states that would be an excellent assist for any fire fighting requirements. CM Wilbur suggests the well be placed near the fence line. Chair states his belief is that it would best support the needs in the center of the circle. VC Hann suggests the Committee allow the Chief to inspect the property and make a recommendation for where it should be placed. VC Hann suggests CM Wilbur meet the Chief on site for further discussion. Chair states the overall goal is to provide an effective fire well, as well as providing water for horses, plants, and possibly a bathroom. CM Wilbur suggests requesting quotes from area well drillers for the work. Chair asks if the Chief can provide a recommendation at a future meeting as to his preferences for the well. VC Hann states that there are different grades of piping that can be used to prevent corrosion. Chief states that he agrees, and the FD would look at all these options. Chair states if necessary, we could install a security box with any electrical pieces required. CM Wilbur reiterates that a 6-inch artesian well would provide water quicker than pulling from a lake. Chair states that this group has also discussed a dry hydrant connected to the lakes in the Jordan Scrub. Chief states that long stretches of pipes could case issues, and pulling from a close source is much preferred. He also states that the area would also potentially be used by other local departments such as Palm Bay or Brevard County. CM Wilbur states that it could even be possible to route trucks down Atz Road to the Marie Street ROW and into the trailhead to create a complete loop. Secretary Kohler states that Council Member Vail was able to spread the remaining dirt at the ENT. He states he will shoot some additional elevations and provide the information back to staff. More fill dirt has been ordered and will be delivered as PW can. Chair states that there is a drainage plan in place. There is thoughts of a drainage ditch along the northern edge, as well as drainage from the center of the islands. Chair also reminds Staff to get the final piece of culvert pipe. Secretary Kohler notes that the Committee only has an open permit for a driveway and a fence. Any drainage work should be permitted and engineered. CM Wilbur states the Council Member Vail will be shooting additional elevations and can provide elevations along the surrounding property. Chair suggests creating a small berm along the eastern edge of the property. Chair suggests a 2-inch pipe to drain the islands. VC Hann and CM Wilbur suggests 4 to 6 inches. Chair states he hopes to avoid drowning the plants in the islands. CM Wilbur states he believes he can solve that issue on site with a small ditch. VC Hann states his concern with asking the engineer to work without speaking with us. Secretary Kohler states he can request the engineer attend the next meeting or meet a member on hand.

MOTION: CM Cameron/CM Hann to request an engineered review, design, and permit for drainage of the Eagles Nest Trailhead, with an in-person meeting prior to submittal.

VOTE: All Ayes (5-0)

d. Cameron Preserve

Chair states that the committee is interested in refreshing the firebreaks in Cameron Preserve via the Florida Forestry Department. Can chief get them involved? Chief states he has been in contact with them and will let the group know when he receives more information. CM Cameron asks if a controlled burn in Cameron Preserve would require FD assistance? Chair states that the Committee has been looking at updating

the control plan, as well as doing a few smaller burns in the area. VC Hann states the short-term goal is to have the fire breaks cut by Forestry. In the past, Forestry cut 90foot-wide firebreaks. We would like to have them recut, but in a more realistic size. The Committee has recently cleared the Cogan Grass along the firebreaks, and they are ready to be maintained. Hopefully we could walk with a Forestry agent to discuss the necessary firebreaks, mainly the east/west along Country Cove, and one north/south in the center of the Preserve. Chief states he will contact the forestry department and bring back any information he receives. Chair states that the Committee is looking to showcase the Cameron Preserve as a diverse spectrum of environments. VC Hann states we would like to use forestry to assist us but have had bad experiences in the past. He hopes future endeavors will be better. Chief states he knows the department head for the area, and he believes he can assist the group in creating safe effective system. VC Hann states eventually we hope to include the Forestry Department in the Cameron Preserve Management Plan. Chair states his belief that Malabar is blessed with many trees, and he is looking forward to working to protect them. Chair then thanked Chief for attending.

e. Purchase Request Review

Chair states quotes have been procured for the signs discussed at the last meeting. VC Hann suggests if we wish to reduce the number of signs for the boundary signs. He suggests getting 25. For the Kiosk signs, he states we should get 8. Chair suggests using the high intensity materials for added longevity. VC suggests getting the 6"x12" signs for the boundary signs, and the 24"x24" size sign for the on-trail maps. He suggests we need 8. He intends to produce "You are Here" for those maps. He would like to include one of the kiosk signs at the Briar Creek Blvd entrance to the Cameron Preserve.

MOTION: VC Hann/CM Cameron move to request an expenditure of \$1,521.52 from the Brevard County Sign Shop for kiosk maps, on trail maps, and Cameron Preserve Boundary Signs.

VOTE: All Ayes (5-0)

Chair then began discussion the idea of a public bike repair stand for the Cameron Preserve. VC Hann states if we purchase one, we should cement it in place. Chair suggests getting a separate pump and station, so if one breaks the other is still serviceable. VC Hann states that Liaison Smith built one of these devises for Grant Valkaria. He states he would also like to check with Bob's Bikes, Revolutions, and Infinity Bikes to see if they would be interested in donating one. He states that if that is unsuccessful, we could build our own. Chair states that one of his family members recently replaced their storm shutters and is willing to donate the old one for use as a trail shelter. There is enough to create a 12'x14' roof. He can bring the smallest one to the next meeting. If we bought a lot of caulks, we could create a low-cost pavilion. CM Wilbur states he found some pavilions at Pelican Beach Park that he thinks would look perfect in Cameron Preserve.

f. Next Field Event – TBD

Chair asks if the Committee has any ideas for an upcoming trail day? Secretary suggests the ENT Fence instillation. Chair states that the new trail in Eschenburg Park was excellently cut by CM Wilbur. CM Cameron states she suggests everyone walk out there to see what it looks like. It looks like the Sandhill Trailhead did before it was developed. Chair gave a brief presentation with information on a proposed trail for the Preserve. He states that removing all the invasive trees will be a major project. He hopes to eventually include a Trail Shelter along a one-way trail near the confluence of the water passages. Chair proposes his presentation serve as the first draft for a trailhead at Eschenburg Park. VC Han suggests utilizing a one-way trail on the narrow portion of the property and to extend the potential trail to the northwest corner. VC Hann states his concern for removing all of the invasives and having a trail through an empty field. He would like to have the trail installed, then pursue a grant

to remove the invasives and develop the trees we want. CM Wilbur states he believes the interior should be cleared first. VC Hann states that grinding a pepper tree can create a bigger issue. Chair states he believes we should cut and treat the peppers. CM Wilbur states we could also ask the FD to do a controlled burn. Fire sterilizes the pepper trees and keeps them from growing again.

MOTION: CM Britt/CM Cameron to accept this proposal as the first draft for a trail and trailhead for Eschenburg Park.

Vote: All Ayes (5-0)

VC Hann suggests the fence build be a two-day event. On day one, a small group cuts the wood and lines them up. On day two, someone with an auger comes to dig fence post holes and install the fence posts and cross beams. He states he will not be back until August 1st. Chair suggests August 12th. VC Hann suggests September 9th. Chair suggests Friday September 8th as day one, and Saturday September 9th as day 2.

BACKGROUND/HISTORY:

- a. The Trails and Greenway's Committee has been actively working towards improving the Eagles Nest Trailhead.
- b. The Committee has indicated it wishes to install the fence line next.
- c. The Malabar Public Works Department has been tasked with bringing in additional fill dirt. A PO for 150 additional tons has been opened.
- d. The Malabar PW Department has successfully brought in several loads of fill dirt. TM Stinnett is coordinating with CM Vail to grade the dirt on site as more is brought in.
- e. The Committee has expressed interest in installing a temporary culvert at the northern exit. TM Stinnett has indicated he will coordinate with a contractor to complete this task.
- f. CM Vail has stated he wishes to develop a drainage swale on the Northern edge of the property, running from east to west, along the whole boundary of the property. He plans to leave a 10-foot vegetative buffer, add a 10-foot-wide swale area to include drainage and a maintenance path.
- g. Staff has requested an engineer reviewed drainage plan and filing a permit for the drainage work.
- h. Interim Chief Giantonio of Malabar FD attended the last meeting to discuss the possibility and applicability of a Fire Well at the Trailhead.
 - a. Interim Chief Giantonio provided staff with the response he received about the Fire Well Grant. Email response is attached.





Thank you for visiting MALABAR Trails!

- This trail system utilizes one-way and two-way trails. Most of the complex, narrow trails are "one way", and it is best to travel that way for safety. Bikes: Please adhere to one way designation
 - "One Way" is the Preferred Direction of Travel. If You Choose to Travel Opposite the Preferred Direction, be vigilant and yield the ROW to the preferred direction.
- USE THIS TRAIL SYSTEM AT YOUR OWN RISK. The property owner is indemnified from liability by Florida Statute 316.0085. YOU are personally responsible for your own safety.
- Trails in this system are considered Medium (blue) difficulty. Expect sandy areas, roots, and moderate drops. Trails may have trees down, or be blocked by debris at any time. Trail conditions can change at any time, so it is up to the trail user to keep themselves safe.
- The trail user is responsible for their own safety. Use trails at your own risk.
- DO NOT MODIFY TRAIL SURFACE PLEASE do not remove roots from trail surface
- NO motorized vehicles of any kind, except ADA exceptions
- HELMETS ARE REQUIRED TO RIDE HERE
- Dogs are allowed, on leash, in Malabar's Cameron preserve only (see Map)
- Horses allowed in Cameron Preserve and Malabar East, but not Malabar West (see Map)

Trail Name: Description / Features

Blue Trail (West): This loop is connected to Red Trail via two long, narrow bridges, which cross the Turkey Creek flood Blue Line – South West section plain. Blue is a challenging trail that has wet sections during the high rain season. Much of this area is in scrub habitat of map restoration, but shade has been left near the trail sections.

Yellow Trail East (Cameron): Yellow Trail East is One-Way, and runs predominately East, toward EELp Malabar East Yellow Line – In Cameron Sanctuary, and the trails that lead to Malabar's Sandhill Trailhead. Trail is marked with Yellow Diamonds, with arrows Preserve, Center of Map and "E" to indicate East. Cameron Trail Shelter is on the Green Trail, and visible from Yellow East

Yellow Line – In Cameron Yellow Trail West (Cameron): Yellow Trail West is One-Way, and runs predominately West, toward EELp Malabar West Sanctuary, and the Red & Purple trails near Turkey Creek. Yellow West includes some very twisty, shaded single-Preserve, Center of Map trac. Trail is marked with Yellow Diamonds, with arrows and "W" to indicate West.

Green Line – In Cameron **Green Trail (Cameron):** The Green Trail is Bi-Directional, and runs predominately North – South, connecting the N. Corey Road Trailhead to the AI Tuttle Trail (Paved). It is generally easy. Generally dry even in high rain season. The Preserve, Center of Map Cameron Trail Shelter (CTS) is on this trail, near the intersection with Yellow-East Blue Diamond Trail (Cameron): The Blue Trail is Bi-directional, and runs predominately East – West, and serves as a Blue Line – In Cameron local connector to other trails in Cameron Preserve. 




