MALABAR TRAILS AND GREENWAYS COMMITTEE REGULAR MEETING June 14th, 2021, 6:00 PM

This meeting of the Malabar Trails and Greenways Committee was held at Town Hall at 2725 Malabar Road.

1. CALL TO ORDER, PRAYER AND PLEDGE:

Meeting called to order at 6:00 P.M. Prayer and Pledge led by Chair Thompson.

4.a. Regular Trails and Greenways Committee Mtg Minutes of 05/13/2021 Committee Members Hann/Cameron move to accept the minutes of 05/13/2021 as corrected.

Chair Thompson suggests the name "Minutes" be added. Vice-Chair Hann corrected the spelling of "Ole" Johnson All Ayes: Motion Carried 4-0 (all ayes).

- 7. DISCUSSION

a. Trail, Kiosk, and Firebreak Conditions

Vice Chair Hann states there was a very serious fire at the MTB trails in Whickam Park. It burned 20-30 acres. Malabar Trails are looking firm, the recent rain has helped. Fire breaks are still grassy and need to be refreshed. EELs responded by patching some of their bridges. The new bridge system is very popular by both bikers and hikers. Chair Thompson suggests placing an umbrella bracket at the bench. Vice-Chair Hann agrees it would be a pleasant addition. CM Cameron asked about the bi-directional trail status on the TCT GFT connector trail. Vice Hair Hann states that issue is being discussed. Palm Bay is tentatively agreed to do a "Grand Opening" of the trail. Final date and time TBD. Chair Thompson recommends having a supply of the VTP cards at that event. Chair Thompson asks how severe are the fire breaks? Do they require work now? Chair Thompson suggests contacting ECOR to have it treated now, so they are well maintained. CM Wilbur agrees to use ECOR to give us an idea of how serious the project will be. Vice Chair Hann states the Cogan Grass is the worst where the Field to Fork Farm corners. Chair Thompson believes we should address this issue now before it becomes a more expensive project. CM Wilbur states Lt. Hooker at the FD states they can get forestry to maintain it, we just have to remove it. Chair Thompson requests a motion to approve spending T&GC funds to repair the Fire Break.

VC Hann/CM Cameron move to identify the extent of the Cogan grass in Cameron Preserve, have CM Wilbur cut it, and approve ECOR to kill it with herbicide. All Ayes (4-0)

b. Eagles Nest

Chair Thompson began by reviewing the Trail Day of 5.19. CM Wilbur suggests a turn around be added at the South end of Marie Street. Chair Thompson states a neighbor of the trail head spoke to him at length about the fear of increased ATV traffic in the area. CM Wilbur states that once the trail head is complete, we should add a gate to prohibit southbound traffic on Marie past the dump. CM Cameron asked if the Committee could put up the fence soon? Chair Thompson states he believes we should lay out and dig the holes, then have a big workday to complete the project. CM Wilbur states the Town sells its ditch dirt and we should utilize that. Chair Thompson states that would be an excellent idea. CM Wilbur will get with Corey Yuetzey and discuss the best path forward. CM Cameron stated the Park Board Member Kemmler requests no more than 4 paddocks in the ENT. Chair Thompson states we could use the old paddocks from Sandhill Trail Head for the ENT.

c. Malabar Road Crossing at Marie Street

Chair Thompson asks for any changes to this letter. None heard, it is requested this letter be added to the first Council meeting in July.

d. Trail Signage Request

Secretary Kohler read the complaint. Vice Chair Hann suggested getting a sign. He also states that the best defense is being courteous. Get a sign that states the Horses have the ROW. Chair Thompson states he will research to see if there are any signs we can copy.

e. Briar Creek Underpass Project

Vice Chair Hann provided an update on the anchors he found to support the base. It is usable at different angles and in many types of materials. This project will likely be delayed until wood prices drop.

f. Next Field Event - T.B.D.

Chair Thompson recommends we work on a Saturday to plan the fence at ENT. CM Wilbur suggests we do one day for putting in posts and another day of putting and screwing in pieces. It will be approximately a 140' fence. Vice Chair Hann suggests an easy day to tape out the area. CM Wilbur states he will get with Mr. Yeutzey and schedule the work day after. Chair Thompson suggests Saturday June 26th? Vice Chair Hann states weekends are hard, maybe an afternoon during the week? He suggests this Friday, June 18th at 4 PM. Consensus is in agreeance.





Florida D.O.T. District 5 Secretary Jared Perdue,

The DOT trail crossing of Malabar Road at the Marie Street intersection in Town of Malabar, is now need of DOT intervention to assure the safety of its equestrian, pedestrian (hiker), and bicycle users. This location is a critical point along the 22-mile South Brevard Linear Trail as it is simply where trail users encounter the most traffic. With some private wooded properties leading to Malabar Road, it effectively divides the greenway areas of the Malabar Scrub Sanctuary East (to the north) and the Jordan Scrub Sanctuary (to the south).

Recent rezoning and development plans of the property located at the northwest corner of the intersection is expected to result in increased activity and modification to existing swales on both sides of Malabar Road. The 22-mile South Brevard Linear Trail runs along the west side of Marie Street. While the crossing of Malabar Road has been designated by FL DOT as an equestrian trail crossing, it may be a while before a more user-accommodating trail crossing materializes from the future Malabar Road plans presented by FL DOT. Funding for future proposed changes in SR 514 design is not even budgeted at this time. However, action is needed now.

A short distance north of the trail crossing is the Sand Hill Trailhead, located at 1400 Marie Street. The trailhead was designed for all users but has special accommodations for horses. The need for the trail crossing was recognized and subsequently designated by DOT because Malabar Road is heavily travelled at times and horses need to feel safe when crossing a major road.

Accordingly, Town of Malabar now seeks additional FL DOT safety features for the trail crossing. Modification of swales to accommodate additional drainage needs due to property development is expected to radically reduce the square footage of the effective trail area to the north and south of the intersection. This will reduce the area where horses wait for traffic to stop prior to those horses safely crossing Malabar Road. Two actions appear to be needed at this time. This first would be for the trail crossing to be marked on the road surface. The second action would be the installation of a flashing yellow light that would only activate when a motion sensor detected one or more horses waiting to cross from either side of Malabar Road. These two actions would greatly improve the safety of this major road crossing of the South Brevard Linear Trail.

Town of Malabar respectfully requests DOT assistance to address this safety issue at our trail crossing.

Thank you for contacting the Florida Department of Transportation with the request from Mayor Reilly regarding the trail crossing of Malabar Road at the Marie Street intersection in the Town of Malabar. I am the FDOT Brevard Operations Engineer and will be taking the lead on this issue. Our team met this week to discuss your request. We believe the best approach will be to perform a study at this location. Our Traffic Operations team will be performing the study to determine the most appropriate safety measures for this location. This study will take approximately 3 months to complete. The consultant that will be performing this study will be reaching out to your office with regards to the upcoming development to ensure we include the additional associated development impacts.

With regards to the drainage concerns. On state roads, new developments are required to apply for an access permit from FDOT. At that time, the Department will be able to address any concerns associated with the drainage and other associated issues.

Additionally, we noted there may be an opportunity to improve the visibility of the crossing. We will be sending out a crew to evaluate any vegetation trimming that can be performed along the FDOT right of way that may improve site distance for the crossing.

Again, thank you for contacting us. As I'm sure you are aware, multimodal safety is a top priority for FDOT. I look forward to working with you on this and please feel free to contact me at any time for an update on the progress.
