Trail, Kiosk, and Firebreak Conditions

Vice-Chair Hann states the trails are great North of Malabar Road. South of Malabar Rd is very wet. ENT Trailhead had less clearing done than he anticipated, and the area is very wet. Firebreaks need to be brush hogged. Vice Chair Hann offers to create a scope of work to do the work, and EELs will maintain it after the initial work has been performed. After the Cogan grass grows back, have Ecor spray it. The North-South firebreaks are the most important for fire prevention services. Chair Thompson asks who is responsible for the Firebreak maintenance, the Town or the T&GC? CM Wilbur suggests it be bid out. MOTION: HANN/CAMERON: For the Town of Malabar to consider annual scheduled maintenance of the Firebreaks in Cameron Preserve, as to not interfere with the FCT GRANT and to allow cooperative efforts from other Public agencies.

SUBJECT: Trail Crossing Updates

BACKGROUND/HISTORY:

- a. After the June Trails and greenways Committee Meeting, the Town of Malabar sent a letter to the FDOT requesting increased crossing enhancements for the Marie Street/Malabar Road intersection.
- b. Late in October, Town Staff received emails detailing some initial findings in the FDOT Study of the intersection, listed below
 - a. Repair and widen the pavement radius on all four corners of the intersection.
 - b. The Town should consider restriping the stop bar and double yellow line pavement markings on the northbound and southbound approaches of Marie Street.
 - c. Install an equestrian warning sign (W11-7) along with supplemental warning "AHEAD" plaque (W16-9P) on eastbound S.R. 514, 175 feet west of the utility stop used by the equestrians.
- c. ITM Morrell has been in contact with contractors to begin restriping projects.

Florida D.O.T. District 5 Secretary Jared Perdue,

The DOT trail crossing of Malabar Road at the Marie Street intersection in Town of Malabar, is now need of DOT intervention to assure the safety of its equestrian, pedestrian (hiker), and bicycle users. This location is a critical point along the 22-mile South Brevard Linear Trail as it is simply where trail users encounter the most traffic. With some private wooded properties leading to Malabar Road, it effectively divides the greenway areas of the Malabar Scrub Sanctuary East (to the north) and the Jordan Scrub Sanctuary (to the south).

Recent rezoning and development plans of the property located at the northwest corner of the intersection is expected to result in increased activity and modification to existing swales on both sides of Malabar Road. The 22-mile South Brevard Linear Trail runs along the west side of Marie Street. While the crossing of Malabar Road has been designated by FL DOT as an equestrian trail crossing, it may be a while before a more user-accommodating trail crossing materializes from the future Malabar Road plans presented by FL DOT. Funding for future proposed changes in SR 514 design is not even budgeted at this time. However, action is needed now.

A short distance north of the trail crossing is the Sand Hill Trailhead, located at 1400 Marie Street. The trailhead was designed for all users but has special accommodations for horses. The need for the trail crossing was recognized and subsequently designated by DOT because Malabar Road is heavily travelled at times and horses need to feel safe when crossing a major road.

Accordingly, Town of Malabar now seeks additional FL DOT safety features for the trail crossing. Modification of swales to accommodate additional drainage needs due to property development is expected to radically reduce the square footage of the effective trail area to the north and south of the intersection. This will reduce the area where horses wait for traffic to stop prior to those horses safely crossing Malabar Road. Two actions appear to be needed at this time. This first would be for the trail crossing to be marked on the road surface. The second action would be the installation of a flashing yellow light that would only activate when a motion sensor detected one or more horses waiting to cross from either side of Malabar Road. These two actions would greatly improve the safety of this major road crossing of the South Brevard Linear Trail.

Ms. Franklin,

Thank you for contacting the Florida Department of Transportation with the request from Mayor Reilly regarding the trail crossing of Malabar Road at the Marie Street intersection in the Town of Malabar. I am the FDOT Brevard Operations Engineer and will be taking the lead on this issue. Our team met this week to discuss your request. We believe the best approach will be to perform a study at this location. Our Traffic Operations team will be performing the study to determine the most appropriate safety measures for this location. This study will take approximately 3 months to Page 14 complete. The consultant that will be performing this study will be reaching out to your office with regards to the upcoming development to ensure we include the additional associated development impacts.

With regards to the drainage concerns. On state roads, new developments are required to apply for an access permit from FDOT. At that time, the Department will be able to address any concerns associated with the drainage and other associated issues.

Additionally, we noted there may be an opportunity to improve the visibility of the crossing. We will be sending out a crew to evaluate any vegetation trimming that can be performed along the FDOT right of way that may improve site distance for the crossing.

Again, thank you for contacting us. As I'm sure you are aware, multimodal safety is a top priority for FDOT. I look forward to working with you on this and please feel free to contact me at any time for an update on the progress.
