Attorney advised Council about recent Supreme Court case on the narrow issue of restriction of free speech as court found there was basis of retaliation which did allow him to sue and directed a new trial.

#### F. **BCSO REPORT:**

Deputy gave stats for May. June stats should come out on the 10th. TA will send them out. TA asked Deputy about fireworks. Deputy knows about the concern with animals. Deputy explained they must see the fireworks lighted and that the person is not starting a race or scaring off wildlife. The fireworks lobby is very powerful. CM White asked if the stats break down the traffic counts by speeding stops. Deputy said the sorftware does not perform that breakdown.

# **BOARD / COMMITTEE REPORTS:**

Drew Thompson, Chair, T&G Com:

The decision of the "Trail Town" was pushed out to September. They want to make a personal visit and it will be sometime in late July or August. He will verify dates and encourage Council to be available when they tour the Town trails. CM White will be present. Agenda could be posted stating that two or more elected officials may be in attendance. They will show them around. Drew then spoke about the T&G plans to work on a new Eagles Nest Trailhead, explaining each trailhead should be named after an animal and there is an eagles nest in the area of Atz Road and Marie Street. They are proposing a plan to use the Town lot north of the PW yard a trailhead. It is 285' x 100' wooded area and they would like to get some clearing done in this year. Tag it on paper, pending Council approval and then do the initial carve out parking area similar to Sandhill Trailhead. He would like this plan to get on the Capital Improvement Plan.

Improving Jordan Blvd for emergency evacuation and put a parking lot with a gate similar to what they have a south end of Brook Hollow.

Eric Bienvenu, Chair Park & Rec Board: presented plan for memorial wall – then the trees and naming the playground after Huggins. CM Dick Korn attended their meeting and spoke about naming the playground at Malabar Community Park after Huggins. If Council approves tonight they will discuss and recommend type of signage. The memorial wall was depicted on overhead and construction was discussed. It is intended to be a permanent attraction and recognition of people that have served the Town.

Last two weeks we have had several compliments. Baseball team brought in a plaque. Also, the Rocky Pt owner called in and thanked the PW crew for a great job of trimming the overhanging limbs. A local business owner in Malabar stopped by to recognize the PW crew for their efforts even though they know how small they are staffed. Wants to keep that trend going. CM White asked TA to look at Eva Lane at Malabar Road. PW has filled in three times. No reason we haven't fixed it by now. TA said it is a high priority. CM White said in conjunction with whatever else they are doing this needs to be fixed before the road base is compromised.

MOTION: CM Mahoney / CM Rivet to approve 1st Reading of Ordinance 2018-06.

Discussion: CM Mahoney asked Atty Bohne if it looks ok. TA asked Council to consider putting this to voters every four years instead of every two years when we get such an overwhelming percentage in support of continuing with the MSTU. TA suggested they put the question to voters when the Sheriff changes. CM Ball like that the voters choose every two years. However, with the Sheriff we have now, we have a great relationship and they give us good support. He suggested it could be put to voters a year after a new sheriff is elected. CM Rivet asked about how much time and money is spent in putting this to voters every two years. TA said more than the cost of the legal ad is the Staff time. He and Deputy Clerk/Treasurer Matt Stinnett went and met with the Sheriff. TA suggested to tailor the question to coincide with the year after a new

Sheriff takes office. Mayor Reilly said if we do what CM Ball said is should be done after two years. Mayor said Sheriff Ivey has done a good job for Malabar. CM Rivet said they are Public Servants and should be accountable to voters. TA said it is a negotiated agreement. It will allow the limited office Staff to be more efficient. CM Mahoney asked about the money. She said Grant-Valkaria came to us and suggested we not vote it in because they would have preferred a contract. What does the MSTU pay for, how many MSTU vehicles? We still have a Sheriff paid for by County taxes. She supports keeping it going before the voters. Chair asked for clarification on ability to change frequency. Clerk Franklin explained that an ordinance was adopted in 2007 that stated Malabar would participate in the MSTU. A separate, subsequent ordinance was adopted to state that the question would go to the voters every two years. The Attorney stated then Council can repeal that ordinance and replace it with one that states a different term. This vote is on the wording for the 2018 ballot.

The Town should get part of that surtax that everyone is paying in order to fund stormwater projects that treat water before it reaches the lagoon. Attorney stated that the bigger polluters get more money. CM Rivet doesn't feel good about this without someone here to explain how the credits and the revenue are distributed. Neither did CM Ball.

5. Authorization to Purchase Gradall

MOTION: CM Rivet / CM Ball to approve purchase of Gradall up to the cost listed of \$316,662,00. TA asked if there were any questions about the proposal. Based on Sheriff bid. Roughly 16K increase, based on the fact that we keep this equipment for 15 years, this model won't be running up to its maximum capacity every time it is used. This model will have the reach they currently don't have. Wants approval to spend up to this amount. He will try and get the price down. The contract price for this is 46K per year. TA said Deputy Clerk/Treasurer Matt Stinnett was able to

find us a significantly lower interest rate for the fire truck and is doing the same for this lease purchase.

CM Mahoney asked if we have looked at renting. TA said they spent \$6K a month for a small track that couldn't do the job. TA said this piece of equipment works very well in Malabar as the reach is out and then down instead of up and out so prevents encounters with power lines. The one cab eliminates a lot of the control equipment and reduces the maintenance costs. CM Mahoney appreciates PW Director Tom Miliore coming and reporting at meetings and giving information about the equipment and their projects. Rent a piece when you need to use it and then you don't need a new building. TA said PW has done a good job and we need to approve the equipment so they can do the work. If we can't provide PW with the equipment they need, they can't get the work done. CM White said as a separate discussion item, he wants to see a lot more effectiveness of PW with this new equipment.

**VOTE:** Ayes, 3; Nay, 1 (CM Mahoney). Motion carried 3 to 1. CM White asked about the ditcher demo so they can pursue that purchase. TA said he will call manufacturer.

SUBJECT: Referendum Question for November 6, 2018 Election: MSTU (Ord 2018-06)

#### **BACKGROUND/HISTORY:**

Council approve the first reading of this ordinance at the June 2, 2018 meeting.

Council adopted Ordinance 2007-05 joining the Brevard County Law Enforcement Municipal Services Taxing Unit (MSTU) in June 2007. MSTU taxes were levied for law enforcement services starting in November 2008. The Table below shows the millage rates for each of the years following.

After voting to join the MSTU, Council adopted Ordinance 2007-06 that stated that the voters should decide if Malabar remain in the MSTU by putting it on the ballot every two years starting in November 2008. The agenda report from the last meeting explained what the county taxes pays for in law enforcement and what the MSTU tax dollars pay for.

#### ORDINANCE 2018-06

AN ORDINANCE OF THE TOWN OF MALABAR, BREVARD COUNTY FLORIDA; REPEALING ORDINANCE 2016-01; CALLING AND SCHEDULING A PERIODIC ELECTION TO DETERMINE IF THE TOWN SHOULD CONTINUE TO PARTICIPATE IN THE BREVARD COUNTY MUNICIPAL SERVICE TAXING UNIT (MSTU) FOR LAW ENFORCEMENT; PROVIDING FOR THE MANNER IN WHICH SUCH ELECTION SHALL BE CONDUCTED; ESTABLISHING THE FORM OF THE BALLOT FOR SUCH ELECTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Florida Statutes, 101.161 provides for the procedures to submit a public measure to a vote of the electors of a municipality and Malabar has followed that procedure in the 2008, 2010, 2012, 2014 and 2016 elections with respect to participation in the Brevard County MSTU for Law Enforcement; and

WHEREAS, In 2014, the Town Council recommended that the question to electors related to continuing participation in the Brevard County Law Enforcement MSTU be amended before being submitted for a vote of the electors to include the financial impact information of the MSTU to the Town's residents; and,

**WHEREAS,** The Town Council in 2016 directed that the question relating to continued participation in the Brevard County MSTU for Law Enforcement be simplified as it was prior to 2014; and,

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, as follows:

SECTION 1. Ordinance 2016-01 is hereby repealed.

#### SECTION 2.

A referendum election is hereby called and scheduled to be held concurrent with the election in November 2018, to determine whether the Town of Malabar shall continue participation in the Brevard County MSTU for Law Enforcement as more particularly in Exhibit A, which shall be approved by a majority of the votes cast in such election to the qualified electors residing in the Town shall participate. Such referendum election shall be held and conducted in a manner prescribed by law for all general elections. The place for voting in such referendum election shall be one of the two usual places, based on Precinct, for voting in the Town in the general election to be held in November 2018.

#### SECTION 3.

The ballot to be used at such referendum election shall contain a statement of the proposed subject matter of the question and shall provide facilities for qualified electors to vote for or against continued participation in the Brevard County Law Enforcement MSTU.

#### SECTION 4.

The Town Clerk is hereby authorized and directed to instruct the Supervisor of Elections of Brevard County to include the above-described question on the ballot for the general election to be held on the 6<sup>th</sup> day of November 2018.

#### SECTION 5.

Notice of the said referendum election in substantially the form showing in Exhibit B to this Ordinance shall be published two times in a newspaper of general circulation according to the laws of the State of Florida. The first publication shall be during the fifth week prior to the week

in which the referendum election is to be held and the second publication shall be during the third week prior to the week in which the referendum election is to be held. A minimum of five copies of this Ordinance shall be kept on file in the office of the Town Clerk for public inspection upon demand during normal business hours.

### SECTION 6.

If continued participation in the Brevard County Law Enforcement MSTU is not approved by a majority of the votes cast in such referendum election the Town Council shall repeal Ordinance No. 2007-05.

This Ordinance shall become effective five business days after its adoption

#### BACKGROUND/HISTORY:

This is the first step in the annual *Truth in Millage* process. Council must set the maximum proposed millage they wish to consider during their discussions and set the date for the first public hearing on the proposed millage and budget. This information is then sent to the Property Tax office and they include it on the TRIM Notice that is mailed to every Malabar property owner.

The ten percent cap we are held to due to Special Law 74-430 is based on the *rolled-back* rate, not the millage rate. Based on this, the maximum millage rate we are permitted to set is 2.1582.

Our millage rate was 2.0906 in 2018, 2.0260 in 2017, 1.9256 in 2016, 1.800 in 2015, and 1.6630 for 2011-2014. In 1978 when we set the first millage rate for ad Valorum collection the millage was set at 1.5. So, in 41 years, we have only increased the tax rate by 30%

To start the budget process, we should set the preliminary rate high and as you go through the budget workshops, you may determine that we can decrease it, but if we set it low now and then decide we need to increase it, we must do so at a great expense.

By August 4, 2018, we must tell the Property Appraiser the following:

- prior year's millage rate (2.0906)
- current years rolled-back rate (1.9620)
- current year's proposed maximum millage rate of 2.1582
- the date, time and meeting place of the first tentative budget hearing (9/5/18 at 7:30pm)
