## MALABAR TOWN COUNCIL REGULAR MEETING MINUTES March 20, 2017 7:30 PM

This meeting of the Malabar Town Council was held at Town Hall at 2725 Malabar Road.

#### A. CALL TO ORDER:

Chair, Mayor Patrick T. Reilly called the meeting to order at 7:30 pm. CM Korn led the prayer and pledge.

## C. APPROVAL OF AGENDA - ADDITIONS/DELETIONS/CHANGES:

CM KORN re: his response to Social Media – would like to add it to agenda and have read into record. No objection.

BCSO – sorry he missed last meeting: there were 334 calls for service in February. One theft. The crash stats were off by about half. Gave example of backing into maibox. They are trying to weed those out.

### D. APPROVAL OF THE MINUTES:

1. Regular Town Council Meeting Minutes 3/06/17

MOTION: CM Korn / CM Kohler to approve RTCM minutes of 3/06/17.

Discussion: CM Kohler said both Item 5 and 6 have the same motion. Franklin will listen and clarify both motions. Done.

CM Mahoney thinks the information in the minutes is untrue; it doesn't represent the whole thing in relation to MCA. She said the minutes don't represent the citizens as well as it could be. The MCA is being slandered.

CM Korn said he can't understand what she is saying. CM Korn suggested to Council that if they want something substantial changed in minutes – something you feel strongly about - put it in a written form before coming to the meeting. That is the only way to understand. CM Mahoney said the Agenda report title "Cancellation of SpringFest Due to Lack of Response from MCA". Chair stated that is a correct statement. Town sent contract and got nothing back from MCA in writing. CM Mahoney said they said at the meeting they would not sign it. Chair said that is not the way to handle it. TA said the contract was revised to provide additional language if the MCA did not make the revenue the "rent" would be reduced. That was presented to MCA and handed to Ms. Ritter. Never received any comment back from the MCA. CM Mahoney asked if Ms. Ritter could speak. CM Korn call point of order. Chair called for the vote. CM Mahoney said she thought it was slanderous. **Vote**: All Ayes, 4; Nay 1 (Mahoney).

## E. ATTORNEY REPORT: Nothing

**F. ATTORNEY LABOR:** Ford and Harrison Attorney Andy Hament spoke: Under PERC law volunteers are not eligible to vote. Any regular FTE or PTE would be eligible to vote. He has spoken to union and they are only looking to represent the 4 Lts.

#### Election process:

In order to file a petition to ask – provide evidence that at least 30% are interested. PERC – April 6 is date set for phone hearing. If there is no dispute, then hearing is not necessary. Then there will be vote by mail ballots. If less than 51% for union, the union does not represent the group. If 51% or more vote to be represented by union, then PERC will issue a statement. This is a right to work state meaning an employee cannot be required to join a union or pay dues. However, if a majority of employees vote the union in, all of the employees in that group are represented by the union, whether they join the union or not.

If you are represented by union, they can participate in collective bargaining – but that does not mean that either the Town or the union have to agree to anything that is not in its best interests. If negotiations do not go well, there is an impasse procedure. PERC will appoint a special magistrate to hold a hearing and then make recommendations to the Council. The Council then makes final decision.

The union's petition lists Firefighter, Driver Engineer and Lieutenants. The union has since clarified that it is only interested in representing full-time employees – the four Lieutenants. Hament's recommendation is to go along with that. Once the unit is determined, PERC will mail out the ballots. You are free to speak to Lt and talk about the pro and cons. Free to speak your mind. You just can't coerce people. Or threaten or promise. Happy to answer any questions.

CM Ball – Bargain for wages, benefits, and retirement and health and safety of the individual. Hament said per the law – volunteers are not eligible.

CM Korn – the nature of this FD is historically volunteer; this is completely out of character. It is now a combination (paid and volunteer) department. He has heard they only want a guarantee that if the FD is disbanded this will enable them to get work elsewhere. There seems to be a lot of misinformation. This is not intended to be a threat. He will not vote for this.

This does not provide protection to outsourcing. This Council has that right. It is a mixed department now; they used to only have one paid person Chuck McClelland who got \$100.00 a month.

What you have is a psychological thing. Legally there is no protection there. The Council has a right to outsource the Fire Department but this is making employees feel insecure and causing morale issues. Recommends Council resolve the issue once and for all, one way or the other.

CM Rivet – Can the Special Magistrate (SM) impose a recommendation. Atty Hament said yes. (Note: Clarification requested by Clerk to Attorney Hament and this is his response "If his question was can the SM impose his recommendations, then the minutes should read that I said no – if no final agreement is reached and ratified by the employees, the Council can impose its final decision on the items in dispute. The Special Magistrate only makes recommendations).

TA said despite all the talk of outsourcing, he hasn't seen any written offers from Palm Bay or Brevard County. He will be requesting that information soon and will have that information by the next council meeting.

#### G. STAFF REPORTS:

#### ADMINISTRATOR:

Sediments filtering IRL project – Eva Lane and treating water from 535-acre area. FDEP likes the project and is interested in funding 50%. Presented project to the CAC IRL group in hopes for partial funding from the County. It would cost no money from the Town. CM Rivet emphasized that this would be paid by grants not from taxpayers.

Atz Road drainage project is progressing – expect survey this week and then will finalize bid documents and post bid.

SR514 packet has been well received and we continue to get support from the various agencies we have presented to. Met with TPO and FDOT and their consultant and have they have a new plan that appears viable and they will give a full-blown presentation at the Malabar Council meeting of April 3, 2017.

CM Korn asked him if it would include the revised publication of the C2T manual defining the rural highway roads like SR514. He stated Council knows he has been working with the Malabar TPO TAC representative Mr. Don Krieger who had come by his house this afternoon. They have been working on this document about defining the roads and the 45 mph etc. and they would have it done in April and it will be more accurate than what we have now. CM Korn asked TA if the TPO had mentioned that to TA at his meeting. TA said no. CM Korn said he got the feeling from Mr. Krieger that April 3 was too early to have that document.

#### CLERK:

Newsletter – received articles from G-V, Nanas House and from a resident on the Fire Dept. and did article on Fall Fest – nothing from Council or Boards

In an upcoming meeting, staff will be proposing an adjustment to the SW fee to better fund the proposed SW projects.

The Redistricting Project is moving forward. We have contracted with a firm that specializes in redistricting for agencies throughout the country. They were recommended by the Brevard Elections Office. We have sent them the Shape files with the current district lines and the new residential population by house since 1/1/10 and they have populated the map. Mr. Ken Tozier will be sending out a tentative agenda for the workshop as well as a briefing paper on how this process is going to work. Workshop is proposed for early April so I will be contacting each of you.

After consensus at the workshop Council will formally approve the revised district lines and District map and it will be sent to the Supervisor of Elections so they can create the five new "precincts" for voting purposes. We will continue to use only one polling location so there is no intent to change that location.

I will be contacting each of you to determine what day is best for the workshop. Tentative dates are early April. Please check your calendars and let me know.

Mr. Milo Zonka gave overview of project. This is not a revenue source for the PA office. The 22 taxing authorities will recover some revenue. He then introduced Property Appraiser Dana Blickley. She explained that the vendor would help the P.A. Office do their job; it is another tool. The vendor will do the data mining that the PA Office can't afford or doesn't have access to and if a questionable case is identified, it is sent to the P.A. office to do the investigation. They might ask you to complete a questionnaire. CM Mahoney said since they need to do inquiry - will there be a hardship on the person. Dana gave example of a husband and wife each seeking and getting homestead exemptions. Yes, they would have to show evidence. In many instances, they have already had to show this evidence. The questionnaire would ferret out most of the issues. CM Mahoney so is there a reason why we have to give our approval. Dana said if they do not get Malabar approval they will still go forward. They are going to do their job. They are not going to exclude Malabar. Dana said in terms of intrusion, to make an application for exemption they ask a lot of questions that may offend some. If you have done that recently, it is an invasive process. It is better to have them slightly offended at the application step rather than get slapped with a large penalty for improper exemptions.

CM Rivet said he voted against this initially and after this additional information he is in favor of this.

Said that Town Chartered them and then church and state issue so went to Malabar Volunteer Fire Department Incorporated (non-profit not part of Town) but then they dissolved, so they then went to the Baptist Church for Charter until the decision was made regarding allowing gays in the Scouts and they went to the Valkaria Aviation Association. Malabar Council agreed they can use the Town logo when Bonnie was here (as Administrator). Council said the Troop could also use the yard to secure their equipment.

Paul Goetsch, Troop 9613 of Trail Life, his troop is in Malabar (Baptist Church), and he works in Malabar (Data Management). Why can't Trail Life and BS Troop 37 work together. He knows a lot of the history in the area. If he can be of assistance, just call.

CM Korn, would like to introduce a resolution in support of Troop 37. Paul Goetsch said if you do it for one do it for both groups.

Chair said the concerns are the use of logo and the equipment being stored at PW and FD. Wants Council to make a decision on this. TA said he is a BSA supporter and a supporter of Trail Life. BS Troop 37 is Chartered with Valkaria Aviation Assc. CM Korn asked if they were still called Malabar BS Troop 37. Liz said yes.

TA said ACLU brought lawsuit - If we are storing for one group - do so for all.

Atty said just allow one organization to use then it should be for all organizations. CM Korn asked if they can make motion to support BS Troop 37 and since they have a historical connection to the town.

CM Ball said BS Troop have gotten a rotten deal. We can't support you politically and then from the church. Take care of all these little issues. They can be addressed. The Town of Malabar should have a Boy Scout troop affiliation. If there is room for it, and if there is insurance they should support it.

Chair said there is a difference between Chartered and Support. Paul said the request to store as there are constraints for storing outdoors. They don't object to that for the Troop. They can store at his work and the airport. CM Ball asked about outdoor storage. Chair said this is just a discussion. Storage

On agenda for next meeting, resolution, supporting BS Troop 37. Between now and then Ms. Ritter and Mr. Hoyt can resolve. They had the east side of the PW yard with their own Key to the gate.

CM Korn said that Ms. Julianna Hirsch gave a trailer to the soccer organization to use at the field for storage. Chair said the issue is the storage. Atty – Council to give direction to TA on what we need to know. Maybe we can create that list for Council to approve. The open policy – it is your call to allow your symbol to be used.

## WORKSHOP ACTION: DISCUSSION ON R/LC - Definition

Chair recapped their homework assignment.

Referred to the Council Member Notebook each got for the FLUM and R/LC issue. Use Code, Section 1, definition "O" -. current and proposed language - see what you like and what you don't like.

P&Z wanted to make residential use first and then limited commercial below it. Then they are start as

P&Z wanted to make residential use first and then limited commercial below it. Then they created a table if you wanted to put multiple uses of R/LC. It is plus or minus one. The attorney suggested that they take it out but he believes it should remain in. This is the key thing on what R/LC. CM Rivet does not have a problem with the words.

CM Korn does not like the quotas. Do not need to be so tight on the rules. Built reputation on live and let live in this rural community. CM Korn said it is hard to regulate. Chair gave example of current residential and adjacent property owner wants to put in six LC. That was P&Z thinking.

CM Mahoney asked about the four units vs six units. Maximum height in R/LC. Mahoney said it should be two stories. Can they have that in R/LC? Chair said the regulations are the same for all zonings.

Ask Atty – can they have different regulations for R/LC re: parcels on Hwy 1 vs. parcels on Babcock and Malabar Roads? (Note: Attorney's response: Generally, I think the answer is yes if we have a rational basis so if privacy, aesthetics, compatibility, and any other rational reason is a concern then they can. You might want to consider a height adjustment if they want to go higher as a conditional use but you would need to establish objective criteria for the conditional use for instance height of the neighboring structure, distance from neighboring structure, etc.)

CM Korn said we are known as "Rural living at its best". Need to develop business districts. They could have different requirements in Palm Shores and Grant Valkaria have designated business districts. We should develop something similar. CM Rivet does not have problem with business on arterials. Problem when it encroaches into the rural areas.

Then they started reviewing the maps. Map 4: consensus to continue the OI along Babcock only the depth of one lot until Osage and then continue east to Prosperity.

Map 5: north side of Malabar Road: consensus to support the proposed changes.

Map 5: south of Malabar Road. Consensus to keep as indicated on the "Present land use" on the parcels west of Weber Road.

Map 6: For the parcels, east of Weber Road change to 660' maximum depth but make them R/LC not OI. CM Kohler stated his notes indicate the property owner of one of the large lots wanted her entire parcel to become R/LC. CM Mahoney wants to protect existing houses from being peered into by adjacent higher commercial structures.

Map 7: Go with P&Z recommendation

Map 8: Go with recommendation on north side. On south side change depth to 660'

Map 9: Go with recommendation

Maps 10 and 11: Go with recommendation

Map 12: parcel identified as RR should be Conservation - same issue on Maps 113 and 14.

CM Rivet appreciates members agreeing to compromise on the depth to retain the rural characteristics.

A RESOLUTION OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, PERTAINING TO A **REQUEST** FROM THE FLORIDA **TRANSPORTATION** PLANNING ORGANIZATION TO RECOMMEND A CONCEPT FOR THE WIDENING ON SR 514, MALABAR ROAD FROM THE WESTERN BOUNDARIES OF THE TOWN TO U. S. 1 (STATE ROAD 5) IN THE TOWN OF MALABAR; PROVIDING FOR DISTRIBUTION OF REQUEST; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Malabar Road is a State Road that intersects the Town of Malabar from east to west at Township lines 28 and 29 in South Brevard County; and,

WHEREAS, the recommended alternatives support the Town's desired goals to limit impacts to private property and the Disc Golf Park by utilizing lands within the Malabar Scrub Sanctuary for improvements to Malabar Road and,

WHEREAS, the recommended alternative between Corey Road and Marie Street includes a paved, multi-use trail on the north side of Malabar Road.

#### **SECTION 1. Findings:**

- 1. The Town of Malabar supports the recommended alternatives and alignments of Malabar Road, including updated sections from Weber Road to Marie Street, as follows:
  - a. Weber Road to Corey Road: Four-lane suburban typical section that features two (2) vehicular lanes in each direction of travel, a bike lane in each direction of travel, and a sidewalk on both sides: and.
  - b. Corey Road to Marie Street: Two-lane rural typical section that features one (1) vehicular lane in each direction of travel, paved seven (7)-foot shoulders on both sides, and a multi-use trail on the north side.
  - c. Roundabouts at the intersections of Malabar Road with Weber Road and Corey Road.
- 2. The Town of Malabar supports the use of a paved multi-use trail on the north side of the improved Malabar Road from Malabar Woods Boulevard to Marie Street to enhance multimodal use and connectivity among public facilities and parks.
