E. SHERIFF'S REPORT:

CM Korn said he will read comments during his report. He said his wife had noticed all the work the PW has been doing. Someone came up to her at local restaurant and thanked her for work PW has been doing. Someone stopped him at Home Depot and said same thing to him.

CLERK: Have not received anything from Council or Boards for newsletter. New article complementing the PW with photo and equipment.

TA said drainage issues are from the 1920's. He has found road elevations and contour maps and this information is absolutely necessary before any shovel is put in the ground.

Month of May review: He read from his report. 41 calls for the month of May. 36 active FF and 10 support services. 10,261 hours of volunteer's x 23/hr. – basically that is what you are saving. Through Forestry they got a cascade system. VFA grant.

Park Bd Chair Hans Kemmler - doing work at Disc Golf Park - fixed T-pad

Standing committee for SpringFest and have three members – report to Park Board or Council it doesn't matter. Meeting once a month. 3rd Thursday of month for meeting. Mayor said events committee and they want to report directly to council. Mayor told them that would be a council decision. CM Korn said his recommendation to be a subcommittee of Parks and Rec. Mayor added that as a standing committee they can use outsiders. CM Vail said what are their plans for Huggins Park. CM Korn said it is a wonderful piece of land very well maintained property. CM Vail said add article in newsletter. CM Kohler added it could be a dog park. Add to next Park and Rec agenda.

T&G Chair Drew Thompson said they would like to do what they did at north end of Corey at Marie Street at south end by Atz Road. He asked why there is a no trespassing sign there. Would like to have the sign removed. The committee could then do a meandering trail heading east through Jordan Blvd. Simply allow some access to Jordan Scrub. If Council approves, it would be a temporary use until Atz connects to Marie Street. Talk about it at council and get back to them.

On another front — USNG — GIS for signage and mapping so someone's smart phone everyone is talking about using SCTPO — Bike Trail Advisory Com BTAC. Murry Hann is actually the Chair. That is the forum that gives suggestions to TPO for consideration and funding.

Their emphasis is connecting with other communities. CM Vail asked about integrating G-V and Malabar on similar projects. Their committee is looking at working on Maries St ROW at south end (Leghorn) but there is a problem with wetlands. Talking to EELs and / or getting easement from Harris Corp. CM Korn asked about Leghorn. He hadn't been there in years. Would wooden bridge on Al Tuttle trail be what he means. Yes. But that was a EELs project.

Mayor Crews referred to some county property at south end that county offered us for parks but we declined. CM Kohler suggested he contact BMBA for volunteer help. Drew mentioned their improved website.

CM Krieger asked about cycle tracks – re: funding. The last meeting of TPO they discussed a paved 2-way cycle track. One of the roads up in Titusville was actually dedicating the ROW.

Palm Bay is dedicating a new park on east side of Babcock Street. Olin Johnson. CM Kohler said it is already a trail but it is not official.

Discussion: CM Vail – summed up his constituent's ideas. CM Krieger said he presented the reso at the last meeting and the reso in package was changed and had additional stuff by Doug. He handed out revised reso with his comments in italics. Line throughs and underlines are shown.

Krieger said they should get the intersections improved first and take the traffic signals out of the resolution. Chair asked if he wanted to amend the motion. CM Krieger wants to amend the reso to take out the lights. Utilize land on north side. Did not implement – last line has italics. Under findings – use. He doesn't envision the discussion

Motion is to replace pg. 1 with new pg. 1. Krieger and Ball. Krieger said this is a sharp stick in the eye. Where is this going. More has to be done but this is a start. First do the two intersections.

MOTION: CM Krieger / Ball to approve Reso 06-2016 with new page 1.

CM Korn agrees with 80-90% of what CM Krieger has said. But we need to get their attention. The presentation they gave to us at last meeting was a scam. My suggestion to them is honor your promise on 2014 to improve intersections and reduce speed. After you have done that in good faith. CM Krieger thinks this reso will do that.

CM Vail asked about funding. CM Krieger said he went to the meetings at the hospital it was their interpretation to improve the intersections was a done deal.

CM Ball said he supports Krieger's reso but still thinks traffic lights are necessary. TA agrees with Krieger but had talked to the BCSO MSTU deputies and they felt the traffic lights were needed. The turn lanes will cause more accidents. Also with the high speed the Chief said it is hard to get rescue vehicles. He spoke with the FDOT and they said tell him what they really want. We need a reso that is unified.

CM Vail said he went through the same thing in front of his shop. It was 2-lane. Since they widened there are more T-bone accidents. Overall and exposure to it, during high traffic times, it is worse.

Voting on amendment first: take lights out. CM Ball said his concern is CM Ball, Aye; CM Vail, Aye; CM Krieger, Aye; CM Korn, Aye; CM Kohler, Aye. Motion carried 5 to 0.

Right now we get a smaller amount monthly and it just goes into the general fund. CM Vail said what is the amortization schedule. TA said in 10 years. Also if technology changes MOTION: CM Korn / CM Vail to take the larger amount now.

Discussion: CM Korn believes that the technology is changing so fast and the satellites will be replacing towers.

CM Ball said he doesn't have a problem with onetime payment. CM Vail said what kind of interest. 2 basis points. TA has investigated some investments for government funds. CM Krieger said the towers are going to be around for a long time and why aren't we looking at other cell tower vendors.

Mrs. Ritter, Orange Avenue asked what are we doing to replace the monthly amount? CM Vail said that getting the reserves built back up is more important. He has been asking about this for a long time. If they have been pulling from reserves to meet budget, then it is a double shortfall. CM Krieger said there is more information we want. CM Korn asked if TA

would he be comfortable going back to them and request a higher number. TA said he looked at the internet. What we are receiving from Crown Castle is consistent with other vendors are paying.

ORDINANCE 2016- D\

AN ORDINANCE OF THE TOWN OF MALABAR, BREVARD COUNTY FLORIDA; REPEALING ORDINANCE 2014-09; CALLING AND SCHEDULING A PERIODIC ELECTION TO DETERMINE IF THE TOWN SHOULD CONTINUE TO PARTICIPATE IN THE BREVARD COUNTY MUNICIPAL SERVICE TAXING UNIT (MSTU) FOR LAW ENFORCEMENT; CALLING AND SCHEDULING A PERIODIC ELECTION TO DETERMINE IF THE TOWN SHOULD AMEND THE CHARTER, SECTION 2.02 TO CHANGE THE CURRENT WAY TOWN COUNCIL MEMBERS ARE ELECTED FROM "AT-LARGE" TO BEING ELECTED BY DISTRICT; PROVIDING FOR THE MANNER IN WHICH SUCH ELECTION SHALL BE CONDUCTED; ESTABLISHING THE FORM OF THE BALLOT FOR SUCH ELECTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Florida Statutes, 101.161 provides for the procedures to submit a public measure to a vote of the electors of a municipality and Malabar has followed that procedure in the 2008, 2010 and 2012 elections with respect to participation in the Brevard County MSTU for Law Enforcement; and

WHEREAS, In, 2014, the Town Council recommended that the question to electors related to continuing participation in the Brevard County Law Enforcement MSTU be amended before being submitted for a vote of the electors to include the financial impact information of the MSTU to the Town; and,

WHEREAS, The Town Council has now directed that the question relating to continued participation in the Brevard County MSTU for Law Enforcement be simplified as it was prior to 2014; and

WHERAS, The Town Council has recommended that a referendum question be submitted to the electors of the Town to determine if the Town Charter should be amended to change from "at-large" voting to district voting as more particularly described herein.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, as follows:

SECTION 1. Ordinance 2014-09 is hereby repealed.

SECTION 2.

A referendum election is hereby called and scheduled to be held concurrent with the general election in November, 2016, to determine whether the Town of Malabar shall continue participation in the Brevard County MSTU for Law Enforcement and a referendum election is also hereby called and scheduled to be held concurrent with the general election in November, 2016, to determine whether the Town of Malabar should adopt an amendment to the Town Charter, section 2.02 relating to how Town Council members are elected, as more particularly described in Exhibit A, shall be approved by a majority of the votes cast in such election in which the qualified electors residing in the Town shall participate. Such referendum election

shall be held and conducted in a manner prescribed by law for all general elections. The place for voting in such referendum election shall be the usual place for voting in the Town in the general election to be held in November, 2016.

SECTION 3.

The ballot to be used at such referendum election shall contain a statement of the proposed subject matter of the question and shall provide facilities for qualified electors to vote for or against continued participation in the Brevard County Law Enforcement MSTU and an amendment to Section 2.02 of the Town Charter relating to a change from "at-large" voting to district voting in two (2) separate ballot questions.

BACKGROUND/HISTORY:

There has been interest to change or repeal this section of the code.

Staff is well versed in the prerequisites to developing a parcel in Malabar. We not only provide the applications and checklists, we provide the sections of applicable code to guide them.

When a property owner has requested information on special exceptions or variances to our code we have also provided those sections of the code dealing with variances.

Staff respectfully requests that the code be changed if Council no longer wants to provide that as an alternative method to develop their property.

ACTION OPTIONS:

- (2) However, should such principal structure not be located wholly on one (1) lot, or should the owner desire to construct accessory uses, ponds or outbuildings (accessory to the principal structure) on the contiguous lot, then the local street/road shall be improved through the furthest boundary on which such accessory building to be constructed.
- (c) The board of adjustment may only grant a variance to the requirements of subsection (b)(1) and (2). Notwithstanding the authority granted to the board of adjustment in section 1-12 of the Town of Malabar Land Development code the below stated procedures shall in all respects be utilized for a variance to subsection (b)(1) and (2). In order to authorize a variance under this section the board of adjustment must find the following:
 - (1) That special conditions and circumstances exist and that the presence of which would make complying with subsection 13-38(b)(1) or (2) unreasonable. Financial or economic reasons, conditions or circumstances shall not be grounds for a variance under this section;
 - (2) The special conditions and circumstances are not caused in any way by the owner or applicant;
 - (3) That such variances will not be injurious or detrimental to the public welfare;
- (4) That the variance granted is the minimum variance that will make possible the reasonable use of the land;
- (5) As a condition to the issuance of a variance the owner of the property shall dedicate the right of way required by section 13-39 of the code through the furthest boundary of the lot of record on which a principal structure or accessory structure is to be constructed. The owner shall also execute an agreement in recordable form with the town that binds the owner and his ner successors in interest to pay for the proportionate share of completion of the road through the furthest boundary of the lot of record on which a principal structure or accessory structure is constructed in the event the road is completed by another. The board of adjustment may impose additional reasonable conditions and safeguards that it deems appropriate;
- (6) The board of adjustment may prescribe a reasonable time limit within which the action for which the variance is required shall be begun or completed or both.

PROPOSED PURCHASING GUIDELINES

NON PIGGYBACK PURCHASES

\$0.00 to \$1,000.00

1. No purchase order required for purchases between \$0.00 and \$1,000.00 unless the item or service being purchased required definition as to size, color, application or other custom feature that requires delineation. In this case a completely filled out purchase order with all of the pertinent requirements as is necessary in order to conclude a transaction, including those listed below in section 2.

No purchase orders are to be issued "after the fact" i.e.: items purchased and then a purchase order issued for the purchase. Exceptions to this would include an emergency that would affect safety of a resident or employee or cause a catastrophic occurrence.

After the fact invoices will not be honored by the Town. Violation of this policy shall be cause for disciplinary action to the offender up to and including termination.

\$1,000.01 to \$10.000.00

2. Purchases of \$1,000.01 to \$10,000.00 shall identify the requestor and the justification for said request for purchase. Town Council shall approve any purchase amount over \$5,000.00 unless said item or service is specifically called out in the Town Annual Budget, in which case prior approval is deemed in place.

The Purchase Order/Contract shall include the following as they apply to the item or service being purchased:

Complete Specifications and or Outline of Work Required

Vendor/Contractor Requirements

Insurance – if required for service

Valid License - if required for service

Length of Time for Proposal Validity

Delivery/Completion Time.

Town of Malabar purchase documents take precedence over all other vendor documents in their entirety.

FOB Point. Note: In most cases the preferred FOB point is Town of Malabar. (freight damage)

Exclusions

Terms and Conditions Waiver of Lien upon Acceptance and Payment – if required for service.

Acknowledgment copy of the purchase order / Contract to be signed by the vendor and returned to the Town as notification and acceptance of the P.O./Contract.

\$10,000.01 and up.

3. Purchases of \$10,001.00 and above require public call for bid in a recognized publication and Town Council Majority approval prior to making an award for the issuance of any purchase order or contract. In addition all of the requirements listed in section 2 must be part of any purchase order or contract.

PIGGYBACK CONTRACTS

- I. Piggybacking is the ability of one governmental agency to avail itself of the purchasing power of other governmental agencies when like services, products or equipment are required. This will reduce costs due to the elimination of writing specifications, advertising for bids, bid evaluation and the economy of scale. In certain instances this process of combining purchases with other governmental agencies may be of value to the Town of Malabar.
- II. In order for Malabar to utilize combined purchasing the following conditions must be met:
 - a. The requirement to purchase must be the same or similar to the purchase being made by a sister organization.
 - b. The Town of Malabar must obtain at least one check bid prior to making any commitment to becoming a party to a given piggyback contract.
 - c. The Town of Malabar must have access to all original bid documents prior to becoming a party to a combined or piggyback contract.
 - d. The Malabar Town Council must approve in advance all piggybacking purchases.

The foregoing is an outline of generally accepted purchasing practices. Please review the above and make any changes and or comments as you see fit.

Please be prepared to discuss this package at the next RTCM and return your marked up copy of this package. We will combine any or all changes that are consistent with good purchasing practices as they apply to governmental purchasing and the Town of Malabar. 

A RESOLUTION OF THE TOWN OF MALABAR, BREVARD ANNUAL COUNTY. FLORIDA. **IMPOSING** AN STORMWATER UTILITY ASSESSMENT BEGINNING OCTOBER 1, 2000, AGAINST ALL REAL PROPERTY WITHIN THE TOWN LIMITS OF MALABAR, BREVARD COUNTY, FLORIDA; PROVIDING FOR CLASSIFICATIONS OF PROPERTY; PROVIDING CERTIFICATION OF ANNUAL ROLL; ASSESSMENT STORMWATER UTILITY PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 15-104 of the Code of Ordinances, Town of Malabar, Florida, the Town Council is authorized to adopt a rate resolution for the purposes of imposing a stormwater utility fee or assessment upon the owners of all real property located within the Town; and

WHEREAS, Section 197.3632, Florida Statutes, and Section 15-104 of the Code of Ordinances, Town of Malabar, provides that on or before the fifteenth day of September the Town Council of Malabar shall hold a public hearing to adopt a rate resolution for the purpose of imposing said schedule of annual stormwater utility fees or assessments [this Rate Resolution shall stay in effect until such time as a change in the Stormwater Utility Fee or Assessment is proposed], after proper notice and publication; and

WHEREAS, prior to September 15, 2000, the Town Council will hold a public hearing to adopt a budget for the operation and maintenance of the Town's stormwater management program for the ensuing fiscal year, and this rate resolution adopted by the Town Council provides sufficient revenues to fund the budget adopted for the operation and maintenance of the Town's stormwater management program; and

WHEREAS, Exhibit "A" of this Resolution provides a Schedule of Rates and Classifications specifying the amount and calculation of annual stormwater utility fee or assessment

imposed within the Town for the fiscal year beginning October 1, 2000; and

WHEREAS, the Town Council is satisfied that the annual Stormwater Utility Assessment Roll has been prepared in conformity with the Schedule of Rates and Classifications.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, AS FOLLOWS:

Section 1

The Town Council of Malabar, Florida does hereby adopt the Schedule of Rates and Classifications attached hereto as Exhibit "A" for all property located within the Town of Malabar.

Section 2

It is intended by the Town Council of Malabar, Florida, that this Resolution constitutes the rate resolution specified in Section 15-104 of the Code of Ordinances of the Town.

Section 3

The Town Council of Malabar, Brevard County, Florida, hereby ratifies, confirms, and certifies that the annual Stormwater Utility Assessment Roll for fiscal year beginning October 1, 2000, is in conformity with the Schedule or Rates adopted by the Town Council.

Section 4

A certified copy of this rate resolution shall be delivered to the Brevard County Tax Collector.

Section 5

Those stormwater utility assessments imposed during fiscal year beginning October 1, 2000, shall be billed by the Town of Malabar or its authorized representative, pursuant to the provisions of Section 15-104 and 15-106 of the Code of Ordinances, Town of Malabar, and shall be due and payable on November 1 of each year, pursuant to law.

Section 6

If any section, subsection, sentence, clause, phrase or portion of this rate resolution is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holdings shall not affect the validity of the remaining portions of this rate resolution.

Section 7

This Resolution shall take effect immediately upon its adoption.

BILLING CLASSIFICATIONS:

- A- Agricultural: Any property without structures which is used for agricultural pursuits, and is designated as agricultural on the Brevard County Property Appraiser's records.
- S- <u>Single Family Dwelling</u>: Any property upon which is located any building or structure designed or constructed for, and capable for use as a residence for one family and is erected on a separate lot or parcel.
- **D-** <u>Multiple Single Family Dwelling Units:</u> Any property upon which is located more than one building or structure, each of which is designed and constructed for, and capable for use as a residence for one family.
- M- <u>Multifamily Dwelling</u>: Any property, designated as a trailer park, or upon which is located any building or structure, consisting of more than one dwelling unit, each designed for occupancy for one family.
- B- Condominium: Any parcel identifying an individual condominium or townhouse unit.
- E- Commercial: Any lot or parcel upon which is located any structure or facility designed for business related uses (other than as a single family dwelling unit).
- I- <u>Industrial</u>: Any lot or parcel upon which there is a structure or building for use as productive enterprises and/or manufacturing activities.
