Local Considerations

- There are 105 confirmed COVID-19 cases, and 2 deaths in Brevard County.
- Brevard County Public Schools has served 48,000 meals; there will no meal distribution on April 10 due to a planned student/teacher holiday. Brevard families utilizing this service should plan to pick-up their children's meals on April 9.
- Brevard County Board of County Commissioners cancelled several upcoming Planning and Development advisory board meetings:
 - North Merritt Island Board: The April 9 and May 14 meetings have been postponed to June 11.
 - Planning and Zoning Board/Local Planning Agency: The April 20 and May 4 LPA/PZ meetings have been postponed to June 15. This will be a combined PZ/LPA meeting.

- The County Commission Zoning meeting for the above advisory boards is July 9.
- Board of Adjustment: The April 22 and May 20 BOA meetings have been postponed to the regularly scheduled June 17 BOA meeting.
- ESF18 Business & Industry:
 - A call to businesses in Brevard County, looking for Personal Protection Equipment to be donated for use by hospitals and emergency workers. PPE includes
 - Gloves: Must be non-latex for medical use, can be made of nitrile or vinyl, any color, any size except small or extra small, unopened boxes please
 - Masks: Disposable surgical or procedure masks with ties or elastic, any color; N95 or KN95 masks any size/manufacturer; *Will also accept home-sewn masks as well for distribution to ALF/nursing home residents
 - Goggles or face protection: Clear, either goggles with straps, or eyeglass type; face shields that cover masks—clear thin plastic
 - Gowns: Yellow isolation, non-woven lightweight fabric-disposable; blue barrier, thin blue plastic disposable; will also accept Tyvek bunny suits
 - Miscellaneous supplies: hand sanitizer unopened bottles of any size, fragrance, brand; shoe covers; hair covers; thermometers - electronic oral or any other type; probe covers for thermometers
 - If you have PPE you are willing to donate, please ship to warehouse location: 560 Solutions Way, Rockledge, FL.
 - Please note, we are only looking for PPE from businesses. Individuals who may have items to donate should give to United Way, Meals on Wheels or similar organizations.

Community Report

- Brevard County Utility Services:
 - (Not COVID-related) North Brevard/Mims area residents should reduce water usage for non-essential activities, such as washing cars and watering grass until further notice.
- Brevard County issued an order to limit tourism and lodging:
 - o Brevard County is closed to tourists and leisure visitors.
 - Effective April 3, all hotels, motels, campgrounds, short-term (less than 28 days) vacation rentals, and other transient rentals, to include marinas, recreational vehicle parks, and timeshares, shall cease renting to tourists for 30 days.
 - The order does not apply to rentals to transitory military personnel, first responders, healthcare workers, construction workers actively engaged in projects in Brevard County, and others working or engaged in formal business in Brevard County. A letter from the lodger's employer must indicate the purpose of the stay and must be presented at rental or lodging facility upon arrival.
- (Not COVID-related) A burn ban is in effect countywide due to the Keetch-Byram Drought Index exceeding 500. All of east central Florida now in moderate drought conditions, and the peak of Florida brushfire season is fast approaching.

 - Target: Tuesday, and Wednesday, 8 9 AM
- BJ's Wholesale Club has announced new initiatives: employee temperature check upon shift entry; mask and glove availability to staff; stores will be closed on Easter Sunday, April 12
- Space Coast Area Transit has waived all fares through April 30
- Eastern Florida State College:
 - All four EFSC campuses will remain closed for the rest of the spring term.
 - Special considerations are being made for a limited number of programs and labs. In those cases, strict social distancing guidelines shall be followed.
 - Student Services are available remotely, including virtual one-on-one student meetings that may be necessary. <u>View our Student Services guide for details.</u>

- City of Cocoa Beach
 - Cocoa Beach City Commission will have a scheduled meeting on April 16 at 7 PM. A decision on virtual meeting versus social distancing attendance is TBD.
- Town of Grant-Valkaria:
 - Town Hall is closed to the general public; essential services will continue; in-person meetings and services are discontinued until further notice.
- Town of Indialantic
 - Beaches are closed to all activities except walking, jogging, biking, fishing, surfing, and swimming through April 30. Activities such as sunbathing, sitting in chairs, organized sports or lying on blankets and grouping of persons is not permitted. People will not be allowed to congregate on boardwalks and access areas. Compliance with the CDC recommendations regarding social distancing shall apply.
 - Beach parking and beach access parking will remain closed.
 - Town Hall, police, and fire departments remain closed to the public. Customer service continues by telephone or electronically.
- City of Indian Harbour Beach:
 - All exercise and playground equipment in City parks are closed.
 - All beach parking is restricted.

- Town of Malabar:
 - Town Hall is closed to the general public. Essential services will continue operating via e-mail and phone calls.
 - The playground equipment and park restrooms are closed until further notice.
 - Public meetings through April 19 have been canceled.

- City of Melbourne:

- Town of Melbourne Beach
 - Municipal Emergency Executive Order 2020-04 pertaining to beach restrictions was signed into effect. This order supersedes previous beach closure order (2020-03).
 - Public beaches in the Town of Melbourne Beach are now closed to all activities except walking, jogging, biking, fishing, surfing and swimming. Activities such as sunbathing, sitting in chairs, organized sports or lying on blankets and grouping of persons is not permitted. People will not be allowed to congregate on boardwalks and access areas. Social distancing shall apply. When your activity is complete, you will be required to leave the beach area. This follows State of Florida Executive Order 20-91, Safer at Home, specifically Essential Activities and will apply until further notice. Beach parking and beach access parking will remain closed. Failure to comply with the Order may result in further restrictions being applied.
 - All annual fire inspections have been postponed until further notice.
 - All building inspections continue at the discretion of the Building Official on a caseby-case basis.
 - Police department lobby is closed; for non-emergency, dial (321) 723-4343.
 - Town Hall lobby remains closed to the public; all business must be conducted via phone (321) 724-5860 or click <u>here</u>
- Town of Melbourne Village
 - Town Hall is closed to the public; essential services will continue through drop box at Town Hall door, phone (321) 723-8300, or email <u>town@melbournevillage.org</u>; inperson meetings and services are discontinued until further notice
- City of Palm Bay:
 - City Council will hold virtual City Council meeting tonight and test for public comment accessibility.
 - City facilities remain closed to the public while city operations continue.
 - Essential services and COVID-19 updates available at <u>www.pbfl.org/COVID19</u>
 - Palm Bay Utilities Department will continue to waive late fees and continue to suspend shutoffs due to non-payment through April 30 to coincide with the Governor's Executive Order.
 - Palm Bay Building Division is allowing a 90-day extension on permits, but contractors must contact the Building Division to request it. 30 days are automatically granted.
- Town of Palm Shores
 - Shoreside Park is closed indefinitely.
 - Town Hall is closed to the public and requests for permits and inspections should be called to 321-242-4555 to schedule an appointment.
- City of Rockledge
 - Building Department Effective April 8 permit pick-up, issuance, and payment will be by appointment only. Plan review will continue as normal.

- City of Satellite Beach:
 - Satellite Beaches are closed to all activities except walking, jogging, biking, fishing, surfing, and swimming, through April 30. No congregating on boardwalks or accesses will be permitted.
- City of Titusville
 - Declared Local State of Emergency on March 18.
- City of West Melbourne
 - The city continues to serve the public primarily through telephone (321-727-7700) email <u>info@westmelbourne.org</u>
 - o The skatepark at West Melbourne Community Park closed until further notice
 - Parking at the park is closed. The park is available for walking and running, provided persons abide by social distancing requirements

Rumor Control

- Hotels remain closed to tourists. Exceptions include business travelers who can produce a note from their employer, those who are working in Brevard County, local residents who need to isolate away from a family member with coronavirus.
- The COVID-19 virus has not been detected in drinking-water supplies.
