

## **Event Overview**

- The pandemic currently affects over 185 countries, with more than 1,840,093 cases worldwide, including 550,016 cases in the United States
- Residents may call 2-1-1 for up-to-date information between 8 AM and 6 PM daily
- The FDOH COVID-19 call center is available 7 days a



week, 24 hours a day at 1-866-779-6121, but is experiencing a large volume of calls. Another option is to email COVID-19@flhealth.gov

## **Local Considerations**

- There are 133 confirmed COVID-19 cases, and 4 deaths in Brevard County.
- All 27 Brevard County Public Schools distribution sites will reopen Monday, April 13, from 10:30 AM to 1:30 PM
- Brevard County Board of County Commissioners cancelled several upcoming Planning and Development advisory board meetings:
  - North Merritt Island Board: the April 9 and May 14 meetings have been postponed to June 11.
  - Planning and Zoning Board/Local Planning Agency: the April 20 and May 4 LPA/PZ meetings have been postponed to June 15. This will be a combined PZ/LPA meeting.
  - The County Commission Zoning meeting for the above advisory boards is July 9.
  - o Board of Adjustment: the April 22 and May 20 BOA meetings have been postponed to the regularly scheduled June 17 BOA meeting.
- ESF18 Business & Industry:
  - o A call to businesses in Brevard County, looking for Personal Protection Equipment to be donated for use by hospitals and emergency workers. PPE includes
    - Gloves: Must be non-latex for medical use, can be made of nitrile or vinyl, any color, any size except small or extra small, unopened boxes please

- Masks: Disposable surgical or procedure masks with ties or elastic, any color;
   N95 or KN95 masks any size/manufacturer; \*Will also accept home-sewn masks as well for distribution to ALF/nursing home residents
- Goggles or face protection: Clear, either goggles with straps, or eyeglass type; face shields that cover masks—clear thin plastic
- Gowns: Yellow isolation, non-woven lightweight fabric-disposable; blue barrier, thin blue plastic disposable; will also accept Tyvek bunny suits
- Miscellaneous supplies: hand sanitizer unopened bottles of any size, fragrance, brand; shoe covers; hair covers; thermometers - electronic oral or any other type; probe covers for thermometers

  - o Florida Department of Health: north, central & south Brevard locations
    - Must be symptomatic with fever of 100.4+, cough, or shortness of breath
    - To schedule an appointment, call 321-454-7141
  - o OMNI Healthcare: Melbourne location
    - Must meet ONE of the following criteria: first responder, over 45 with one chronic illness, over 60 years old, healthcare worker, Publix or Winn Dixie employee, low grade fever or cough
    - To schedule an appointment, call 321-802-5515 or 321-727-1973 or visit www.covid19testbrevard.com
    - Insurance will be billed for testing
- Brevard County Utility Services:
  - (Not COVID-related) North Brevard/Mims area residents should reduce water usage for non-essential activities, such as washing cars and watering grass until further notice.
- Brevard County issued an order to limit tourism and lodging, and to prohibit usage of spoil islands:
  - Brevard County is closed to tourists and leisure visitors.
  - Effective April 3, all hotels, motels, campgrounds, short-term (less than 28 days)
     vacation rentals, and other transient rentals, to include marinas, recreational vehicle parks, and timeshares, shall cease renting to tourists for 30 days.
  - The order does not apply to rentals to transitory military personnel, first responders, healthcare workers, construction workers actively engaged in projects in Brevard County, and others working or engaged in formal business in Brevard County.
  - All access and use of spoil islands and sandbars is prohibited.

- (Not COVID-related) A burn ban is in effect countywide due to the Keetch-Byram Drought Index exceeding 500. All of east central Florida now in moderate drought conditions.

- Retailers' announced hours dedicated for seniors:

  - Walmart stores/pharmacies/vision centers: Tuesday, 6 7 AM
  - o Walgreens: Tuesday, 8 9 AM, senior discounts offered all day
  - o Target: Tuesday, and Wednesday, 8 9 AM
- BJ's Wholesale Club has announced new initiatives: employee temperature check upon shift entry; mask and glove availability to staff.
- Space Coast Area Transit has waived fares through April 30. Bus routes are now available between 7 AM and 6 PM.
- Eastern Florida State College:
  - o All four EFSC campuses remain closed for the rest of the spring term.
  - Student Services are available remotely, including virtual one-on-one student meetings that may be necessary. <u>View our Student Services guide for details.</u>

- Brevard County Public Schools:
  - Food distribution sites are open weekdays from 10:30 AM to 1:30 PM at 27 schools.

  - o Distance learning will remain in effect until May 4.

    distancing guidelines.

#### Town of Indialantic

- Beaches are closed to all activities except walking, jogging, biking, fishing, surfing, and swimming through April 30. Activities such as sunbathing, sitting in chairs, organized sports, or lying on blankets and grouping of persons is not permitted.
   People will not be allowed to congregate on boardwalks and access areas.
   Compliance with the CDC recommendations regarding social distancing shall apply.
- Beach parking and beach access parking will remain closed.
- Town Hall, police, and fire departments remain closed to the public. Customer service continues by telephone or electronically.

### Town of Melbourne Beach

- Municipal Emergency Executive Order 2020-04 pertaining to beach restrictions was signed into effect. This order supersedes previous beach closure order (2020-03).
- O Public beaches in the Town of Melbourne Beach are now closed to all activities except walking, jogging, biking, fishing, surfing and swimming. Activities such as sunbathing, sitting in chairs, organized sports, or lying on blankets and grouping of persons is not permitted. People will not be allowed to congregate on boardwalks and access areas. Social distancing shall apply. When your activity is complete, you will be required to leave the beach area. This follows State of Florida Executive Order 20-91, Safer at Home, specifically Essential Activities and will apply until further notice. Beach parking and beach access parking will remain closed. Failure to comply with the Order may result in further restrictions being applied.
- All annual fire inspections have been postponed until further notice.

- All building inspections continue at the discretion of the Building Official on a caseby-case basis.
- Police department lobby is closed; for non-emergency, dial (321) 723-4343.
- Town Hall lobby remains closed to the public; all business must be conducted via phone (321) 724-5860 or click <u>here</u>

## Town of Melbourne Village

- Extension of the Town of Melbourne Village local state of emergency in accordance with Town resolution 2020-02 until April 17.
- Town Office is still closed to the general public; however, business is still being conducted using email address of <u>town@Melbournevillage.org</u> or (321) 723-8300.

# City of Palm Bay:

- City Council extended local state of emergency.
- Utilities Department will continue to waive late fees and continue to suspend shutoffs due to non-payment through April 30 to coincide with the Governor's Executive Order.
- Building Division is allowing a 90-day extension on permits, but contractors must request extension by contacting the Building Division; 30 days are automatically granted.
- o City facilities remain closed to the public while City operations continue.

## **State/National Highlights**

- Florida Department of Education is distributing 32,614 laptop computers to 34 mostly small, rural school districts throughout Florida and the Florida A&M University Developmental Research School.
- The Governor's Executive Order 20-87: All vacation rentals, rental of any house, condominium, cooperative, or dwelling unit that is also a transient public lodging establishment are prohibited from making new reservations or bookings and shall not accept new guests for check-in; has been extended until April 30, per EO 20-103.
- The CDC issued an extension of a No Sail Order for all cruise ships for 100 days.
- The CDC advises that critical infrastructure workers may be permitted to continue work
  following potential exposure to COVID-19, provided they remain asymptomatic and
  additional precautions are implemented to protect them and the community, such as
  wearing a mask for 14 days, cleaning and disinfecting all surfaces, staying 6 feet away from
  anyone, and having their temperature taken daily.
- The Department of Children and Families will waive work requirements for individuals participating in the Supplemental Nutrition Assistance Program and Temporary Assistance

- for Needy Families program; additional information can be accessed by calling 850-300-4DCF or click here

- Governor DeSantis waived the work search and work registration requirements for

#### **Public Protective Measures**

- Wash hands with soap and water for 20 seconds
- Use hand sanitizer with at least 60% alcohol

- Advise sick employees to stay home
- Allow telework or administrative leave
