CDC Guidance on Thanksgiving and COVID-19



- If having guests to your home, be sure that people follow the steps that everyone can take to make Thanksgiving safer. Other steps you can take include:
 - Have a small outdoor meal with family and friends who live in your community.
 - · Limit the number of guests.
 - Have conversations with guests ahead of time to set expectations for celebrating together.
 - Clean and disinfect frequently touched surfaces and items between use.
 - Limit the number of people in food preparation areas.
 - Have guests bring their own food and drink.
 - If sharing food, have one person serve food and use single-use options, like plastic utensils

- Rental/Mortgage Assistance Program and Utility/Security Deposit Program are available for applicants who submit all required documents and attachments to qualify for assistance as listed on the <u>Housing & Human</u> <u>Services Coronavirus Assistance</u> <u>Program Application Form</u>.
- Visit the Brevard CARES website for details on the <u>Small Business and</u> <u>Nonprofit Organizations grant on-line</u> <u>application</u>.
 - Small businesses and nonprofit organizations may be eligible for grants up to \$10,000 to offset expenses and lost revenue related to impacts from COVID-19.
- Residents financially impacted by COVID-19 can apply for the A/C, Heating Unit Replacement Funds.
 - <u>Paper applications are</u> <u>available</u> at county libraries and community Centers.
- Workforce Recovery Assistance
 <u>Program</u> is available through
 December 30, 2020. This program aids small businesses (fewer than 50 employees) impacted by COVID-19.

- The CDC has updated its webpage for holiday celebrations and small gatherings. Recommendations include:
 - Celebrating virtually or only with members of your own household poses the lowest risk for the spread of COVID-19.
 - Consider the amount of COVID-19 cases in your area, exposure during travel, location of gathering, duration of gathering, and the number of attendees
 - Gatherings with more safety measures in place, such as mask wearing, social distancing, and handwashing, pose less risk than gatherings where fewer or no preventive measures are being implemented
