




And just today, we've learned that 86% OF K-12 TEACHERS AND SCHOOL STAFF have gotten at least their first shot.

Vaccine Operation Highlights

- Florida Department of Health Brevard, and the partners they support, have provided 114,998 vaccines since January 4, 2021
- The Florida Department of Health has made adjustments to the COVID-19 dashboard and switched to weekly reports
- Per the Florida Department of Health, the total number of residents vaccinated in Brevard County is 289,376 (as of 6/10)
 - 54% of those 12 plus
- DOH has partnered with Library Services, Emergency Management and Health Heroes to conduct a Pfizer vaccine operation with an emphasis on increasing vaccine availability for children 12-17, but is open to anyone 12+ (second dose dates/location on page 2)
- DOH is coordinating with the local business community to establish vaccine outreach missions
 - A current list of locations and operating hours for the month of June is available on their website.



Florida COVID -19 Vaccine Priorities

(Revised 3/26, effective 4/5 per Executive Order 21-79)

Persons over 18 years of age

*All vaccines are approved for this age group

Persons 12 – 17 years of age

*Requires parental or legal guardian consent

*Pfizer is the only FDA vaccine approved for this age group

Community Partner Operations as of 6/18/21




- For information on food pantry locations and how to access additional help, utilize the United Way of Brevard's COVID-19 Community Resource guide
- Brevard County Public Schools continue to offer meals for all children up to 18 years old at various food distribution sites.
 - Food distribution sites are open Mondays, Wednesdays, and Fridays at several local Brevard County Public School locations
 - A seven-day-meal package program is being offered on Wednesdays only and requires pre-registration. (dates/locations on page 5)
- The Brevard County Parks and Recreation Department will participate in the <u>Summer Break Spot Program</u> beginning Monday, June 7, and running through Friday, August 6, 2021. Any child age 18 or younger can receive a meal.
 - Meals will be served on a first-come, first-serve basis; child must be present to receive food. Children may consume the meal at the site or take it with them. At lunchtime, on Fridays, children can receive a shelf stable weekend meal to take home, along with their lunch meal.

Brevard County Updates



- Brevard County Government has a limited amount of funds to assist families who have lost a loved one due to Coronavirus. The <u>application for the program</u> is available at the Community Action Agency (Dr. Joe Lee Smith Community Center, 415 Stone Street, Cocoa, FL 32922), or <u>Brevard County's Housing and Human Services website</u>.
 - Eligibility requirements include:
 - Cause of death on the death certificate must be directly or indirectly related to Coronavirus (COVID-19)
 - Example of indirect heart attack (main) exacerbated by coronavirus
 - Brevard resident and household income below 150% of poverty (\$39,300 for a family of 4)
- The Emergency Rental Assistance Program provides financial assistance and housing stability services for those impacted by COVID-19.
 - Eligibility requirements include:
 - Applicant is a resident of Brevard County and is below 80% of Area Median Income.
 - The applicant must sign all required documents or their application will be rejected/denied.
 - Documentation of all income from the entire Household as reported on the Household Income Section of the application (include 2 months of bank statements, paystubs, etc., or a 2020 tax return (IRS Form 1040)).
 - All members of a household must be accounted for in the application.
 - For applications filled out by hand, please make sure that the writing is clear and legible
 - Program statistics as of 5/21/21:
 - 848 applications received since 2/12/21
 - 601 (71%) from municipalities
 - 245 (29%) from County (unincorporated)
- Brevard County EOC will return to a Level 3 on Friday, June, 25th. This will be the last community report

State and National Updates

- All state COVID-19 testing sites have transition to local providers, such as primary care offices, retail, and pharmacies
 - Florida Division of Emergency Management can provide a full list of COVID-19 testing sites near your location
- Subscribe to get CDC's COVID Data Tracker Weekly Review sent to your inbox every Friday
- Per the CDC, as of June 23, more than 319 million doses of vaccines have been administered in the United States and 62.7% of the entire United States population over 12 has had at least one dose of a COVID vaccine
- The current 7-day moving average of <u>daily new cases (13,997) decreased 6.0%</u> compared with the previous 7-day moving average (14,890). Compared with the highest peak on January 10, 2021 (251,834), <u>the current 7-day average decreased 94.4%</u>.
- The White House announced that the United States is donating half a billion vaccines to countries around the world because it's the right thing to do and because as long as this virus has a hold somewhere in the world, we're all at risk.
- The CDC issued guidance for fully vaccinated individuals within the United States. Per the guidance, they can now can resume activities that were done prior to the pandemic without wearing a mask or social distancing; except where required by federal, state, local, tribal, or territorial laws, workplace guidance, rules, and regulations
