

RESOLUTION 08-2013

A RESOLUTION OF THE TOWN OF MALABAR PROVIDING FOR THE ADOPTION OF GOAT CREEK LANE AS A NEW MALABAR PRIVATE STREET NAME; PROVIDING THE FORWARDING OF THIS INFORMATION TO BREVARD COUNTY ADDRESS ASSIGNMENT FOR E 9-1-1 EMERGENCY IDENTIFICATION PURPOSES; PROVIDING FOR REPEAL; PROVIDING FOR CONFLICT; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Malabar has the responsibility of naming or approving the names of private or public roadways within its jurisdiction through coordination with Brevard County Address Assignment for E 9-1-1 purposes; and

WHEREAS, Brevard County Commission has approved the name of Goat Creek Lane for the private access off of Valkaria Road in Section 17 and Malabar Council has directed that the portion of that private access in Section 8 providing access to parcels 503, 504, 509, 511 and 515 also be named Goat Creek Lane as indicated on attached map, marked "Exhibit A," and

WHEREAS, after adoption of this new street name, the Brevard County E 9-1-1 and Address Assignment offices shall be notified of its approved status.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, as follows:

SECTION 1. That the Town of Malabar approves of the new name "Goat Creek Lane" for the private access described above.

SECTION 2. By naming this access, Malabar in no way accepts maintenance responsibilities for said access.

SECTION 3. It shall be the property owners responsibility to place the appropriate street sign(s) and keep said access clear and accessible for emergency vehicles.

SECTION 4. That the Town of Malabar directs that this resolution be recorded at the Brevard County Clerk of Courts and a copy be forwarded to Brevard County Address Assignment for input into the E 9-1-1 database and additional copies be sent to the Post Office serving that area, the property owners, the Supervisor of Elections, and all concerned public safety agencies for their information, and that the proper notations be made on all maps of record.

SECTION 5. All resolutions or parts of resolutions in conflict herewith are hereby repealed.

SECTION 6. Should any Section, Clause, or Provision of this Resolution be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the remaining provisions or parts of this Resolution.

SECTION 7. This resolution shall take effect immediately upon its adoption.
