## **RESOLUTION 9-2014**

A RESOLUTION OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, ADDING THE CONSTRUCTION OF A RESTROOM AT THE SAND HILL TRAILHEAD FOR COMMUNITY ENHANCEMENT PURPOSES TO THE CURRENT FIVE YEAR PLAN OF THE CAPITAL IMPROVEMENT SCHEDULE; PROVIDING SUPPORT FOR OUR GRANT APPLICATION TO THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION OFFICE OF GREENWAYS AND TRAILS FOR 113,113.00 TO COMPLETE THIS PROJECT; PROVIDING FOR THE ALLOCATION OF CONTRIBUTING FUNDS OF 11,310.00 IN CASH AND THE SAME AMOUNT IN IN-KIND SERVICES FROM MALABAR IN FISCAL BUDGET 2013-2014; PROVIDING FOR CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE.

- WHEREAS, the Town of Malabar's Comprehensive Plan stipulates that adequate recreation facilities and open space shall be provided in order to meet present and projected future needs; and
- WHEREAS, the Town of Malabar has developed a community trailhead for mixed recreational uses at the Sand Hill Trailhead with funding assistance from the Department of Greenways and Trails; and
- **WHEREAS**, The Town of Malabar is a duly constituted municipality qualified to meet the needs of its citizens, its neighbors and its visitors; and has previously demonstrated its commitment to complete this project and comply with all State laws, rules and regulations.

## NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, THAT:

- Section 1. Intent. The Town Council directs that this project continue to be included as an item on the Capital Improvements Plan for the current five year schedule.
- <u>Section 2. Funding.</u> The Town of Malabar is pursuing grant funding to assist in the construction of a restroom; specifically through the Department of Environmental Protection Office of Greenways and Trails. This Program will fund 80% of this cost.
- <u>Section 3. Budget.</u> Recognizing that this grant requires local funds, either cash or in-kind service, as a match in the amount of \$22,620.00, the Town Council directs the allocation of contributing funds for the fiscal year 2013 2014.
- <u>Section 4. Conflict.</u> All resolutions or parts of resolutions in conflict herewith are hereby repealed.
  - Section 5. Effective date. This resolution shall take effect upon passage.
