SONG LICENSE AGREEMENT

This is a Song License Agreement (hereinafter "Agreement") dated this 28th day of September, 2011 and shall be effective commencing on October 1, 2011 by and between: Rick and Chris Rakauskas, (hereafter referred to as the "LICENSOR"); and The Town of Malabar (hereafter referred to as the "LICENSEE").

Grant: The LICENSOR owns and holds a copyright for the song "The Little Town of Malabar" and hereby grants to the LICENSEE the exclusive license for the song "The Little Town of Malabar" (hereinafter the "SONG") and to use the said SONG and the words and music of said SONG at all Town sponsored events; on the Town web site; in and on all Town promotional materials and news letters and for any purpose in promoting the Town of Malabar. The Town of Malabar shall not use the SONG and the words and music for any other purpose.

Term: This Agreement shall be for the term commencing October 1, 2011 and ending September 31, 2012 and shall automatically renew for successive annual terms unless

terminated as provided for herein.

Consideration: For consideration of the grant, LICENSEE shall pay a yearly royalty of one dollar (\$1.00), the receipt and sufficiency of which is hereby acknowledged for the initial term. Said annual royalty payment shall be made on or before the expiration of the previous annual period.

Conditions of Use: Conditions for renewal are timely payment of the yearly royalty. The LICENSEE shall not sub-license the SONG and the words and music of said SONG for any

consideration.

Termination: This Agreement may be terminated by either party, with or without cause, by giving the other party at least 60 days advanced written notice prior to the expiration of the current annual term of its intent to terminate this Agreement.
