RESOLUTION 19-2012

A RESOLUTION OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA ACKNOWLEDGING THE SAFETY CONCERNS OF THE RESIDENTS OF BROOK HOLLOW SUBDIVISION; SUPPORTING THE SPEED REDUCTION ALONG BRIAR CREEK BOULEVARD WITHIN MALABAR JURISDICTION; REQUESTING PALM BAY TO ALSO REDUCE THE SPEED ALONG BRIAR CREEK IN THEIR JURISDICTION; PROVIDING DIRECTION TO STAFF TO INSTALL 20MPH SPEED LIMIT SIGNS; PROVIDING FOR REPEAL OF RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in the 1980's the Malabar Town Council approved a subdivision plat known as Brook Hollow that was supposed to be built in phases and utilize a collector roadway between Malabar Road and Pt. Malabar Blvd, with said lots being developed at a density of four per acre creating a highly dense neighborhood; and,

WHEREAS, the subdivision development ended after Phase I and Briar Creek Blvd was never completed to connect to Malabar Road, making this a no outlet development; and,

WHEREAS, the residents of Brook Hollow have presented their concerns about speeding along this corridor and the tragic accidents that have occurred in part because of the failure of drivers to abide with traffic control devices; and,

WHEREAS, Malabar Town Council has approved installation of a speed hump along Briar Creek Blvd and the installation of additional stop signs so each intersection requires all sides to stop; and,

WHEREAS, Malabar Town Council desires to establish the rationale for reduced speed along this roadway by this resolution in order to document the reduced speed.

NOW, THEREFORE BE IT RESOLVED BY THE TOWN OF MALABAR OF BREVARD COUNTY, FLORIDA that;

SECTION 1. The Malabar Town Council supports the speed reduction on Briar Creek Blvd. to 20 mph and directs staff to install such signs.

SECTION 2. The Malabar Town Council directs the Administrator to contact Palm Bay to seek their mutual support in placing similar 20 mph signs along their section of Briar Creek Blvd.

SECTION 3. All resolutions or parts of resolutions in conflict herewith are hereby repealed.

SECTION 4. This Resolution shall take effect immediately upon passage.
