### **RESOLUTION 02-2007**

## A RESOLUTION OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, REPEALING RESOLUTION 7-93 RELATING TO FIRE INSPECTION FEES; PROVIDING FOR ADOPTION OF NEW FIRE SAFETY APPLICATION, REVIEW, INSPECTION AND PERMIT FEES; PROVIDING FOR REPEAL OF RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Town Council of Malabar adopted the most current edition of the Florida Fire Prevention Code as provided for in the Florida State Statute 633.0215 in order to establish building and structural regulations relating to fire prevention; and

WHEREAS, The Town Code provides for the Town Council to establish by resolution reasonable nonrefundable application, review, inspection and permit fees to cover the Town's cost in administering provisions of the code to comply with the Florida Fire Prevention Code, the Florida Building Code and Florida State Statute in requiring the Fire Marshal to conduct plan review and new construction inspections of commercial premises located within the Town of Malabar, for the purpose of ensuring public health, safety and welfare of the citizens of the Town of Malabar; and,

**WHEREAS,** the Town Council of the Town of Malabar has determined that a revision to the fees schedule is appropriate in order to more accurately reflect staff obligations and costs to the Town of Malabar and provide a more equitable fee schedule:

# NOW, THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, as follows:

**SECTION 1. FEES.** The Town of Malabar does hereby adopt the following fees in accordance with the Town of Malabar's Code, the Florida Fire Prevention Code and Florida Statute 633, for Fire Safety and Compliance Review; said fees to be in the amounts set forth in this resolution, replacing Exhibit "A" in the resolution notated above.

#### SECTION 2. NEW CONSTRUCTION SITE PLAN REVIEW AND INSPECTION

**FEES.** The Town of Malabar shall perform site plan review and site improvement inspections, as required by law, on multi-family residential project sites with greater than three units proposed and all commercial projects sites. Proposed site plans are reviewed for access, fire fighting water, urban/rural interface, and property setbacks for fire safety. Subdivisions also require a similar review and site inspection to insure water requirements are met. Change of Use refers to an occupancy classification change within an existing building.

#### SECTION 3. NEW BUILDING CONSTRUCTION REVIEW AND INSPECTION

**FEES.** The Town of Malabar shall perform construction plan review and inspections, as required by law, on multi-family residential construction building projects with greater than three units proposed. This includes new construction, remodeling and repairs, and those projects requiring a commercial construction permit. Technical assistance may be necessary on certain projects and portions of the fire prevention plan review may need to be performed by an independent third party with expertise in the matter to be reviewed, at the submitter's expense. This

provision

is defined in the Florida Fire Prevention Code.

<u>SECTION 4. FIRE PREVENTION SAFETY INSPECTION FEES</u>. The Town of Malabar shall perform fire prevention safety inspections, as required by law, on commercial business occupational occupancies, multi-family residential or short-term lodging occupancies, assembly, educational and medical occupancies, and industrial and storage occupancies. The Town of Malabar shall conduct these inspections annually for the following rates based on the square footage of the building or occupancy. The inspection fee includes one re-inspection within 45 days to ensure that any violations noted during the initial inspection have been corrected. If no efforts have been made

to comply with the Fire Prevention Code requirements, a compliance inspection fee that is twice the original fee shall be assessed. If additional inspections after the first compliance (third actual) inspection are required, the fee will continue to be increased by twice the initial fee. If the occupancy shall fail to comply after the sixth actual inspection, the Fire Marshal shall have the authority to revoke said occupancy and forward to the Special Magistrate for their review and/or administrative action.

It shall further be assumed that the Town Council would have enacted the remainder of this resolution without said invalid or unconstitutional provision, thereby causing said remainder to remain in full force and effect.

**SECTION 8. EFFECTIVE DATE.** This Resolution shall become effective
