## **RESOLUTION NO. 28A-2008**

A RESOLUTION OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, PROVIDING FOR COUNCIL APPROVAL OF THE INTERLOCAL AGREEMENT WITH BREVARD COUNTY SCHOOL BOARD SUPPORTING THE REVISED SCHOOL CONCURRENCY PLAN; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Brevard County, Malabar and all other municipalities within the geographical boundary of Brevard County School District are required by the Florida Statute 163.31777 to enter into an Interlocal Agreement with the district school board to jointly establish specific ways in which the plans and processes of the district school board and the local governments are to be coordinated; and

WHEREAS, the Interlocal Agreement encompasses the concurrency requirements in Florida Statute 163.3180 and the planning requirements in Florida Statute 1013.35; and

**WHEREAS**, the Town of Malabar is required by Florida Statute to include this concurrency plan in its Comprehensive Plan.

## NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, that:

<u>Section 1.</u> The Town Council of Malabar, Brevard County, Florida, hereby approves and directs that the Interlocal Agreement to be signed by the appropriate Town Officials.

<u>Section 2.</u> The Town Council of Malabar, Brevard County, Florida, hereby authorizes and directs that the signed Interlocal Agreement be forwarded to the Brevard County School Board.

**Section 3.** This Resolution shall take effect immediately upon its adoption.
