RESOLUTION NO. 13-2009

A RESOLUTION OF THE TOWN OF MALABAR, BREVARD COUNTY FLORIDA; CALLING AND SCHEDULING A NON-BINDING REFERENDUM ELECTION TO DETERMINE IF THE TOWN OF MALABAR SHOULD CONTINUE TO SUPPORT THE PURCHASE OF COMMERCIAL AND RESIDENTIAL REAL PROPERTY IN THE TOWN BY THE ENVIRONMENTALLY ENDANGERED LANDS PROGRAM FOR BREVARD COUNTY ("EELS"); PROVIDING FOR THE MANNER IN WHICH SUCH ELECTION SHALL BE CONDUCTED; ESTABLISHING THE FORM OF THE BALLOT FOR SUCH ELECTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, The Town of Malabar is a municipal corporation organized and existing in Brevard County, Florida and has a population of 2859 and a total land area of 11.5 square miles; and

WHEREAS, the EELS program was approved by Brevard County voters in a 1990 Brevard County referendum; and

WHEREAS, the Brevard County, Board of County Commissioners has final responsibility for implementation of the EELS program; and

WHEREAS, the EELS program has purchased approximately 939 acres of land in the Town, which is approximately thirteen percent (13%) of the land in the Town; and

WHEREAS, the removal of this land from the tax base of the Town has and will cause financial strain for a town the size of the Town of Malabar; and

WHEREAS, the EELS program goals include, but are not limited to, interagency partnership, effective communication with the public, uniform acquisition procedures throughout Brevard County, providing liaisons with local agencies, cooperation with all municipalities in Brevard County, consideration of the financial situation of the affected municipality, impacts on the local community, economic impacts and impact on local programs; and

WHEREAS, despite numerous requests by the Town for cooperation and limiting real property purchases in the Town to the Brevard County, Board of County Commissioners and the EELS program, the Town Council believes that the Town's requests have been substantially ignored; and

WHEREAS, the Town Council believes that EELS has purchased a sufficient quantity of land within the Town and that no more purchases should occur; and

WHEREAS, the Town Council believes that it should be up to the residents of the Town to determine if the Town of Malabar should support future purchases of commercial and residential land by EELS in the Town; and

WHEREAS, Florida Statutes, 101.161 provides for the procedures to submit a public measure to a vote of the electors of a municipality; and

WHEREAS, the Town Council hereby submits to the electors of the Town a non-binding referendum election determine if the Town should support future purchases of commercial and residential land in the Town by EELS.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, as follows:

Section 1.

If there is a need to hold an election for a council seat on the Town Council of the Town in the November, 2009 general election then a non-binding referendum election is hereby called and scheduled to be held concurrent with the general election on the 3rd day of November, 2009 to determine whether the Town should support future purchases of commercial and residential land in the Town of Malabar by the Environmentally Endangered Lands Program for Brevard County. The non-binding referendum shall be approved by a majority of the votes cast in such election in which the qualified electors residing in the Town shall participate. Such non-binding referendum election shall be held and conducted in a manner prescribed by law for all general elections. The place for voting in such non-binding referendum election shall be the usual place for voting in the Town in the general election to be held on the 3rd day of November, 2009. However, in the event there is no need to hold an election for a council seat on the Town Council for the Town in November, 2009 general election then a non-binding referendum election is called and scheduled to be held concurrent with the general election in November, 2010 to determine whether the Town should support future purchases of commercial and residential land in the Town of Malabar by the Environmentally Endangered Lands Program for Brevard County.

The polls shall be open at such voting place on the day of such referendum election during the hours specified by the general laws of the State of Florida. All duly qualified electors residing within the Town shall be entitled to participate in and vote at such referendum election.

Section 2.

The ballot to be used at such non-binding referendum election shall contain a statement of the proposed subject matter of the question and shall provide facilities for qualified electors to vote for or against support for future purchases of commercial and residential land in the Town of Malabar by the Environmentally Endangered Lands Program for Brevard County (EELS) in two

(2) separate ballot questions. Said ballot shall be in substantially the following form:

Section 3.

The Town Clerk is hereby authorized and directed to instruct the Supervisor of Elections of Brevard County to include the above-described question on the ballot for the general election to be held on the ___ day of November, 2009 if an election for a council seat on the Town Council is necessary. If an election for a council seat in November 2009 is not necessary then the Town Clerk is hereby authorized and directed to instruct the Supervisor of Elections of

Brevard County to include the above-described questions on the ballot for the general election to be held in November, 2010.

Section 4.

Notice of the said non-binding referendum election in substantially the form showing in Exhibit A to this Resolution shall be published two times in a newspaper of general circulation according to the laws of the State of Florida. The first publication shall be during the fifth week prior to the week in which the referendum election is to be held and the second publication shall be during the third week prior to the week in which the referendum election is to be held. A minimum of five copies of this Resolution shall be kept on file in the office of the Town Clerk for public inspection upon demand during normal business hours.

Section 5.

This Resolution shall take effect immediately upon its adoption.
