## **RESOLUTION 30-2012**

A RESOLUTION OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, PROVIDING FOR COUNCIL APPROVAL OF ROBERT STRANDELL TO SERVE AS THE FIRE CHIEF FOR THE MALABAR FIRE DEPARTMENT FOR AN ANNUAL STIPEND OF \$9,162.92; PROVIDING FOR REPEAL OF RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Malabar has had an Interim Fire Chief since Chief Covey left on July 1, 2012; and

WHEREAS, the Town Administrator, in accordance with section 8-92 (1) shall recommend to the Malabar Council a person for this position; and

WHEREAS, the Interim Fire Chief position has been filled by Malabar Assistant Chief Robert Strandell since July 1, 2012 in order for the Administrator to observe his capabilities in this position and get input from Fire Department personnel and the Town Administrator has recommended that Robert Strandell be approved as the new Town of Malabar Fire Chief..

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, as follows:

SECTION 1. That the Town Council accepts the recommendation by the Town Administrator of Mr. Robert Strandell for the position of Fire Chief for the Malabar Fire Department.

SECTION 2. That the Town Council offers the position of Fire Chief to Mr. Robert Strandell for an annual stipend of \$9,162.92 with a 2% raise effective October 1, 2012.

SECTION 3. All resolutions or parts of resolutions in conflict herewith are hereby repealed.

**SECTION 4.** This resolution shall take effect immediately upon its adoption. 4
