

## **RESOLUTION 43-2014**

**A RESOLUTION OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, PROVIDING FOR COUNCIL APPROVAL OF BID PROPOSAL FROM VOLUSIA GENERAL CONTRACTORS, DBA FORMASTERS AT A COST OF \$39,695.00 FOR THE FABRIFORM BREAK REPAIR & ERODED SOIL REPLACEMENT WITH FLOWABLE FILL UNDER THE WEST END OF BRIAR CREEK BOULEVARD BRIDGE ID#705500 OVER TURKEY CREEK; PROVIDING FOR FUNDING; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Malabar Town Council has determined the need to repair the void at the west approach slab and repair the slope protection, drain flum and related restoration work to the Briar Creek Boulevard (Brook Hollow) bridge for the safety and welfare of the traveling public; and

**WHEREAS**, The project was put out to bid and the Town received four submittals and held the bid opening on December 5, 2014 and they were reviewed by the Administrator and Town Engineer; and

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, that:**

### **Section 1.**

The Town Council of Malabar, Brevard County, Florida, hereby selects and approves Volusia General Contractors DBA Formasters as the Company to provide the Bridge Repairs under Briar Creek Boulevard at a price of \$39,695.00 and authorizes the Town Administrator to execute a contract for this project.

### **Section 2.**

The Town Council of Malabar, Brevard County, Florida, hereby authorizes and directs the Town Administrator to direct the funds to be allocated for Briar Creek Boulevard Bridge Repair from the Stormwater Fund in the amount of \$39,695.00.

### **Section 3.**

The Town Council of Malabar, Brevard County, Florida, hereby authorizes and directs the Town Clerk to notify the selected company advising that they have been awarded the bid for this project.

### **Section 4.**

This resolution shall take effect immediately upon its adoption.
