

RESOLUTION 78-2011

A RESOLUTION OF THE TOWN OF MALABAR, BREVARD COUNTY, FLORIDA, PERTAINING TO A BUDGET ADJUSTMENT IN THE FISCAL YEAR 2010-2011; PROVIDING FOR REPEAL OF RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

SECTION 3. Amend the Budget Amount in Streets and Roads (541) Department.

SECTION 4. Amend the Budget Amount in Parks & Recreation Department.

Transfer from and to the Accounts indicated on the attached Budget Transfer Authorizations to accurately record the revisions to the Parks & Recreation Department.

SECTION 5. Conflict.

All resolutions or parts of resolutions in conflict herewith are hereby repealed.

SECTION 6. Effective Date.
