Town Council Election Qualifying

It is election season again! This year, the Town of Malabar will be holding elections for 2 seats. Districts 4 and 5 are all up for election in 2021. The Town of Malabar will hold its municipal election on Tuesday, November 2nd, 2021, from 7:00 a.m. to 7:00 p.m. at which time the two (2) Council Members (Seats 4 and 5) will be elected to serve from the first regular Council meeting in November following the election (November 15th, 2021) until the Special Council meeting on November 9, 2023. Due to the approval of the referendum question on the 2016 ballot, the candidates for Districts 4 and 5 must not only qualify from their respective Districts but now must be voted on **ONLY BY** those electors residing in their respective Districts.

Last year, with the passing of Ordinance 2020-05, Town Council has extended the qualifying period back to a two-week period from 8:30 AM on July 27th to 4:00 PM on August 10th. Forms will be available from the Office of the Town Clerk and online during this time period and may only be filed during this period.

REQUIREMENTS TO QUALIFY AS A CANDIDATE

All persons desiring to announce and qualify as a candidate for office in Malabar must meet the following criteria:

- Be a resident of Malabar for six (6) months for Council.
- Candidates for Districts 4 and 5 must reside within their District at time of qualifying and throughout the election and term of office.
- Complete the Qualifying Paperwork and Oath of Candidate.
- Select a Campaign Treasurer and name a bank for campaign financing.
- All candidates must collect signatures from a minimum of 15 registered voters within their District.
