

The Town of Malabar got its 1st official Post Office and name on December 24,1883 when R.A. Ward was named Postmaster by President Chester A. Arthur. Two times a week, the boat that travelled down the intracoastal waterway from Jacksonville, would deliver the mail to the palmetto shack post office along the river bank at Malabar. The mail was dumped on the counter for the population of 25 to shuffle through. With the coming of the railroad, in 1893, the mail boat was no longer needed.

### **Sheriff Protection or Create a Malabar Police Department**

From the Desk of Ed Booth, Town Administrator

Police protection affects all of us, homeowners and renters alike, so I'd like to ask that all renters bear with me on the discussion of taxes and still respond to the enclosed survey. Every input is considered valuable.

For some time now the Brevard County Sheriff's Department has been *requesting* that the Malabar Town Council pass an ordinance to allow a special tax on all taxpayers in town. This special tax is called a MSTU (Mult Service Taxing Unit) and would cover Sheriff protection in Malabar. Currently Sheriff protection in Malabar is limited. At this point in time, Brevard County has stopped *requesting* and has

begun demanding that Malabar 'pay its fair share' for Sheriff protection. The current MSTU rate for sheriff protection is .9960 for every \$1,000 your property is valued at. All other municipalities using the Sheriff for police protection pay the same MSTU rate.

The MSTU rate is unlike Malabar's current stormwater assessment fee. The stormwater fee is a flat rate each year that rarely changes. A MSTU is different than the fee in that it is based on a percentage of the value of your property. A MSTU is subject to all the same regulations as your property taxes and can go up or down each year.

It is the responsibility of the Town Council that the citizens of Malabar have adequate police protection. The time has come for the Council to make a decision but before doing this, they want citizen input. This article is designed to provide you with highlights of either paying the MSTU, creating a Malabar Police Department, or possibly doing nothing at all.

The Brevard County Sheriff's office has two types of officers, general fund officers and MSTU officers. They use the general fund officers mainly for administration, there are very few general fund officers with patrol cars. The Sheriff uses MSTU officers for patrol. Currently all the deputies responding to calls in Malabar are MSTU officers.

While attending the November 7, 2005 Town Council meeting (minutes on the web at www.townofmalabar.org), Sheriff Jack Parker stated that if the Town Council did not pass the MSTU ordinance, he would restrict the response from the Sheriff's department in Malabar to the very few general fund deputies. Parker said this could mean up to a thirty (30) minute delay in response to being called out. When asked what additional protection Malabar would receive if the MSTU passed, Sheriff Parker stated that he could not promise anything but would look into adding additional deputies for this district.

It was at that time the Town Council directed me to do a study on how much a small police department would cost. Which is how we came to the enclosed survey. In order to make a decision Council will need to know if the citizens feel safe. Which is why your participation is very important.

These are the items that the citizens of Malabar should consider:

- 1. The MSTU of .9960 mills will cost a property owner with a house valued at \$200,000 an additional \$200 per year in taxes.
- 2. The County's Environmentally Endangered Lands (EEL's) committee has purchased about 1,100 acres of land in Malabar and with an acre selling for as much as \$100,000 that equals 110 million dollars in property that can no longer be taxed. Malabar has asked the County if they are willing to give us a credit for this land and the answer was no. In addition to taking the land off the tax roles, the land in question has cost the Town considerable monies for policing and securing the areas.
- 3. A very small police department of two (2) officers could be started with costs under \$100,000 and an annual budget under \$100,000. The increase in property value in the town would raise the taxes to a level to support the police department. The staff would have to

freeze the budgets for the other departments for several years.

If the citizens and the Council want to establish their own police force, this could be accomplished within six (6) months. Below you will find additional information on this issue. ### **Background**

- 2003 the County determines that the Town
  of Malabar is receiving sheriff protection without
  paying MSTU. Former County Commissioner
  Nancy Higgs indicates that she would ask the
  Town for payment for past years. When being
  informed that the Town would be asking for
  some sort of reimbursement for all the land the
  County had purchased and taken off the tax
  rolls, she indicated that she would not support
  the County taking such action.
- 2003 Town Council voted not to approve the MSTU.
- 3. 2004 The storms at year-end put everything on hold.
- 4. 2005 The County Manager, Sheriff and County Commissioner Voltz make a presentation to the Town Council of Malabar. The Sheriff indicated that Malabar was receiving minimal police protection. Without the approved MSTU, the Town of Malabar would continue receiving minimal police protection.

### **Proposal by Sheriff's Department**

- 1. The Town of Malabar pass the ordinance in favor of a MSTU. The current millage rate is .9960 mills, and with the 2005 Town of Malabar valuation at \$2 million dollars, this would amount to \$199,200 in additional taxes to the citizens of Malabar. For a house valued at \$200,000, this would amount to a \$200 increase in taxes per year.
- 2. The Sheriff has promised that if the Town of Malabar accepts the MSTU, he will restructure the district to allow for patrolling in Malabar and to take a more pro-active approach to Malabar's needs.

### Proposal to Create a Malabar Police Department

## 1. If the Town Council recommends adopting the County MSTU:

The County would like to separate the issue of sheriff protection and the negative financial impact they have had in the Town. The bottom line is the County needs to contribute to the MSTU for the property they took off the tax rolls. The only way for Malabar to participate in the County's MSTU is at a reduced rate. In addition, the Sheriff needs to put in writing an agreement of additional protection.

## 2. If the Town of Malabar Town Council establishes a Police Department:

- A. A recommendation is for the Town to wait until the total town valuation reaches \$3 million dollars. At the present time, the valuation is just over 2 million. In 2002 the valuation was just over \$1 million the Town Administrator estimates that within three (3) years, the value will reach the \$3 million mark. And with the additional population, it will greatly off-set the cost of the police department. This depends on the millage rate remaining the same and future Council's not taking the roll-back rate (total ad valorem taxes collected by the town would increase).
- **B.** We should establish a citizens committee. This would provide representation from the citizens and help answer any questions.

# Open Burn Issues from the Fire Department

As the weather in the sunshine state grows colder and humidity begins to drop, the threat of brush fires becomes greater. It is during this time of the year that we must take extra precautions to prevent accidental ignition of fires. In addition to properly disposing of cigarette buts and matches, proper grilling techniques must also be used. Malabar has a open fire (burning) ordinance that prohibits most open burning. Any person(s) wishing to conduct open burning must obtain a written permit from the Malabar Fire Chief or his assigned designee.

# As of December 2005, only the following open burning is permitted:

- Only those persons who are involved in a FIRST time land clearing for future construction purposes or agricultural and silvicultural burns will be considered for burning permits.
- Winds > than 10 MPH requires a notice from the Fire Department the day of the burn.

### The following burns are not permitted:

- Celebratory fire, bonfires and open cooking fires (other than approved barbeques) are prohibited unless approved as indicated above.
- Yard trash fires are prohibited.
- Burning of household trash is prohibited.


