

The Town of Malabar got its 1st official Post Office and name on December 24,1883 when R.A. Ward was named Postmaster by President Chester A. Arthur. Two times a week, the boat that travelled down the intracoastal waterway from Jacksonville, would deliver the mail to the palmetto shack post office along the river bank at Malabar. The mail was dumped on the counter for the population of 25 to shuffle through. With the coming of the railroad, in 1893, the mail boat was no longer needed.

SPECIAL MEETING MARCH 10TH IMPORTANT TAX ISSUE, YOUR OPINION MATTERS

This letter to the citizens of Malabar is to announce a special meeting to receive input on the subject of police protection. The Council passed a motion on Jan. 22, 2007 to have this meeting and educate the public in advance.

As you may know, over the past four years, the Town Council has been trying to resolve the issue of passing an ordinance requiring the citizens of Malabar to pay an MSTU tax for Sheriff service or establish our own Police Department. Over the past four years, the Council has conducted surveys, had members of law enforcement make presentations, been addressed by a County Commissioner and had the issue placed on the ballot for a referendum. The bottom line is that although the Town Council has received a great amount of feedback, we are looking for the opinion of the majority.

The Town Council has four choices. The first is to pass an ordinance to require the citizens of Malabar to pay the MSTU tax for the Sheriff. According to State law, the Sheriff must respond to calls in Malabar and there is no requirement that Malabar pay for it. The Sheriff has stated that if Malabar does not pay the MSTU tax, he could stop using MSTU deputies in Malabar and respond with general fund deputies. The response time could be 30 minutes or more because the general fund deputy may be in the central part of the county. The County Commission has injected "fairness" into this issue. They

say it is not fair for Malabar to get Sheriff service for free when citizens in Palm Shores, Cape Canaveral and the unincorporated County area pay for it. At the present rate, the amount Malabar citizens would pay for an MSTU tax would be \$86.80 per \$100,000 of valuation. Based on current property valuations in Malabar, the total tax collected would be about \$220,000. This rate could be changed by the County Commission. The second option is for the Town Council to establish a Police Department. The cost would be dependent on size and level of service. Staff will prepare the numbers for the meeting. If the money is not available in the budget, it would require a vote of the citizens of Malabar for the additional funding. The third option is to do nothing. This option was not offered in the referendum and the Council is concerned that this could be the majority opinion. The County Commission has threatened the Town of Malabar with a lawsuit if the Town Council does nothing although legal opinion from our Town attorney says such a lawsuit would have no basis. The fourth option is to enter into a contract with the Sheriff. Since this is not an MSTU, the money would have to come from the general fund. Again, if the money is not available, it would require a vote of the citizens.

Before a decision by the Town Council is made, they are requesting your opinion. It is important for you to attend this meeting because of the impact it has on your taxes. We hope to have the Sheriff or his representative in attendance. The meeting will be held at the Malabar Fire Station on March 10, 2007 at 6 P.M. Please come and give the Council your opinion. If you are unable to attend this meeting, please call Town Hall or your council representative with your opinion.

Dear Mayor Eschenberg and Council Members:

I am taking this opportunity to follow up on the recent Malabar Town Council Meeting discussion regarding law enforcement options for the Town. I want to be sure that you have accurate information regarding costs for services and levels of service as you make your decision.

Currently, the Law Enforcement MSTU ad valorem millage rate for Sheriff's patrol services equates to \$86 per \$100,000 of taxable value (excluding any exemptions) ...not the \$860 dollars per \$100,000, which I am advised was presented to you by the Town Administrator at the Council meeting.

During that same meeting, I am told you were advised you that a new Police Department could be implemented with a recurring cost of approximately one million dollars annually (not including start-up costs). Based on that cost, the taxes you will have to assess the citizens to enable the Town of Malabar to operate a police department would <u>greatly</u> exceed the cost of being served by the Sheriff's Office. Should the Town Council abide by the outcome of the voters' referendum to pay the MSTU for Sheriff's services, it appears the tax burden you place on your citizens will be greatly reduced as compared to starting your own police department.

I would also like to emphasize that the cost of running a small police department may exceed your current expectations. The presented budget amount of a million dollars a year may not be sufficient when you consider personnel costs such as providing coverage for court appearances, sick/annual leave, work injury, extensive required training, and continuous recruitment in addition to operational costs such as insurance and replacement equipment. Although the start-up budget was not included in the annual budget, this cost needs to be fully understood as it can be substantial. It also should be considered that the Town would be in the position of defending possible lawsuits and paying subsequent financial awards due to the actions or negligence of the Town's Police Officers.

As I have stated previously, if the Malabar Town Council decides to be served by the Sheriff's Office, I will request the Board of County Commissioners allow me to use the funding to hire more patrol deputies for the South Precinct area that will result in an improved level of service to Malabar and surrounding areas.

However, to acquire the additional Deputies in time, I need to submit the request for the new Deputies in my budget for FY 2007/2008. It is my intent to finalize that request no later than April 15th of this year. As a result, I need your decision on whether you will join the MSTU or opt to start your own police department by the April 15th deadline, preferably sooner. If no decision is made by that date, the additional Deputies for your area will be difficult to achieve.

We look forward to serving the citizens of Malabar with a high quality, low cost law enforcement service that fully meets the needs of Town residents.


