

The Town of Malabar got its 1st official Post Office and name on December 24,1883 when R.A. Ward was named Postmaster by President Chester A. Arthur. Two times a week, the boat that travelled down the intracoastal waterway from Jacksonville, would deliver the mail to the palmetto shack post office along the river bank at Malabar. The mail was dumped on the counter for the population of 25 to shuffle through. With the coming of the railroad, in 1893, the mail boat was no longer needed.

Candidate Qualifying

Candidate Qualifying is upon us once again! If you live in either District 4 or District 5, you can take an active part in shaping the future. The Council Member seats for Districts 4 and 5 are up for election this November and candidate qualifying begins August 17th and ends on August 31st. Bobbi Moccia has held the District 4 seat for the past six years and due to Malabar's three-term limit she can no longer run. Patricia Dezman has held the District 5 seat since April 2005.

To be eligible to qualify you must be at least 18 years of age and able to prove that you have lived within the town

limits for the past year. Qualifying consists of obtaining 15 signatures of registered voters from your district and filling out the necessary paperwork. The packets can be picked up at Town Hall. Confused about what district you live in? Look at the back page of this newsletter to determine your district, or look online at www.townofmalabar.org and click on the Town Officials page.

Just a reminder that though you need to live within the district you wish to qualify for, in Malabar we vote 'at large' which means that all registered voters in Malabar will vote on all seats on November 6th.

Meet our new Town Administrator, Bonilyn Wilbanks-Free

It has been two months since I took the position as your Town Administrator. I hope that everyone has had a chance to read the news articles that were written about me as it fills in all the blanks about where I have been professionally to the present day. Since my tenure began it has been an interesting journey for me. I have met a lot of the residents who have stopped by Town Hall for various reasons or I have spoken to you on the phone and by email. Malabar is a busy little Town! Staff has done an excellent job helping me learn the history on people, places, problems and general day-to-day operations, and for that I am very thankful. Residents have also lent their historical knowledge on issues as well, which has been helpful. All this information combined has really helped me to get acclimated quicker to the job.

There are several things that I have implemented as soon as I got here and I know that some of you have

written me and let me know how much you appreciate a timely response to your inquiries. I consider my communications with residents to be a priority everyday. I try to respond to every phone call the same day, and I do this by phone or email. You will hear my staff ask you for details of the reason you are calling and I know that you may feel that is redundant when you are going to be telling it all to me. However, staff will provide me with background information which lets me have a more productive conversation with you when we do speak so please answer their questions. In addition, I have asked staff to please attempt to always get an email address from you and the best time of day to call. Some of you have been the recipients of my late night or very early morning email responses, as I work on these matters at all hours. Email has afforded me a greater opportunity to be more responsive to you, so please provide it if you would like a quicker response than snail mail.

General Items

At the time of this writing, the Town Council at their last meeting, will consider the creation of a "Board of Honor" to be placed in the Town Hall. The purpose of this project is to post the pictures and a brief bio of active duty military service men and women with a Malabar connection. This would include resident's children and grand-children as well as active duty personnel who formerly lived in Malabar. By the time of this newsletter publication, the Council should have made a decision. If you know someone who should be posted in the "Board of Honor", call the Town Hall for information as to whether the Council approved this project.

TAXES

For those who have not been following the goings-on in Tallahassee, the Legislature in a June special session passed two bills. The first one will give people a small reduction in their ad valorem tax. According to published figures, the average combined county and city tax reduction will be \$174. A roll back of ad valorem taxes to 2005/2006 is required. In addition, a further reduction of up to 9% is required depending on how much a government entity has raised taxes over the last five years. Malabar's percentage is 5. The Town Council will have to make tough budget decisions to reduce spending by about \$54,000. The second bill passed is for a proposed constitutional amendment to be voted on in January during the Presidential primary. A 60% majority is required for approval. There will be much publicity and propaganda about this amendment as we get closer to the vote, probably reaching a peak after Christmas. This amendment is known as the "Super Homestead" and would appear to benefit most, those people who have purchased a house in the last few years. The Counties and Cities most likely will fight this amendment with the

claim that they will loose so much revenue that services will have to be drastically cut back. Be sure to educate yourself on this amendment so you may cast an intelligent vote in January.

MSTU

After a long contentious battle with the County, the Town Council passed the MSTU tax for Sheriff protection. As a result, the County Commission decided not to pursue a lawsuit against Malabar. This new tax will appear on your tax bill this November as the line item "Law Enforcement MSTU". It should amount to a little less than \$87 per \$100,000 of your taxable value. The Council also passed a companion ordinance to have a binding referendum starting in November 2008 and every two years thereafter, to let the people decide if they want to continue paying the MSTU tax.

TRASH

Keep Brevard Beautiful and Waste Management sponsor a County-wide Trash Bash every year during the month of April. Volunteers all over the County go out and pick up trash. Each city has their own volunteers. Waste Management awards \$500 to the city or town that collects the most trash in their population group. Malabar has won in their group for a number of years in a row, thanks mainly to our Boy Scout troop. The Town Council then awards the \$500 to the Boy Scouts. While this is a wonderful project, trash continues to accumulate along the roads and in the ditches all year long. We should all be volunteers and pick up any trash along the road or in the ditch in front of our own property at least every two or three months. This would make Malabar an even more beautiful place to live. Also, it is great exercise.

HURRICANE SEASON

As you all know, hurricane season is here. There have been predictions of a bad season this year. We all know the damage and devastation that these storms can cause. I would like to give you some basic information regarding hurricane precautions, preparations and safety issues. Also provided are lists for a hurricane shelter and a disaster supply kit.

Before Hurricane Season starts:

- Check your insurance policy for the proper coverage. If you are not sure of the coverage, call your insurance company and express your concerns. They will be able to provide you with advice on this matter.
- 2. Know the hurricane risks in your area; determine whether you live in a potential flood zone.
- 3. Know where the hurricane shelters are in your area.
- 4. Prepare a personal evacuation plan with your family.
- 5. Trim your trees and shrubs.
- 6. Buy plywood or shutters to protect the doors and windows of your home.
- 7. Make sure that your emergency equipment (flashlights & battery operated radios) are working. Make sure you have enough batteries on hand.
- 8. Make sure that you have enough non-perishable food and water for a two-week period. The electric could be off for some time. Also, make sure that you have a hand-held can opener. This is very important if your electric is not functioning.

Before the Storm:

- 1. Listen to the radio frequently for official bulletins of the storm's progress.
- 2. Fuel and service family vehicles.
- 3. Have extra cash on hand.
- 4. Inspect and make sure your home is as secure as you can make it.

- Check your non-perishable food and water supply. If needed, stock up as quickly as you can.
- 6. Fill all of your sinks and bathtubs with water. This will come in handy for bathing and flushing toilets, especially those of us with well/septic system homes.
- 7. Cover all windows and doors with shutters or other shielding materials.
- 8. Check batteries, first aid supplies and medications that you may need during the storm. If you are low on your prescription medications, call your doctor immediately so that you have time to get the prescription medications from the pharmacy. This is a very important issue.
- Bring all lightweight objects, such as garbage cans, garden tools, toys, and lawn furniture inside. This will keep these items from flying if the winds are strong and causing damage to someone else's property.

During the Storm:

- 1. Listen closely to the radio for official bulletins as to the storms progress.
- Follow instructions issued by local officials. LEAVE IMMEDIATELY IF TOLD TO DO SO!
- If you are evacuating, leave, if possible, during daylight hours. Stay with friends/ relatives, stay at a low-rise inland hotel/motel, or go to a pre-designated public shelter outside a flood zone.
- 4. Notify neighbors and a family member outside of the warned area of your evacuation plans.
- If you are evacuating, DO NOT LEAVE YOUR PETS BEHIND. If you can, find a shelter that will allow you to bring your pets, whether it's a shelter or another means of shelter.
- 6. Move to a safe area before you are cut off by floodwaters.
- 7. Turn off all propane tanks.

- 8. Unplug all small appliances and shut down any and all computers. Make sure that your computer equipment is placed high up off the floor and you may want to cover it in plastic as extra protection.
- If you are staying in your home, turn your refrigerator to the coldest setting and leave it closed.

After the Storm:

- Listen to the radio for official bulletins of the storm.
- 2. Keep abreast of road conditions through the media. Wait until an area has been declared safe before entering.

- Do not attempt to drive across flowing water. As little as 6" of water may cause you to lose control of your vehicle 2 feet of water can carry most cars away.
- Stay away from standing water. It may be electrically charged from underground or downed power lines.
- 5. Have professionals check gas, water and electrical lines and appliances for damage.
- 6. Use a flashlight for emergency lighting. Never use candles and other open flames indoors.
- 7. Use tap water for drinking and cooking only when officials say it is safe to do so.
- 8. Use the telephone only for emergency calls.

What to Bring to a Shelter:

First-aid kit

Extra batteries

Cards, games, books

Credit card or cash

Flashlight (one per person)

Baby food & diapers

Blankets or sleeping bags

Toiletries

Valuable papers (insurance)

A Disaster Supplies Kit Should Include:

3-day supply of water Prescription medicines **Emergency tools** (1 gal. per person/day) One blanket or sleeping bag Flashlight, extra batteries Non-perishable food Extra set/car keys & (per person) Battery-powered NWR** credit card or cash One change of clothes and portable radio Special items for infant, elderly & shoes per person or disabled family members

We hope that this information will prove to be helpful to you and your families. Please put this portion of the newsletter in a safe place, and pull it out as a handy reminder checklist for you. In times of emergencies, when everyone is rushed to get things completed and prepared, it is not easy to remember all that we need to take with us or the things that need to be taken care before we have to leave our homes. Use these lists as gentle reminders in times of hurricane emergencies.


