

The Town of Malabar got its 1st official Post Office and name on December 24,1883 when R.A. Ward was named Postmaster by President Chester A. Arthur. Two times a week, the boat that travelled down the intracoastal waterway from Jacksonville, would deliver the mail to the palmetto shack post office along the river bank at Malabar. The mail was dumped on the counter for the population of 25 to shuffle through. With the coming of the railroad, in 1893, the mail boat was no longer needed.

# Budget Approved and Millage Does Not Increase!

The Town Council just approved the millage for the next fiscal year budget (October 1, 2010 through September 30, 2011) and kept their promise that rates would not increase. It was important to Council to not increase the millage when the economy is still struggling. With the continued reduction in property values and the millage rate staying at 1.6630 per \$1000.00 of value, a Malabar home with a taxable value of \$152,310, after the \$50,000 exemption taken, would pay \$253.29 in Malabar property taxes. Last year that property paid \$308.50. Malabar has budgeted its expenditures for the next year with 46,000.00 less in Ad Valorum taxes. Malabar Council utilized a Taxpayer Budget Review Board, a committee of citizens appointed by Council and the Mayor to review the draft budget and make recommendations. This is the second year Council has used the citizen participation board and has thanked the Board for their efforts.

# **Big Ballot For All This Year**

The voters in Malabar this year will be asked to complete a multi-page ballot covering the offices of US Senator & Rep (15<sup>th</sup> Dist), Governor, Atty Gen, Chief Financial Officer, Com of Ag, State Representative (31<sup>st</sup>), Supreme Court Justice, District Judges in addition to our Local Candidates. There are also six amendments proposed to our State Constitution, Questions 1, 2, 4, 5, 6 and 8 and one state referendum question. There will also be amendments relating to the County Charter. Information on these amendments and questions can be found on the Supervisor of Elections website, <a href="www.votebrevard.com">www.votebrevard.com</a>, 2010 Amendments and referenda. Malabar will have two questions related to our Charter and three other questions on the ballot. They are all explained in this newsletter.

# Candidate Forum October 21, 2010 at 7:00 PM to be held at Town Hall

On November 2, voters in Malabar will be asked to select Council Members for Districts 1, 2 and 3. These positions are elected *At-Large* in the Town-wide vote. Council Members serve a two (2) year term and may serve a maximum of three (3) consecutive terms.

It has been the practice to provide brief background and contact information for each candidate on the ballot. The Clerk's Office requested and received the following information for voter convenience and benefit. Please contact them for more information on their positions and other experience. ### **Candidate Bios District 1:**

### **Nancy Borton**

Businesswoman and community activist Nancy Borton is in her second two-year term as a member of the Malabar Town Council. The 13-year resident is an unrelenting booster of her home town. "I love this town and want it to continue as it is. In Malabar, if you want to live in a rural setting, with horses and cows on large acreage, you can. Or if you want to live in a subdivision, you can do that. And we have a beautiful riverfront that we get to drive by every day. It's quiet. It's awesome here." Borton, who served a single term as a Town Council member in 2000, was elected again in 2006 and continues to serve. "I love public service," she says. "As a public servant, I am allowed to help people accomplish what they want to accomplish. We help people achieve their dreams. What could be more satisfying than that?"

A Massachusetts native, she is one of the best regarded food professionals in Brevard County and it runs in the family, her parents having owned successful restaurants after having started with virtually nothing.

Borton has operated flourishing dining establishments in her own right since 1980. She and her husband, Stuart Borton, opened the Yellow Dog Café, one of the region's best-regarded and most innovative eateries, in 1997, and have become mainstays of charitable and community efforts in the area.

### **Carl Beatty**

Carl Beatty has been a resident of South Brevard County for 50 years; he has resided in the Town of Malabar for 35 years. Mr. Beatty was a prior employee of the Town from 1994 - 2009 and also served as the Mayor from 1985 - 1987. Mr. Beatty also served on the Planning & Zoning Advisory Board for two years and helped write the first Land Use Plan. Mr. Beatty stated he was also a two-year voting member of the Board of Governors to the Florida League of Cities. Mr. Beatty has been very active in assisting with Keep Brevard Beautiful as the Site Captain for Trash Bash for the past ten years; and he has been very instrumental in assisting the Boy Scouts/Girl Scouts with community service projects. He has also assisted in many projects with the Malabar Fire Department and the Trails and Greenways work projects.

### **Candidate Bios District 2:**

### Wayne E. Abare

After graduating from the University of South Florida, Wayne accepted a job with Radiation Incorporated (a Division of Harris Intertype). Wayne started out as an Analog Designer but shortly thereafter switched to nuclear and space radiation effects. He retired from Harris Government Communications System Division in June 2009 after 40+ years with Harris. He is currently a part time Consultant for Trident Systems in Virginia. Mr. Abare was an adjunct professor at Florida Institute of Technology during the 1970s teaching senior level courses in electrical engineering. Mr. Abare has been married to his wife Katie for 44 years. They have two daughters Tamara and Amber. Tamara is an Architect and lives in Tampa. Amber is an Electrical Engineer (PhD) and lives in Raleigh North Carolina. They have four grandchildren.

#### **David White**

My name is David White and I am running for Seat 2 on the Town Council. I have been a resident of Malabar for 20 years, and as such, I have seen our town grow from the times of all dirt roads and secluded homes, to paved streets, traffic signs, medical facilities and subdivisions. ### **Donald Krieger**

Efficient government, in my view, always requires an eve on reduced spending. If elected I would employ a 'Back to Basics' set of criteria so our Town adheres to living within its means. Responsible elected officials should reduce spending in times of economic downturn and not burden residents and businesses by raising costs. Employing better communication methods to inform residents of the issues is prime to keeping Malabar the rural environment most of us moved here to enjoy. When I was last on Council I did my best to limit costs, streamline operations, and maintain, improve, and pave roads. My wife and I recently celebrated 34 years of marriage and enjoy sailing on the Indian River Lagoon and bicycle riding around Town. We recognize the fragile nature of the rural lifestyle Malabar currently offers and hopefully will maintain.

I believe this year's vote is critical to this purpose and invite your thoughts and inquiries on the issues important to you. The issues I continue to address are: watchdog upcoming changes to future comprehensive land use planning; maintain the independent rural character and lifestyle of Malabar; maintain Town sovereignty; oppose outside non-funded mandates; maintain appropriate and cost efficient police, fire, rescue, and safety standards; continued roads and drainage enhancement and maintenance and getting Back to Basics while living within our means.

# Referendum Questions for November 2010 Ballot

We will have five (5) referendum questions on the ballot this year; three (3) are binding and two (2) are non-binding. If the binding referendum questions are approved by the voters, then there will be action taken to make those decisions effective. The two non-binding referendum questions will provide Council with the voter's opinion on these issues.

### **Binding Questions:**

 Amendment to section 2.07 of the Charter relating to the election and term of appointed officials in the office of Town Council and the Mayor. Proposes a Charter amendment that if a vacancy on Council or in the office of the Mayor is filled by Council appointment pursuant to section 2.09 of the Charter, then such appointive term shall not be used as part of the calculation for term limits.

**Explanation of question:** This question pertains to a seat that becomes vacant during the term of office of either a Council person or the Mayor. If Council appoints someone to fill the remainder of the term, would that time be counted as a "term" when considering the term limits for Council (a maximum of three consecutive 2-year terms) or the Mayor (a maximum of two consecutive 4-year terms).

 Amendment to the Charter relating to the filling of vacancies on the Town Coucil and in the office of the Mayor. Shall the Charter be amended to require the Council to schedule a special election to fill a vacancy on Town Council or in the office of the Mayor when one (1) year or more remains in the vacant term.

Explanation of question: This question is asking the voters if they feel a special election should be required if there is a vacancy in a Council Member's seat or the Mayor's seat of one year or more remaining in the term. The current wording in the Charter directs Council to appoint a successor if there is "less than one year" and directs Council to hold a special election if there is "more than one year" – this amendment will clarify the one year period.

 Continued Participation in the Brevard County Law Enforcement MSTU. Shall the Town continue to participate in the Brevard County Law Enforcement MSTU.

Explanation of question: Council approved participation in the Brevard County Law Enforcement MSTU in 2007 with an effective date of 2008. They also adopted Ordinance 2007-06 that required Council to bring the question back to the voters of Malabar every two years thereafter for their input as to whether they wish to continue participation with the MSTU for Brevard County Law Enforcement protection and services.

### **Non-binding Questions:**

Support for the future purchases of commercial land in the Town by EELS.
Should the Town of Malabar support future purchases of commercial land in the Town by the Environmentally Endangered Lands Program for Brevard County (EELS).

Explanation of question: The Environmentally Endangered Lands Program has purchased land in Malabar over the years from willing sellers. These properties were in areas designated for industrial development off of US 1, commercial development adjacent to the FEC railroad and Office Institutional along Malabar Road. The Brevard County Commission has asked Malabar Council in recent years to voice support of these purchases before the issue is voted on by the County Commission. Malabar Council wishes to hear from Malabar voters on whether the Malabar property owners support future purchases of commercial land within Malabar by the Environmentally Endangered Lands Program.

5. Support for the future purchases of residential land in the Town by EELS. Should the Town of Malabar support future purchases of residential land in the Town by the Environmentally Endangered Lands Program for Brevard County (EELS).

**Explanation of question:** The Environmentally Endangered Lands Program has purchased land in Malabar over the years from willing sellers. These properties were in areas designated for residential

development off of Marie Street, Corey Road and Malabar Road. The EELs are interested in acquiring other properties in residential areas of Malabar. The Brevard County Commission has asked Malabar Council in recent years to voice support of these purchases before the issue is voted on by the County Commission. Malabar Council wishes to hear from Malabar voters on whether the Malabar property owners support future purchases of residential land within Malabar by the Environmentally Endangered Lands Program.



### MALABAR OFFICIALS WANT YOUR INPUT!

Council has reviewed the P&Z Board's recommendations for changes to the land use designations in our Comp Plan for the areas along Malabar Road and Babcock Street. Before they can be approved, there will be public meetings and advertised Public Hearings so that the adjacent property owners and any owners within 500' will be notified by mail of these meetings.

Malabar wants the input from its residents. Council has asked the Planning and Zoning Board to continue their review of the "Land Use Designations" along US 1 and the rest of the Town before Public Hearings are held. Once all recommendations are made we will have advertised meetings to seek residents input.

There was a joint meeting of Council and the P&Z Board on February 24, 2010 to review the preliminary recommendations from P&Z. Both the Council and the P&Z Board would like your participation and input on this effort. Should we have more commercial along Malabar Road? Should we provide more commercial along Babcock? Some say we should not allow commercial development until Malabar Road is widened. Some say we should widen Malabar Road so commercial development will come. Malabar Comp Plan and Land Use Regulations prohibit automobile car lots and gas stations along Malabar Road.

Our FLUM was approved in 1988 and extended out to 2010. It is being reviewed to determine if it should be updated. We have made three changes

to the FLUM since 1988 but they each involved single properties.

RLC would allow mixed use – residential and limited commercial. It was created in the mid 1990's to provide a method for existing home owners along Highway 1 to keep their residence but to allow their business to operate from it. Would you support a similar change along Malabar Road?

CL, commercial limited allows for limited commercial development up to 4,000 sf of retail. OI, office institutional, allows for office development. Most of this type of business would close up at 5PM so it is ideal as a buffer to residential.

Please check our website, <u>www.townofmalabar.org</u> for upcoming agendas for Council and P&Z meetings where this item will be discussed. After the Council and P&Z Board come to a consensus, we will be putting up signs and sending out information on the website to attend public hearings on these proposals. The last time we did this we had an outstanding response.

Malabar's Charter states that the Town shall remain a rural community. But we are also home to Harris Corporation, Digital Graphics, Data Management, Warrior Books, MIMA, Palm Bay Pediatrics, Callagy Tires, Ace Hardware, several commercial storage facilities, and numerous small businesses and home businesses. Malabar Council and the P&Z Board would like to hear what you think.

# MALABAR FEASIBILITY STUDY FOR FOUNDATION PK BLVD EAST:

The Town recently had a feasibility study done on extending Foundation Parkway Boulevard to the east side of Babcock Street in order to connect to the Lett Lane intersection and provide access to the parcels within the CG and CL zoning classifications. The study showed there were wetlands issues but with approaching the access as a curved road around the wetlands, it was very feasible. We have sent out letters to the property owners to determine interest and have had very favorable response. We have held informational meetings with some of the property owners to discuss possible development strategies. We will be providing more information on the Town website.

It is with great sadness that we say goodbye to Chief Joseph Gianantonio; his last day with the Town was Sunday September 5, 2010. The Malabar First Baptist Church had its annual ceremony honoring the 9/11 heroes on September 5, 2010 at which our Fire Department participated. ### **Prescription Drugs – The Silent Killer**

### **Exerpts reprinted from the Hometown News**

There is a new drug epidemic sweeping the nation. It may be one of the most prolific and most dangerous threats to public safety yet...prescription drugs.

Strong prescription drugs for pain, depression or anxiety can be highly addictive. In Brevard County over the past 5 years, more than 700 people died as a result of prescription drug abuse. In that same 5-year period, only about a quarter of that many died from using street drugs in Brevard.

While addiction affects people of all ages, a special word of caution needs to go out to the parents of teens and young adults. Many people become addicts without the intent to do so. Many suffer legitimate injuries or have medical procedures and are given these pain medications to deal with their pain. Young people, especially those in their teens, seem to be especially susceptible to getting addicted to these medications.

As parents, we must get more involved and ask doctors serious questions when it comes to pain or anxiety medications for our children. Even if you are assured prescribed medications are necessary, you should control these medications and administer them yourself.
