

The Town of Malabar got its 1st official Post Office and name on December 24,1883 when R.A. Ward was named Postmaster by President Chester A. Arthur. Two times a week, the boat that travelled down the intracoastal waterway from Jacksonville, would deliver the mail to the palmetto shack post office along the river bank at Malabar. The mail was dumped on the counter for the population of 25 to shuffle through. With the coming of the railroad, in 1893, the mail boat was no longer needed.

Message from the Town Administrator

Candidate Qualifying is over – Meet Our Newest Council Members

Candidate Qualifying is over. We had two seats available, District 4 and District 5. Jeff McKnight qualified for District 4 unopposed and Pat Dezman, incumbent, qualified for District 5 unopposed. Since Mr. McKnight and Mrs. Dezman were the only two people to qualify, one for each District, the Town of Malabar will not be having an election this year. This is Mr. McKnight's first term as a Council Member; please stop by and make him feel welcome. Mrs. Dezman will rejoin Council for her third term.

Why Stormwater Matters

Urban development can have a profound impact on the quality of water entering the Indian River Lagoon. It is our goal to make that impact positive rather than negative. That takes efforts from all of us. During clearing, trees that had intercepted rainfall are removed, and natural depressions that had temporarily ponded water are graded to a uniform slope. The spongy humus layer of the forest floor that had absorbed rainfall is scraped off, eroded or severely compacted. Having lost its natural storage capacity, a cleared and graded site can no longer prevent rainfall from being rapidly converted into Stormwater runoff. The situation worsens after construction. Rooftops, roads, parking lots, driveways and other impervious surfaces no longer allow rainfall to soak into the ground. Consequently, most rainfall is directly converted into Stormwater runoff. The volume of Stormwater runoff increases sharply with impervious cover. For example, a one acre parking lot can produce 16 times more Stormwater runoff than a one acre meadow each year. Malabar requires tree protection to maintain our rural character as well as maintain as much pervious areas as possible. We require each construction site to be designed to withhold the first inch or more of rainwater on site and then slowly direct runoff to retaining or detaining areas that will act as filters so the Stormwater runoff eventually reaching the Turkey Creek or IRL will be filtered as much as possible of adverse nutrients. Please contact the Building Department for helpful information on Stormwater runoff.

WELLS - plan for your future water needs

Cap your free flowing well and drought proof your drinking well. We live within the St. Johns River Water Management District. In our District there are three Aguifer systems that are used for water supply (aguifer is an underground body of rock, cemented shell or limestone and/or sand that is sufficiently permeable to transmit and yield quantities of water to wells): Surficial Aguifer, which is the shallowest, Intermediate Aguifer, and the Floridan Aquifer, which is the deepest. Most of our drinking water comes from the Floridan Aguifer, but in Brevard the Surficial Aguifer is also a significant source of water. Aguifer levels fluctuate due to changes in pressure and drought and rainfall conditions. Rainfall deficits of even a few inches can cause water levels and pressure declines in various aguifers. St. Johns RWMD can offer technical assistance to homeowners seeking information on installing or upgrading a private well by calling 800-RALLY-22.

Tidbits for Trash...

When cutting vegetation in your yard, it should be cut to lengths no longer than 4 feet long; it should not be mixed with any other type of trash and should be placed at the right of way where you place your garbage cans for normal trash pick-up. Loose yard vegetation should be placed in containers and set at the right of way as well.

If you have "white elephant" trash, i.e. appliances or large household items to be hauled away, please remove the doors so that children playing do not get trapped inside. To have this type of debris removed, please call Waste Management and let them know what you have for pick-up. It can take 7 to 10 days for the pick-up. This type of debris should also be put at the right of way.

About the Building Department

The Town of Malabar's Building Department issues building permits for commercial and residential buildings, swimming pools, shed, additions, re-roofs and all related construction.

The Building Department reviews all required submitted documents for compliance with applicable building codes as well as federal, state and local laws. As "administrator" of permit applications, the department coordinates the review of submitted documents with Engineering, Planning & Zoning and Utilities Departments.

The Building Department inspects, at pre-determined intervals, different stages of construction. Criteria for passing of an inspection are based on information contained on approved plans and applicable codes.

Compliance with current Florida Building Codes should help you to achieve a successful construction project. Sometimes, dictated by laws or law interpretations require that changes be made with short or no notice. The Building Department will, as always, work to minimize these occurrences and their efforts through proper communication and education.

Please contact the Building Department personnel at (321) 727-7764, ext. 14 to request information and permit status. The Building Department hours are 8:30 a.m. to 4:30 p.m. Monday through Friday.

PROPER MARKING OF OCCUPANCIES FOR EMERGENCY USE

Malabar is rural and many homes and businesses are set back from the roadway. If the building is not clearly visible from the public or private way, an additional building number must be placed in a manner easily visible from a public or private way.

The size of lettering and numbers will be determined by occupancy as follows:

- Single-family dwelling: Minimum of four (4) inches in height and one-half (1/2) inch in width.
- Other residential and all commercial: Minimum of six (6) inches in height and one (1) inch in width.
- All letters and numbers shall be in a contrasting color to the immediate background of the building or structure on which they are affixed.

Please take notice of this requirement and bring your addressing requirements into compliance – it could save your life. If further assistance is required, you may call the Building Department at 321-727-7764, ext. 14.

Florida Construction Lien Law

According to Florida law (F.S. 713, Part 1), those who work on your property or provide material and are not paid in full, have the right to enforce their claim for payment against your property. This means if your contractor fails to pay for materials or pay his subcontractors, the people who are owed money may look to your property for payment, even if you have paid your contractor in full. The Building Department can provide information for you regarding this but here are some main points:

Require a release of Lien from any contractor or material supplier or a partial release for partial payments. Construction jobs with a value of \$2,500.00 or more are required to have a Notice of Commencement (NOC) filed and recorded with the Brevard County Clerk of Courts.

The Building Department is prohibited from performing the first inspection if the NOC is not filed with the Building Dept.

Always remember to verify your contractor is licensed and insured and has been issued a Building Permit prior to construction.

Comprehensive Plan Meeting Well Attended

Thirty residents, Planning and Zoning Advisory Board members, and Town Council members participated in a meeting on October 1st, 2007 in the Town Council chambers to determine development issues for an evaluation of the Town's Comprehensive Plan. The meeting was facilitated by Lorraine Tappen, a planner with Calvin-Giordano and Associates (CGA), hired by the Town to complete the state-required *Evaluation and Appraisal Report of the Town of Malabar Comprehensive Plan*. The Comprehensive Plan provides the basis for land use and zoning, requires infrastructure for development, and provides for environmental protection.

Each municipality must complete an Evaluation and Appraisal Report (EAR) every seven years. The main purpose of the EAR is to provide guidance on updating the Town's Comprehensive Plan to meet current statutory requirements for Comprehensive Plans and adjust to the community's goals and vision. This is the first EAR for the Town of Malabar since adoption of the Comprehensive Plan in 1998. During the 1990s, Malabar was exempt from completing the EAR because its population was under 2,500.

The October 1st "Scoping Meeting" (called scoping because it assists in determining the scope of work) allowed attendees to voice their likes and dislikes/concerns about their community and development. The Town's Planning and Zoning Advisory Board has also spent countless hours reviewing the Comprehensive

Plan with Town staff to determine which sections of the Comprehensive Plan need updating. The comments made by attendees and notes from meetings of the Planning and Zoning Advisory Board were recorded and used to determine a list of major issues for the EAR.

Major issues to be considered in the EAR include:

- Enhancing Indian River Lagoon access and historic features
- 2. Need for a corridor plan along Malabar Road
- 3. Improve pedestrian/bike/equestrian connectivity
- 4. Timing of infrastructure improvements
- 5. Enhance and protect rural atmosphere
- 6. Address blight and redevelopment
- Stormwater management and Indian River Lagoon water quality

Each of these issues will be discussed in the report in addition to state requirements for EARs. The final report and recommendations for amending the Comprehensive Plan will be presented at two meetings in December with the Planning and Zoning Board and the Town Council. Once approved and adopted by the Town Council, the Florida Department of Community Affairs will determine if the report is sufficient. If sufficient, the Town may proceed to amend its Comprehensive Plan based upon the EAR. EAR-based amendments must be completed within eighteen months of the sufficiency determination of the EAR.


