The Town of Malabar got its 1st official Post Office and name on December 24, 1883 when R.A. Ward was named Postmaster by President Chester A. Arthur. Two times a week, the boat that travelled down the intracoastal waterway from Jacksonville, would deliver the mail to the palmetto shack post office along the river bank at Malabar. The mail was dumped on the counter for the population of 25 to shuffle through. With the coming of the railroad, in 1893, the mail boat was no longer needed.

## *Voters to Select Mayor and Council Member in Nov. 4 Election*

On November 4, voters in Malabar will be asked to select a District 3 Council Member and a Mayor in the General Election. These positions are elected At-Large in the Town-wide vote. Council Members serve a two (2) year term and may serve a maximum of three (3) consecutive terms.

The Mayor serves a four (4) year term and may serve a maximum of two consecutive terms. This was changed by a Charter amendment, approved by voters in 1996 to extend the Mayoral term from two years to four years.

# ***THE MSTU ISSUE***

On Nov. 4, the voters of Malabar have a very important issue to decide. Do we want to continue to pay the MSTU tax for Sheriff's service for two more years? When the Council passed the MSTU tax in 2007, they also went along with my suggestion to have a binding referendum every two years to allow the voters to decide if the service they receive from the Sheriff is worth the price they pay. As you know, this issue was very controversial prior to the Council passing the ordinance.

After four years of a standoff, the County initiated conflict resolution proceedings. This process is required by the State before one government entity can file a lawsuit against another. I represented Malabar at the first meeting in the conflict resolution process with the County Manager and County Attorney. I took the position that sheriff service for our town is a county responsibility. I felt that if the Council was going to pass the MSTU tax, they needed to start negotiating from this position in the next step of the conflict resolution process. In subsequent negotiations, the Council got a promise from the Sheriff to use the money Malabar would pay to try to add four more deputies to the south precinct and appoint a deputy as liaison to Malabar.

The Sheriff made good on his promise. So why have the referendum? The Sheriff provides a service. The taxpayers of Malabar purchase that service. This is no different from what people do in their everyday lives. We all purchase services in the consumer market. We have the option to discontinue most of those services if we are not satisfied. Just like a private business, the Sheriff can raise his price for services. We continually evaluate the cost benefit ratio of the services we purchase to determine if the price is still worth the service provided. The referendum allows Malabar voters to make this determination.

So do I think the Sheriff's service is worth the price I pay? I am not going to tell you how I am going to vote, but offer some observations. It is generally agreed that because of "save our homes", the ad valorem tax system is unfair. Some people pay much more for the same government services than those who have been in the same home for a longer period of time. Business owners, landlords and vacant property owners are all subject to the ad valorem tax and do not have the benefit of the homestead exemption. Since the MSTU tax is based on taxable value of a property like the ad valorem tax, people pay different prices for the same service. According to my TRIM notice, I will pay \$62.22 on my homestead next year for sheriff service. That is only a little over five dollars a month. It certainly is a bargain price for me to have a deputy available on short notice. Some of my neighbors who have not been here as long as I have will have to pay three or four times as much. They will have to make their own determination of the value of sheriff service.

I am also going to have to pay \$70 MSTU tax on my vacant lot adjacent to my house. Is it worth \$70 for sheriff service to my vacant lot? I will have to make that determination. The Sheriff has stated that if Malabar does not pay the MSTU tax, service will be reduced. Normal response will be made with a general fund deputy and it could take a half an hour or more. Deputies will no longer patrol in Malabar. I believe the Sheriff will do what he says. We have to weigh this in our decision. When you vote on Nov. 4, please do not overlook this important referendum. I have full trust in the voters of Malabar to make the right decision.

In November, each of you will be asked to vote regarding the Town continuing its participation in the MSTU policing services provided by Brevard County Sheriff's Office. I have the opportunity to know the policing service provided by the Sheriff's Office not only as a resident, but also as a business owner. I have received excellent service in both capacities.

As your Councilmember, I monitor closely not only the services offered in our Town, but I look closely at other municipality services. I have found that our police protection is one of the finest and the additional services that are available to us such as K-9, Marine Patrol and Crime Scene Processing, would be extremely costly if we were to have our own police department and had these specialty units. The percentage we pay for these services is minimal to what having our own police protection would cost.

Please be sure to vote on November 4th and consider closely whether you want to change the excellent service that we now receive from the Sheriff's Department to maintaining our own police department; which I believe cannot be done for the minimal cost we all pay presently. I have investigated the MSTU issue to see what Malabar receives for its additional tax.

Please refer to the Brevard County website under 2006-2007 and 2007-2008 budget. The Sheriff's Office Programs and Services list duties under Law Enforcement and Law Enforcement MSTU. The MSTU contains Operations, Special Investigations, General Investigations, and Special Enforcement. ALL of these are redundant and a duplication of services under the Law Enforcement heading. I asked Sheriff Parker, when he attended our Town Council meeting, specifically about this and he stated he had no recollection of this. In this year's budget, 2008-2009, has redefined duties as Road Patrols, only, under MSTU.

If you look at the Sheriff's Budget for 2007-2008 and specifically the budget analysis for Law Enforcement - MSTU, it states, and I quote, "Operating Revenues increase 11.01% primarily due to the increase in ad valorem tax revenue from the inclusion of the Town of Malabar in the Law Enforcement MSTU." Two lines later it states: "Operating Expenditures increase 2.91% primarily due to the addition of four (4) deputy positions as a result of the inclusion of the Town of Malabar in the MSTU." This is not out of context and is stand-alone. Does anyone else see an issue here? What happened to the other 8.10%?

I checked the arrest records for the Brevard County Sheriff's Department on the Sheriff's website and noticed that there are usually over a thousand arrests for Palm Bay/Melbourne area, usually about 10 for Malabar, less than 10 for Grant-Valkaria, and none for Palm Shores.

Law Enforcement MSTU is defined on the Sheriff's Budget Summary 2007-2008 as: Provides road patrol and school resource officers to the unincorporated areas of Brevard County, Palm Shores, Malabar, and Grant-Valkaria. The MSTU is funded by a special ad valorem tax paid by residents and businesses located within the boundaries of the MSTU.

I requested clarification on the overwhelming number of arrests by MSTU deputies in other than MSTU funded locations and my response was:

- There is one (1) General Fund road patrol deputy assigned to the South Precinct.
- There are fifty-six (56) MSTU Fund road patrol deputy positions assigned to the South Precinct.
- The County's General Fund provides four (4) Lieutenants and five (5) Sergeants in South Precinct.
- There is no MSTU Fund road patrol supervisors assigned to the South Precinct.
- There is one general fund corporal assigned to patrol zones within the South Precinct. Corporals are generally assigned as an assistant to the sergeant. However, corporals will, at the direction of the sergeant, work a patrol zone when necessary.

I understand that some of these arrests are in unincorporated areas, so I rephrased the question again. All I received was a map with arrests for one month highlighted. I further probed this question and an officer agreed to attempt a meeting with me to explain the situation, but I have been unable to coordinate or have my questions adequately answered.

We are supposedly paying for added patrols – Road Patrols, not response time or speed traps. Do you routinely see a Sheriff's car drive down your street – daily, weekly, even monthly? I don't and two of my stay-at-home resident neighbors do not either.

I just want to insure that Malabar gets what they think they are paying for. Did you know that since we have opted to participate in the MSTU that the rate has increased three times? Do you trust our commissioners to keep this millage tax in check? I don't. We paid \$243,560.00 to MSTU last year. It was proposed at less than \$200,000.00.

A "No" vote on the MSTU could not affect any services for at least one year because we pay ahead. This gives council adequate time to justify whether added services are taking place. Here is something else to think about for what to expect over the next year.

Beginning 1OCT08, the Law Enforcement MSTU Personnel were decreased by 4 full-time positions per Law Enforcement MSTU: Program Profile 2008-2009, which is coincidentally exactly the same amount it was increased for the Malabar MSTU inclusion per Law Enforcement MSTU: Program Profile 2007-2008. Malabar should have adequate checks and balances to insure that our money is being well spent.

I would like to see a negotiated contract paid through the general fund rather than an ad Valorum tax. Remember, the seats of the County Commission are going to change and possibly the Sheriff's position as well.

Thanks for taking the time to read this. I know that it is a very serious issue. I have tried to be unbiased and factual even though I am very frustrated with the pressure and bullying from the Sheriff and the County. I am still appalled at the request to the Supervisor of Elections by Sheriff Parker to have your right to vote on this removed.


# Town Happenings . . .

## FPL's Line Clearing

FPL's strategy to maintain power lines free of tree growth is based on cycle line clearing. These cycles can vary depending on tree species and growth rates. The main lines, which typically run along major roads and serve the greatest number of customers, are trimmed every three years, on an average. Smaller neighborhood lines are trimmed on average every six years. Additionally:

## TOWN ADMINISTRATOR'S MESSAGE

Many residents have seen a major ditch maintenance program kicked off throughout the Town. This program will continue to be maintained on a regularly planned schedule throughout the year with special work being scheduled and completed on certain ditches 30 days prior to hurricane season beginning each year.

Ditch maintenance and the swale areas need to be everyone's responsibility. Now that the ditches have been cleaned and mowed, we need your help. Please help us help you and your property by doing a few simple tasks: Monitor the ditches in front of your property for litter or large debris that can become obstructions to the normal water flow during a rain event

Remove debris and large tree branches that may fall periodically into the ditch as soon as it is noticed

Monitor the vegetation that may spring up in the ditch and notify Town Hall by phone or email

You are encouraged to mow the swale area which reduces and retards the vegetation grown in the ditches. Shallow ditches can be maintained easily with weed whacking regularly as a part of the normal maintenance you do to your property.

Currently we have 5 staff members in our Public Works Department and ditch maintenance is just one of the jobs they perform for our Town. Any assistance you can give through either monitoring your ditches closely for debris or assisting us by maintaining your property adjacent ditches would be greatly appreciated. If you are unsure how to do it, please contact my office and I will be happy to schedule a time to meet with you to discuss areas that you can assist us.

Malabar also has a Referendum Question on the ballot. It asks if you want to continue the MSTU (Municipal Services Tax Unit) with Brevard Sheriff's Office. Council adopted Ordinance 2007-05 providing for Malabar to join in the MSTU with the Brevard Sheriff's office for law enforcement. The Council also approved Ordinance 2007-06 providing for the question of whether to continue with the MSTU would be put to the voters every two years. # Conserving Our Most Precious Resource

---

## Amount of Water Used for Common Activities

Brushing Teeth	3 gallons per minute IF the water is left running
Shower	40 gallons per 10 minutes
Bath	20 gallons
Clothes Washer	50 gallons per load
Dishwasher	14 gallons per load
Landscape	360 gallons per day
Hosing Driveway	130 gallons for every 15 minutes
Car Washing	100 – 160 gallons
Toilet	25 gallons per day per person

## Water Conserving Habits:

Bathroom — where over half of all water use inside a house takes place:

- Do not let the water run while shaving or brushing teeth.
- Take short showers instead of tub baths. Turn off the water while soaping or shampooing.
- If you must use a tub, close the drain before turning on the water and fill the tub only half full.
- Bathe small children together.
- Never use your toilet as a waste basket.

Kitchen and Laundry — simple practices that save a lot of water:

- Keep drinking water in the refrigerator instead of letting the faucet run until the water is cool.
- Wash fruits and vegetables in a basin. Use a vegetable brush.
- Do not use water to defrost frozen foods; thaw in the refrigerator overnight.
- Scrape, rather than rinse, dishes before loading into the dishwasher; wash only full loads.
- Add food wastes to your compost pile instead of using the garbage disposal.
- Wash only full loads of laundry or use the appropriate water level or load size selection on the washing machine.

Outdoors

- Sweep driveways, sidewalks and steps rather than hosing off.
- Wash the car with water from a bucket and only on the grass, or consider using a commercial car wash that recycles water.
- When using a hose, control the flow with an automatic shut-off nozzle and be sure the water does not run into the street

- Avoid purchasing recreational water toys which require a constant stream of water.
- Consider purchasing a new water-saving swimming pool filter.
- Use a pool cover to reduce evaporation when pool is not being used.
- Do not install or use ornamental water features unless they recycle the water

## A liter out of 58 gallons: Breaking Down the Water Supply

Water is a common chemical substance, essential to all known forms of life. About 1,460 trillion tons of water covers 71 percent of the Earth's surface, but relatively little is suitable for consumption. In many parts of the world, suitable water is in very short supply.

Let's scale the world's water supply to a size easier to comprehend like 58 gallons, about the same as a really full bathtub. A full 55 gallon drum of that water is saltwater ocean. About 10 pounds of ice is locked in polar ice caps and glaciers. About one drop is in the atmosphere as vapor, clouds, and precipitation. Another drop is in our soil, and part of life itself (our bodies are made up mostly of water, for instance).

Our drinking water sources:

Almost one gallon of that water is below ground in aquifers. Three-fourths of this is polluted or otherwise unavailable to us. We are left with less than a liter of this water to live on. About four tablespoons of that is in surface water such as rivers and lakes.

Proper disposal is key to water conservation because water is easily contaminated.




