

The Town of Malabar got its 1st official Post Office and name on December 24,1883 when R.A. Ward was named Postmaster by President Chester A. Arthur. Two times a week, the boat that travelled down the intracoastal waterway from Jacksonville, would deliver the mail to the palmetto shack post office along the river bank at Malabar. The mail was dumped on the counter for the population of 25 to shuffle through. With the coming of the railroad, in 1893, the mail boat was no longer needed.

This will minimize the chance of "head-on" collisions and will connect users to segments of the EEL Program Yellow Trail on the West and East Malabar Scrub Sanctuary parcels. Horses will be going the other way – they do not like surprises from behind.

The Town of Malabar Trails & Greenways Committee (T&GC) continues to work hard to improve our local trail system and can always use another helping hand on our field projects. <u>Septic Systems – What to do after the flood</u>

The Town of Malabar does not do any of the required permitting or inspections for septic systems. Brevard County is the issuing agency for septic system permits and inspections. If you need information regarding your septic system, you should contact Brevard County at 321-633-2000 (this is the main number) to make your inquiries. You can also make contact with the National Environmental Services Center at 800-624-8301 or visit their website at www.nesc.wvu.edu. You may also visit www.epa.gov/safewater and look for brochure EPA 816-F (September 2005). This brochure has very important information for septic systems if a flood should occur in Malabar. In this brochure, you will find helpful information of what and what not to do should there be a flood. Please take a few minutes to visit these sites and familiarize yourself with the information so you are safe in the aftermath of a flood disaster situation.

Volunteers Needed

The Town of Malabar is looking for volunteers to serve on our three boards. We have the Parks & Recreational Advisory Board, Planning & Zoning Advisory Board and the Board of Adjustment. Each board meets at specific times during the month with the exception of the Board of Adjustment. They meet on an as needed basis.

All board meetings are held at Town Hall in the Council Chambers; meetings start at 7:30 pm. The Park Board meets on the third Wednesday of each month, the P & Z Board (Planning & Zoning) meets the second and fourth Wednesday of each month and the Board of Adjustment meets when needed and the meeting is coordinated by staff with the assistance of the Board Chair. Positions are available on each board and we welcome all applications. If the board you apply for is full at the time, we will hold the application and when a position becomes available, the applications will be presented to Council for appointment.

As a qualified volunteer, you must live in Malabar for a least a year and be a registered voter. If this is something that interests you and you would like to be a part of the Town of Malabar's history, please feel free to contact the Clerk's Office here at Town Hall at 321-727-7764 or via email to the Town Clerk Debby Franklin at townofmalabar.org or the Deputy Town Clerk Cindi Kelley at ckelley@townofmalabar.org. You can also download an application by visiting the website at www.townofmalabar.org.

Upon receipt of your application, it will be presented at the next RTCM (Regular Town Council Meeting) for Council to review and make the appointment by Resolution to the corresponding board that was applied for. Along with your application, Council has requested a brief description of your qualifications. You are also welcome to attend the Council meeting at which the appointment to the board is scheduled and address Council with your qualifications.

News From the P&Z Advisory Board

The Planning and Zoning Advisory Board has been pretty busy the last few months making recommendations to the Town Council. Here are some of the major topics that have been discussed and forwarded onto Council:

- 1. Updating the Land Development Code Article IX for Off-Street Parking.
- 2. Vacating Malabar owned Right-of-Way along Johnston Ave. to a resident.

The following topics are presently being discussed at our meetings:

- Future Land Use map recommendations to Council for Residential/Limited Commercial (R/ LC) land uses along Babcock St., Malabar Rd. and US1. We are recommending changing land uses from Rural Residential (RR) to R/LC for some property along the major arterial roads.
- 2. An updated definition for R/LC, and what this Land Use allows in its Land Use district.
- Updating the 500 ft. radius notice given to residence. Presently, the code only requires this for variances that are heard by the Board of Adjustments. We believe the residence should be given notice for land use changes, conditional uses, and for all Public Hearing actions.

We meet the 2nd and 4th Wednesday's of the month at 7:30pm in the Town Hall if you are interested in seeing what's being discussed by the Board pertaining to the future development of the Town. We also discuss the Code of Ordinances, Comprehensive Plan, Zoning and Land Use direction of the Town, and are part of the Site Plan Reviews process.

Mowing the Rights-of-way in Front of Your Improved Property

HEAR THE BEEP WHERE YOU SLEEP

Keep your family safe with a working smoke alarm in every bedroom.

Did you know that roughly half of home fire deaths result from fires reported between 11 p.m. and 7 a.m., when most people are asleep?

Smoke alarms save lives. If there is a fire in your home, smoke spreads fast and you need smoke alarms to give you time to get out. In fact, having a working smoke alarm cuts the chances of dying in a reported fire in half!

When it comes to smoke alarms, it's about "location, location, location".

The key message of this year's Fire Prevention Week campaign, October 4-10, is to install smoke alarms in every bedroom, outside each separate sleeping area, and on every level of your home, including the basement. Larger homes may need more alarms.

Smoke alarms provide a critical early warning of fire, allowing additional time to escape. National estimates of reported fires derived from the National Fire Incident Reporting System (NFIRS) and the National Fire Protection Association's (NFPA's) fire department survey show that in 2009-2013, fires in homes with no smoke alarms caused an average of 940 deaths per year (38% of home fire deaths). An additional 510 people per year (21% of home fire deaths) were fatally injured in fires in which smoke alarms were present but failed to operate. Power source problems were the leading cause of smoke alarm failures.

Almost all households indicate having smoke alarms, yet smoke alarms were present in slightly less than three-quarters (73%) of reported home fires and operated in roughly half (53%). When present in reported fires large enough to activate them, they operated 87% of the time. Hardwired smoke alarms were more likely to operate than those powered solely by batteries.

The death rate per 100 reported fires was more than twice as high in homes with no or no working smoke alarms (1.18 deaths per 100 fires) as it was in fires with working smoke alarms (0.53 deaths per 100 fires). The lowest fire death rates were seen in homes with hardwired smoke alarms and sprinklers. Victims in homes with working smoke alarms were more likely to have been in the area of origin. They were also more likely to be 65 or older, to have a physical disability or to have tried to fight the fire themselves.


